TRAINER HECTOR SANCHEZ WHO STARTED THE HORSE "SNOWBOARD" IN THE FIFTH RACE ON NOVEMBER 16, 2007, AT LOS ALAMITOS RACE COURSE IS FINED FOUR HUNDRED DOLLARS (\$400.00)* PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE # 1887(A) (TRAINER TO INSURE CONDITION OF HORSE) FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE # 1843 (A&D) (MEDICATION, DRUGS AND OTHER SUBSTANCES – TWO NSAIDS PHENYLBUTAZONE AND FLUNIXIN, NOT IN EXCESS OF PERMITTED LEVEL).

The above ruling was issued after meeting with Mr. Sanchez to address case # 07LA0241. Hector accepted full responsibility explaining that he'd had a horse with colic and that his groom got the medication for the sick horse and "Snowboard" who was in to race mixed up.
