Each jockey was given a stern warning and were informed that better efforts were expected in their control of their mounts. Each stated they would be more cognizant in the future.

As the field crossed the finish line the inquiry sign was posted to review two different incidents. The first involved # 7 “Chase My Fire” (A. Bautista) (DNF) who hopped at the start unseating the jockey. (Accident Report Attached). The second occurrence involved # 1 “Zatoichi” (5th – C. Jenson) who drifted out slightly in front of # 2 “Eye An The Breeze” (6th – G. Boag). It was a unanimous decision # 2 was slightly inconvenienced but not enough to cost him the chance of a better placing. The original order of finish was made official.

(4) INQUIRY – NO CHANGE – 7TH RACE (QH 300 YDS.)

Following the running of the race the inquiry sign was lit to review the start of the race. Involved were # 2 “Shake Em Fast” (5th – A. Bautista) who stumbled badly ducking out into the path of # 3 “Masquerade” (7th – S. Ramirez Jr.) who broke slow directly behind # 2. It was a unanimous vote that # 3 was not compromised and the race was made official.
