Report of the Board of Stewards for the week of January 1, 2008 through January 6, 2008.

**TUESDAY**  
01/01/2008

(1) DUTY STEWARD

Randy Winick is the Steward on duty this week and will attend to morning office matters and record the minutes during this reporting period.

(2) SCRATCHES

The scratches for Thursday were completed at 9:00 a.m. sharp, and consisted of only one declaration and four rider changes.

(3) ENTRIES AND DRAW

Ten races were drawn at noon for Friday night's card consisting of seven Quarter Horse and three Thoroughbred races.

**WEDNESDAY**  
01/02/2008

(1) SCRATCHES FOR FRIDAY

Friday's scratches were completed at 9:00 a.m. with only one rider change for the evening.

(2) ENTRIES AND DRAW

Entries were drawn today for Saturday at 12:00 p.m. and eleven races were filled, consisting of six Quarter Horse, four Thoroughbred and one Arabian race.

**THURSDAY**

01/03/2008

**(1) SCRATCHES**

9:00 a.m. scratch time was completed with two declarations.

**(2) CAL-BRED REPORT**

The first race in the book, for maidens three years old, claiming price \$2,500 at 350 yards, was off with one entry.

**(3) ENTRIES AND DRAW**

Sunday's draw was held at 12:15 p.m. and the ten races consisted of six Quarter Horse and four Thoroughbred events.

**(4) FILM REVIEW**

Jockey J. R. Ramirez was in to review two races from opening night (December 28, 2007) where his mounts were drifting out. The Stewards told Jose that a better effort was needed by grabbing his reins, and that whipping alone is not enough to straighten his horse. Mr. Ramirez was in agreement with this assessment and would comply in future races.

Jockey Joy Scott appeared as directed to review the tape of Sunday's first race (December 30, 2007) where her mount came over a little too quickly from the outside post when it was not necessary to do so. The Stewards reminded Ms. Scott that she had a long enough backstretch to work her horse over gradually and to not be in such a hurry to angle in. Joy took the instruction well and would make a better effort in future races.

**(5) JENSEN RULING****RULING # 1**

JOCKEY CODY JENSEN IS FINED ONE HUNDRED DOLLARS (\$100.00)\* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE # 1872 (FAILURE TO FULFILL JOCKEY AGREEMENT) ON SATURDAY, DECEMBER 29, 2007.

The above ruling was given to jockey Cody Jensen after explaining that he rode at Sunland Park and his flight arrived too late to make the weigh in for Saturday's third race. The Stewards informed Cody that it is his responsibility to make timely arrangements.

**(6) GARCIA RULING****RULING # 2**

JOCKEY ALEJANDRO GARCIA, HAVING COMPLIED WITH THE PROVISIONS OF LOS ALAMITOS RULING # 242 DATED NOVEMBER 2, 2007, IS HEREBY RESTORED TO GOOD STANDING.

FURTHER, AS A CONDITION OF LICENSURE, SUBJECT MUST MAINTAIN AN ONGOING RECOVERY PROGRAM IN A 12-STEP PROGRAM, HAVE A SIGNED TESTING AGREEMENT ON FILE WITH THE CALIFORNIA HORSE RACING BOARD, AND IS PLACED ON PROBATION FOR THE TERM OF HIS LICENSE (02/2009).

The above ruling was written after Mr. Garcia was in to provide documentation of completing a residential rehabilitation treatment program and show proof of attending 12-step meetings to the satisfaction of the Stewards and Investigators. Mr. Garcia will remain on a testing program.

**(7) LATE DECLARATION REFUND**

A refund was ordered in the second race as # 1 "Cattos Cocktail" (Mario Gonzalez) was fractious in the starting gate and was injured. He was declared by the Stewards on the advice of Track Veterinarian Dr. T. Hackathorn.

(8) INQUIRY – 5<sup>TH</sup> RACE - DISQUALIFICATION

The Stewards lit the Inquiry lamp to review an incident through the stretch of the 300 yard Quarter Horse event, where # 6 “Sportin Audrey” (4<sup>th</sup> – R. Aceves) was lugging in on # 3 “Ladiesniteout” (5<sup>th</sup> – J. Cruz) causing her to be put on the heels of # 2 “Extra Dough” (2<sup>nd</sup> – S. Ramirez). After reviewing the film of this race and talking to the riders involved, the Stewards disqualified # 6 from fourth to fifth, behind # 3 for interference in the stretch, costing # 3 a better placing.

(9) INQUIRY – 7<sup>TH</sup> RACE – DISQUALIFICATION

The Stewards posted the Inquiry sign after the finish of the seventh race to review # 6 “Seldom Happens” (5<sup>th</sup> – C. DeAlba) veering in shortly after the start, and continuing to lug in on # 5 “Positively Powerful” (7<sup>th</sup> – C. Huerta) through the stretch and forcing that one off stride. After viewing the film of the incident and talking to the riders involved, the Stewards unanimously voted to disqualify # 6 and place him last behind # 5 for interference through the stretch.

(1) SCRATCHES

Scratches for Sunday were held at 9:00 a.m. promptly, and resulted in two rider changes and one equipment adjustment.

(2) CAL-BRED REPORT

The "Denim and Diamonds Handicap," for fillies three years old bred in California at 350 yards, was off with no entries. There was also a Cal-Bred race for four-year olds and upward, claiming \$3,200.00 at 300 yards, that went open with nine, five of which are Cal-Bred.

(3) FILM REVIEW

Jockey Jay Conklin was in to review Thursday night's first race where the Stewards observed him coming over from his outside post too quickly which caused some crowding to his inside down the backstretch. The Stewards counseled Mr. Conklin to be more careful, and to be aware of his position at all times. Jay was understanding of this assessment, and would make a better effort in the future.

(4) STEWARDS – JOCKEY MEETING

Prior to Friday night's first race, Stewards Martin Hamilton, Kim Sawyer, and Randy Winick called for a meeting with the Los Alamitos Jockey Colony in the Jockey Quarters to discuss various issues concerning riding safety and general procedures. Such topics as riding too close, dropping over too soon, staying in proper lanes, usage of whips and the general welfare of the horse and rider were emphasized as of the utmost of importance. There was also some time spent on certain procedures that needs to be clarified, such as the proper weighing in and checking, timely reporting of jockey objections to the Stewards, and reporting to the Stewards office when instructed for film and various other matters. This meeting was well received by the riders and the Stewards wanted them to know that communication is important and that they are available to discuss issues as they arise. The practice of Friday night film review and discussion with the riders and Stewards would also be continued if the riders were willing to participate. The Stewards wanted to convey an open door policy.

(5) ACCIDENT – INQUIRY – 2<sup>ND</sup> RACE – NO CHANGE

At the start of the second race (300 yards – Quarter Horse) # 4 "Kitada" (J. Williams) ducked his head downward, pulling the assistant starter into Jeff Williams and knocking him off his mount. The Stewards posted the Inquiry sign to look at the film to determine if any interference was caused by this incident, and none was detected so there was no change made to the order of finish. Jeff Williams returned to the Jockey's Quarters uninjured on his own accord.

(6) INQUIRY – 7<sup>TH</sup> RACE – NO CHANGE

The Stewards posted the Inquiry light to review the start of the seventh race (300 yards – Quarter Horse) when # 6 "Jodys Special Pop" (C. DeAlba) dwelt at the start, then hopped in the air as he was leaving the gate behind the field. The Stewards determined that the horse was the cause of his problem and that the starting gate doors opened properly, thereby declaring the race official as posted.

(1) CAL-BRED REPORT

The fourth race in the book for Saturday, for Cal-Bred maidens four years old and upward, claiming price \$5,000 at 300 yards, was off with two entries.

(2) ENTRIES AND DRAW

Thursday's draw was conducted at 11:45 a.m. The program was made up of four Quarter Horse, one Thoroughbred, and three Arabian Trials, for an eight race card.

(3) FILM REVIEW

Jockey Manuel Segundo was in at the Stewards request to review Friday nights first race (4 ½ furlongs – Thoroughbred) about coming over a little too soon on a tiring horse in the one path. This incident was minor in nature but we wanted to make a point that he must be more patient and to make sure he is clear when making such a decision. A warning was given to Manuel that he will be dealt with more harshly in the future if he continues this behavior.

(4) ACCIDENT – INQUIRY – NO CHANGE – 4<sup>TH</sup> RACE (TB. 4 ½ FURLONGS)

The inquiry sign was posted after the finish of the fourth race (TB – 4 ½ furlongs) concerning # 6 “Tasha’s Flirt” breaking down approaching the ¼ pole. The filly was laying second in the clear when she went wrong and stumbled to the ground unseating jockey Victor Navarro. Review of the tape showed that no other horses were involved or impeded and therefore the Stewards made no change. It was later reported that Jockey Navarro was transported to Los Alamitos Medical Center complaining of pain in his left ankle and side. It was reported that the filly broke her knee and also suffered a heart attack.

(5) WIN ONLY BETTING – 10<sup>TH</sup> RACE – RULE 1954

As per requirement of California Horse Racing Board Rule # 1954, win only wagering was offered on Saturday Nights tenth race due to the seven horse field being reduced to three starters as a result of four veterinarian scratches of sick horses.

(1) CAL-BRED REPORT

The sixth race in the book for Sunday, four year olds claiming price \$6,250 at 300 yards, failed to fill with three entries.

(2) FILM REVIEW

Jockey Dorothy Williams was in to review two races from Friday night in which her mounts drifted inward. The first incident was minor in nature for which the Stewards cautioned Dorothy to make a better effort to maintain a straight course and did not warrant a sanction. The second film was of the tenth race (300 yards – Quarter Horse) where her mount (Ah Randy – 1<sup>st</sup>) was lugging in under right handed whipping and her not making sufficient effort to correct this inward motion. In the Stewards opinion this did not affect the placing enough to warrant a disqualification, but however was deemed sloppy riding. The following ruling was therefore issued.

RULING # 3

JOCKEY DOROTHY WILLIAMS WHO RODE "AH RANDY" IN THE TENTH RACE AT LOS ALAMITOS RACE COURSE ON FRIDAY, JANUARY 4, 2008, IS SUSPENDED FOUR (4) RACING DAYS (JANUARY 12<sup>TH</sup>, 13<sup>TH</sup>, 17<sup>TH</sup>, AND 18<sup>TH</sup>, 2008) FOR FAILURE TO MAKE THE PROPER EFFORT TO MAINTAIN A STRAIGHT COURSE, CAUSING INTERFERENCE. A VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE # 1699 (RIDING RULES – CARELESS RIDING).

THE TERM OF THIS SUSPENSION SHALL NOT PROHIBIT PARTICIPATION IN DESIGNATED RACES IN CALIFORNIA.

(3) ACCIDENT – INQUIRY – NO CAHNGE – 1<sup>ST</sup> RACE (T.B. 4 ½ FURLONGS)

Upon completion of Sunday evening's first race, the Stewards posted the Inquiry sign to review an incident concerning a break down along the backstretch involving two horses at approximately the three-furlong marker. # 7 "Gambling Rent" (Jay Conklin) broke down while racing second on the outside, unseating his rider and throwing him to the ground, then receiving impact from a trailing horse. As # 7 struggled to regain his feet, he veered to the outside making contact with # 4 "McKinna G" (Cesar De Alba) causing that horse to dislodge his rider and connect with the track surface. A thorough film review showed that this accident had no bearing on the eventual outcome and the original order of finish was allowed to stand.

Both riders were attended to and transported to Los Alamitos Medical Center, their condition yet to be determined.

(4) RULE 1954 – 2<sup>ND</sup> RACE (T.B – 4 ½ FURLONGS)

Due to three late scratches in a seven-horse field reducing the betting to four interests, Rule 1954 was invoked and therefore only win and place wagering was allowed by order of the Stewards.

(5) RACING CANCELLED – UNSAFE CONDITIONS – WEATHER

Following the running of the fourth race, the jockey's called for a meeting with Track Management and the Stewards regarding the condition of the racing surface being unsafe due to severe weather conditions. After all parties conferred, it was decided to call off the remaining races for the safety of riders and horses.
