Report of the Board of Stewards for the week of October 28, 2008 through November 2, 2008.

TUESDAY

10/28/2008

(1) DUTY STEWARD

Will Meyers will record the minutes and oversee morning entries and declarations. Tuesday's entries will be supervised by Martin Hamilton to allow Steward Meyers time to move from Golden Gate to Los Alamitos.

(2) SCRATCHES

Scratch time for Thursday resulted in one scratch and two jockey changes.

(3) CAL-BRED REPORT

The fifth race in the book for maidens three years old and up, claiming price \$4,000, was called off with four entries.

(4) THE DRAW

Ten races will be offered Friday. One Arabian, two Thoroughbred and seven Quarter Horse races will be contested.

WEDNESDAY

10/29/2008

(1) SCRATCHES

Two scratches for Friday were taken and no rider changes were needed.

(2) CAL-BRED REPORT

The second race, Quarter Horse maidens, claiming price \$8,000, was off with two entries.

(3) THE DRAW

Eleven races were drawn for Saturday. One Arabian, one Thoroughbred and nine Quarter Horse races are scheduled.

(4) ATTORNEY CALLS

Don Calabria, attorney for Adan Farias, contacted the Stewards indicating Mr. Farias wished to drop his appeal and request an immediate imposition of the 15-day suspension imposed in the original ruling. Mr. Calabria was instructed to contact Sharon Jolly in Sacramento and have her send us the proper paperwork for reinstatement of the penalty. More to come.

THURSDAY

10/30/2008

(1) SCRATCHES

Three rider changes and two scratches were made by the 9:00 a.m. deadline for Saturday.

(2) CAL-BRED REPORT

The sixth race, maiden Quarter Horses three years old and up, failed to fill with four entries.

(3) THE DRAW

Ten races are on tap for Sunday. One Thoroughbred, one Arabian, and eight Quarter Horse races are scheduled.

(4) CLAIMS RESCINDED

Two claims were voided. Trainer Dominic Fama claimed # 1 "Nicolina U" and # 2 "Ming Rose" from Sunday's third race. Fama had dropped a total of three claims in the race, which is a violation of California Horse Racing Board rule # 1652 (g) (Prohibited Actions with Respect to Claims). Former trainers James Barnes ("Nicolina U") and Charles Treece ("Ming Rose") were informed and accepted the horses back.

(5) JANUARY COMPLAINT (CASE# 08LA0206)

Trainer Elmer January was in to discuss a high Phenylbutazone (5.49 ug/mL) reading on his horse "Datebook." "Datebook" ran the first race on October 2, 2008 at Los Alamitos finishing first. January has not had a medication violation of any kind since May of 2004. In accordance with the new penalty guidelines for category "C," Mr. January was issued a warning.

(6) NUNEZ COMPLAINT (CASE# 08LA0208)

Trainer Jesus Nunez called and accepted the following fine for not having a current groom's license for employee Sergio Alvarez.

(1) ALVAREZ SUSPENSION (CASE# 08LA0207)RULING # 256

OWNER SERGIO ALVAREZ, HAVING RECEIVED NOTICE, AND HAVING FAILED TO APPEAR BEFORE THE BOARD OF STEWARDS AT LOS ALAMITOS RACE COURSE ON OCTOBER 31, 2008, TO ANSWER A COMPLAINT REGARDING CASE NUMBER 08LA0207, IS HEREBY SUSPENDED PENDING APPEARANCE BEFORE THE BOARD OF STEWARDS PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1547 (FAILURE TO APPEAR).

DURING THE TERM OF THE SUSPENSION ALL LICENSES AND LICENSE PRIVILEGES OF SERGIO ALVAREZ ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE SUBJECT IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION).

The above ruling was issued because Alvarez failed to appear to answer charges of working without a proper license.

(2) CAL-BRED REPORT

The seventh race for three year olds and upward, claiming price \$2,000, failed to fill with three entries.

(3) THE DRAW

Three Thoroughbred and five Quarter Horse races make up Thursday's eight race card.

(4) GELDING HEARINGS (CASES #08LA0171 & 08LA0197)

Two hearings were held for Director of Racing Ron Church who heads the Los Alamitos Racing Office.

The first case involved a first time gelding named "Push Your Pulse." The program correctly listed "Push Your Pulse" as a gelding. The final proof had the notation "first time gelding," however when the program printed a computer glitch dropped the "first time gelding" notation. No violation was proven.

The second case involved a gelding named "Flusta." "Flusta," trained by Billy Lewis, had been registered at Los Alamitos as a colt and never started before leaving to race on the fairs. "Flusta" raced on the fairs as a gelding and returned to Los Alamitos in September. "Flusta" was entered at Los Alamitos, and the entry blank and a copy of the papers both showed him as a gelding. The racing office staff failed to correct the computer from the original registration and the horse appeared as a colt in the program. Mr. Church accepted responsibility for the error and also explained the remedies he has implemented to assure future problems are avoided. The following ruling was issued.

RULING # 257

DIRECTOR OF RACING RONALD CHURCH IS FINED FIVE HUNDRED DOLLARS (\$500.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE # 1461 (DUTY TO COMPILE OFFICIAL PROGRAM – GELDING LISTED AS COLT ON OFFICIAL PROGRAM) ON SEPTEMBER 25, 2008.

(5) JOEL VALADEZ RULINGRULING # 258

JOCKEY JOEL VALADEZ IS FINED ONE HUNDRED DOLLARS (\$100.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE # 1530 (CASES NOT COVERED BY RULES AND REGULATIONS-WHIP COCKED IN GATE) ON FRIDAY, OCTOBER 31, 2008.

The above ruling was issued after Valadez appeared and accepted the penalty imposed. Valadez had been warned before so a penalty was warranted in this instance.

(6) SANTIAGO MENDEZ RULINGRULING # 259

JOCKEY SANTIAGO MENDEZ IS FINED FIFTY DOLLARS (\$50.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE # 1689 (SAFETY HELMETS REQUIRED) ON FRIDAY, OCTOBER 31, 2008.

The above ruling was issued after Mendez was contacted and plead guilty to forgetting a most important part of racing safety.

(7) SERGIO RUIZ RULINGRULING # 260

JOCKEY SERGIO RUIZ IS HEREBY FINED THE SUM OF ONE HUNDRED DOLLARS (\$100.00)* FOR FAILURE TO FULFILL HIS RIDING ENGAGEMENTS IN THE FOURTH AND SEVENTH RACES AT LOS ALAMITOS RACE COURSE ON FRIDAY, OCTOBER 31, 2008, A VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE # 1872 (FAILURE TO FULFILL JOCKEY AGREEMENT).

The above ruling was issued after Ruiz contacted the Stewards shortly before the first race and stated he would not ride Friday and Saturday. Ruiz was informed penalties would be issued if he didn't ride after giving calls out to trainer Sandy Torok.

(8) GOOD RACING

This evening's racing was conducted without incident. The \$1,386,500 "Golden State Futurity" was won by "Tres Passes" for owner Janet McKinnerney. Los Alamitos all-time leading trainer Blane Schvaneveldt and all-time leading rider Eddie Garcia clicked for victory.

TRAINER HELEN SHELLEY IS FINED TWO HUNDRED DOLLARS (\$200.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE # 1629 (PENALTY FOR LATE DECLARATION – WORKS) ON SATURDAY, NOVEMBER 1, 2008.

The above ruling was issued after Shelley was contacted and accepted full responsibility for the late declaration. Shelley stated that she worked the horse at Fresno, but there was no record of the work.

(2) SERGIO RUIZ RULING – PART IIRULING # 262

JOCKEY SERGIO RUIZ IS HEREBY FINED THE SUM OF ONE HUNDRED DOLLARS (\$100.00)* FOR FAILURE TO FULFILL HIS RIDING ENGAGEMENT IN THE EIGHTH RACE AT LOS ALAMITOS RACE COURSE ON SATURDAY, NOVEMBER 1, 2008, A VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE # 1872 (FAILURE TO FULFILL JOCKEY AGREEMENT).

The above ruling was issued after Ruiz again failed to show for Saturday's races.

(3) ALVAREZ RULINGS (CASE# 08LA0207) – REFER 11/01/08 (5)RULING # 263

IN THE MATTER OF: SERGIO ALVAREZ

HAVING NOW APPEARED BEFORE THE BOARD OF STEWARDS THE LICENSE PRIVILEGES OF OWNER SERGIO ALVAREZ ARE RESTORED AND LOS ALAMITOS RACE COURSE RULING #256, DATED, NOVEMBER 1, 2008, SUSPENDING SERGIO ALVAREZ FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE # 1547 (FAILURE TO APPEAR), IS HEREBY SET ASIDE.

RULING # 264
