TOTE EMPLOYEE JOSEPH LABORICO IS FINED ONE HUNDRED DOLLARS (\$100.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE # 1874 (DISORDERLY CONDUCT-BOISTEROUS AND AGGRESSIVE BEHAVIOR).

This ruling was issued after an informal hearing. Present at the proceedings for the complainant were Assistant Los Alamitos General Manager Mike Monji, Executive Chef Sam Gonzalez, Maitre'd Rueben Arcilo and admission person Jody Giordino. For the respondent, tote employee Joseph Laborico and Scientific Games Foreman Michael Ramirez were present. Mr. Laborico allegedly was disorderly and boisterous in the Vessel's Club. Testimony was heard from the complainants, and Mr. Laborico did not deny the allegations. The tote employee has a clean record.

(1)THE DRAW

Eight races were drawn for next Thursday's program. Two Thoroughbred and six Quarter Horse races complete the card.

(2)CAL-BRED REPORT

The second race on the card for four-year olds, claiming price \$2,500, going 330 yards, failed to fill Cal-Bred but was used open with five Cal-Breds in an eight horse field.

(3)JOCKEY REVIEWS RACE

Jockey Julio De La Torre appeared to review yesterday's second race with the Stewards. The rider was cautioned to make a better effort to keep a straight course.

(4)INQUIRY – TENTH RACE – DISQUALIFICATION

After the finish of the tenth race (350 yards – The Cypress Handicap) the Stewards posted the Inquiry sign to review an incident at the start. Involved were the second place finisher # 7 "Hawk In The City" (jockey Saul Ramirez, Jr.) and the sixth place horse # 6 "JP Rhythm" (jockey Santiago Mendez). After talking with the riders involved and reviewing the replays, the Stewards unanimously agreed to disqualify # 7 from second and place him sixth, behind # 6, for interference at the start. Replays show # 7 break in at the start, bumping # 6, costing the latter the opportunity at a better placing.
