Report of the Board of Stewards for the week of February 17, 2009 through February 22, 2009.

TUESDAY

02/17/2009

(1) DUTY STEWARD

Albert Christiansen will be present for morning responsibilities and shall author the week's minutes.

(2) SCRATCHES

Three rider changes made up scratch time completed at 9:00 a.m.

(3) THE DRAW

Ten races were drawn for Friday's program. Four Thoroughbred and six Quarter Horse races complete the program.

(4) CAL-BRED REPORT

The sixth race in the book for three year olds and upward, claiming price \$2,500, going 300 yards, failed to fill.

WEDNESDAY

02/18/2009

(1) SCRATCHES

Two rider changes completed scratch time at 9:00 a.m.

(2) THE DRAW

Eleven races were drawn for Saturday's program. One Arabian, four Thoroughbred and six Quarter Horse races complete the card.

(3) CAL-BRED REPORT FOR SATURDAY

The fourth race in the book for three year olds, claiming price \$8,000, going 330 yards, failed to fill.

(1) SCRATCHES

Four rider changes made up scratch time completed at 9:00 a.m.

(2) THE DRAW

Ten races were drawn for Sunday's program. One Arabian, one Thoroughbred and eight Quarter Horse races make up the card.

(3) CAL-BRED REPORT

The third race in the book for fillies and mares, three year olds, claiming price \$5,000, going 300 yards, failed to fill.

(4) JOCKEY APPEARS

Jockey Ramon Sanchez, accompanied by trainer Paul Jones, appeared to review last Saturday's seventh race with the Stewards. At issue was the jockey stepping off his horse in the gate. After much discussion, the rider was advised that the starter is in charge at the gate.

(5) THIRD RACE – INQUIRY – NO CHANGE

After the finish of the third race (Thoroughbred – 4½ furlongs), the Stewards posted the Inquiry sign to review the start. Replays show # 3 "Candeye Lou" (jockey Maggie Carter) throw her head at the start and break extremely slow. Starter John Baker verified the incident. As the gate opened properly, the horse was declared a starter.

Jockey Jeff Jerman appeared to review last Saturday's fourth race with the Stewards. The rider was cautioned to make a better effort in maintaining a straight course.

(1) THE DRAW

Eight races were drawn for next Thursday's program. Four Thoroughbred and four Quarter Horse races make up the card.

(2) CAL-BRED REPORT

The seventh race in the book for three year olds and upward, claiming price \$8,000, going 330 yards, failed to fill.

(3) INFORMAL HEARING

An informal hearing was conducted today to address two complaints against owner Enrique Alejandro Garcia. Mr. Garcia is a licensed veterinarian in Mexico with a clinic in Jalisco. Present at the hearing were Mr. Garcia who appeared in person, waived his right to an attorney and notice of hearing, Senior Investigator Tom Blake who presented the cases, and California Horse Racing Board Licensing Tech Amador Villanueva who translated for Mr. Garcia.

The first case, from October 2007 involved a suitcase of injectable medications that Fed-Ex had mistakenly delivered to Los Alamitos. Mr. Garcia explained that the suitcase was his and had been missing for a year and a half. The testimony by Mr. Garcia in this complicated affair was believable to the Stewards.

The second case concerned a van-load of medications, racing equipment, and miscellaneous supplies. The veterinarian explained that he had purchased all this apparatus for his clinic in Mexico and the match races in Jalisco. Mr. Garcia stated he foolishly left the van in Los Alamitos' parking lot to attend a veterinary seminar in San Diego. At the conclusion of testimony, Mr. Garcia was told the Stewards would deliberate the case and reach a decision at a later time.

(4) GARCIA RULING (REFER 02/21/09 (03))

RULING # 31

OWNER ENRIQUE A. GARCIA IS HEREBY FINED FIVE HUNDRED DOLLARS (\$500.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE # 1890 (POSSESSION OF CONTRABAND - INJECTIBLE MEDICATIONS) ON DECEMBER 6, 2008.

This ruling was agreed upon after due deliberation. The Stewards were convinced that Mr. Garcia did not have any nefarious motives but was guilty of poor judgment. The fact that the contraband had no narcotics or needles and syringes was taken into account when reaching the decision.

(5) RAMIREZ RULING

RULING # 32

JOCKEY SAUL RAMIREZ, JR. IS HEREBY FINED THE SUM OF ONE HUNDRED DOLLARS (\$100.00)* FOR FAILURE TO FULFILL HIS RIDING ENGAGEMENT AT LOS ALAMITOS RACE COURSE ON FRIDAY, FEBRUARY 20, 2009, A VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE # 1872 (FAILURE TO FULFILL JOCKEY AGREEMENT).

This ruling was issued after jockey Ramirez missed his first mount last night. The rider flew in to ride the Winter Derby and did not allow enough time for his first scheduled mount.

(6) RIDER REVIEWS RACE

Jockey Eduardo Nicasio appeared to review last night's eighth race with the Stewards. The rider was cautioned to not whip right-handed on a lugging in horse.

(7) FOURTH RACE – INQUIRY/ACCIDENT – NO CHANGE

After the finish of the fourth race (Thoroughbred – 4½ furlongs), the Stewards posted the Inquiry sign to review an accident turning for home. Replays show # 2 “Stern Wheeler” break his left front leg, stumble, and unseat jockey Gerardo Gavica as the horse falls. “Stern Wheeler” was racing in the clear, and no other horse was involved. Jockey Gavica was shaken but walked to the ambulance.

(8) FIFTH RACE – INQUIRY – NO CHANGE

After the finish of the fifth race (Quarter Horse – 300 yards), the Stewards posted the Inquiry sign to review an incident shortly after the start. Involved were the fourth place finisher # 4 “Ritas Fair” (jockey Alex Bautista) and the sixth place horse # 5 “Hennessey Venom” (jockey Ramon Sanchez). After talking with the riders involved and reviewing the replays, the Stewards unanimously agreed to make no change in the order of finish. Replays show # 4 coming out shortly after the start, however, # 5 overreacts and ducks out, clipping heels with # 6 “Denali Special” (jockey Juan Andrade). Because # 5 contributes to the problem, no change was warranted.

(9) TENTH RACE – INQUIRY – DISQUALIFICATION

After the finish of the tenth race (Los Alamitos Winter Championship – Grade I – 400 yards), the Stewards posted the Inquiry sign to review the incident approaching the wire. Involved were the third place finisher # 5 “First To Reach” (jockey Juan Andrade) and the sixth place finisher # 8 “Magic Show Czech” (jockey Ramon Sanchez). After talking with the riders involved and reviewing the replays, the Stewards unanimously agreed to disqualify # 5 from third and place him sixth, behind # 8, for interference about fifty yards before the finish. Replays show # 5 steadily drift into the path of # 8, causing the latter to steady and lose the opportunity at a better placing.

(1) ANDRADE RULING**RULING # 33**

JOCKEY JUAN P. ANDRADE WHO RODE “FIRST TO REACH” IN THE TENTH RACE AT LOS ALAMITOS RACE COURSE ON SATURDAY, FEBRUARY 21, 2009, IS SUSPENDED FOUR (4) RACING DAYS (MARCH 1st, 5TH, 6TH AND 7TH, 2009) FOR FAILURE TO MAKE THE PROPER EFFORT TO MAINTAIN A STRAIGHT COURSE, CAUSING INTERFERENCE RESULTING IN THE DISQUALIFICATION OF HIS MOUNT FROM THIRD TO SIXTH PLACE. A VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE # 1699 (RIDING RULES – CARELESS RIDING).

THE TERM OF THIS SUSPENSION SHALL NOT PROHIBIT PARTICIPATION IN DESIGNATED RACES IN CALIFORNIA.

This ruling was issued after jockey Andrade appeared along with his agent Saul Servin. Mr. Andrade got careless in that he fails to straighten his mount while continually drifting out. The rider had little to say in his defense.

Jockey Carlos Bautista appeared to review last night's ninth race. The rider was cautioned to make a better effort in maintaining a straight course.
