Report of the Board of Stewards for the week of March 1, 2011 through March 6, 2011.

TUESDAY

03/01/2011

(1) DUTY STEWARD

Albert Christiansen will be present for morning duties and shall author the week's minutes.

(2) THE DRAW

Ten races were drawn for Friday's program. Six Quarter Horse and four Thoroughbred races make up the card.

(3) CAL-BRED REPORT

Two races were offered Cal-Bred in the condition book, but neither filled. The third race for maidens three years old, going 300 yards, was called off with two Cal-Bred entries. The sixth race for three year olds, claiming price \$12,500, going 350 yards, did not attract an entry.

WEDNESDAY

(1) SCRATCHES

One rider change completed scratch time at 9:00 a.m.

(2) THE DRAW

Nine races were drawn for Saturday's program. Three Thoroughbred and six Quarter Horse races complete the card. The races for Saturday were difficult to fill.

(3) CAL-BRED REPORT

The seventh race in the book for mares four years old and upward, claiming price \$12,500, going 300 yards, attracted one Cal-Bred entry.

(3) CAL-BRED REPORT

Two races were offered Cal-Bred in the condition book. The third race for maidens three years old, claiming price \$10,000, going 300 yards, was called off with one entry. The seventh race in the book for maidens four years old and upward, claiming price \$2,500, going 350 yards, attracted one entry.

(2) AMARO RULINGRULING #41

GROOM ROSEMARY AMARO IS FINED TWENTY-FIVE DOLLARS (\$25.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE # 1530 (CASES NOT COVERED BY RULES AND REGULATIONS - ILLEGAL PARKING) ON THURSDAY, MARCH 4, 2011.

This ruling was issued after the groom pled guilty to parking her car in the barn area overnight. She fell asleep.

(3) VIRAMONTES RULINGRULING #42

TRAINER RODOLFO VIRAMONTES IS FINED TWO HUNDRED DOLLARS (\$200.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1629 (PENALTY FOR LATE DECLARATION - FAILED TO ADMINISTER LASIX) ON SUNDAY, FEBRUARY 27, 2011.

This ruling was agreed upon after Mr. Viramontes requested a telephonic hearing. The trainer and his veterinarian got their signals crossed, causing a late declaration. Mr. Viramontes' stable vet had registered the horse in question as a bleeder. The horse was not administered lasix on race day.

(4) SHOWALTER RULINGRULING #43

TRAINER DAVID SHOWALTER IS FINED FOUR HUNDRED DOLLARS (\$400.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1629 (PENALTY FOR LATE DECLARATION - FAILED TO PROPERLY SUBMIT SCRATCH CARDS -TWO (2) INSTANCES) ON SATURDAY, FEBRUARY 26, 2011.

This ruling was issued after trainer Showalter accepted a hearing telephonically. The trainer failed to ship in two entries the day before their races. Also, the trainer failed to make out scratch cards, resulting in a delay in the declaration of both horses.

(5) MALDONADO RULINGRULING #44

JOCKEY RODRIGO MALDONADO WHO RODE "LOST IN LOVE" IN THE FOURTH RACE AT LOS ALAMITOS RACE COURSE ON SUNDAY, FEBRUARY 27, 2011, IS SUSPENDED THREE (3) RACING DAYS (MARCH 11TH, 12TH AND 13TH, 2011) FOR FAILURE TO MAKE THE PROPER EFFORT TO MAINTAIN A STRAIGHT COURSE, CAUSING INTERFERENCE. A VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1699 (RIDING RULES - CARELESS RIDING).

THE TERM OF THIS SUSPENSION SHALL NOT PROHIBIT PARTICIPATION IN DESIGNATED RACES IN CALIFORNIA.

Jockey Guild Representative Cesar De Alba appeared on behalf of jockey Rodrigo Maldonado. After reviewing the replays the Stewards agreed jockey Maldonado made a late and weak effort to correct his mount. There was no Inquiry as the horse interfered with ended up beating Maldonado's mount.

(6) LATE DECLARATION

He stated he administered this specific horse about 26-28 hours before the race. A split sample confirmed the original overage. Mr. De La Torre was advised the Stewards would study the case and testimony and reach a decision tomorrow.

(1) DE LA TORRE RULINGRULING #45

TRAINER UGO DE LA TORRE WHO STARTED THE HORSE "LAS VEGAS LUCKY" IN THE SEVENTH RACE ON JANUARY 22, 2011, AT LOS ALAMITOS RACE COURSE IS FINED ONE THOUSAND FIVE HUNDRED DOLLARS (\$1,500.00)* PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE # 1887(A) (TRAINER TO INSURE CONDITION OF HORSE) FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE # 1843 (A, B & D) (MEDICATION, DRUGS AND OTHER SUBSTANCES) AND # 1844 (c-1) (AUTHORIZED MEDICATION - PHENYLBUTAZONE IN EXCESS OF PERMITTED LEVEL (7.49 UG/ML - CLASS IV - SECOND OFFENSE).

This ruling was agreed upon after due deliberation from yesterday's hearing. In reaching this decision Mr. De La Torre's medication record was considered an aggravating circumstance.

(2) PEREZ RULINGRULING #46

TRAINER MAGDALENO PEREZ IS FINED TWO HUNDRED DOLLARS (\$200.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1629 (PENALTY FOR LATE DECLARATION - NOT ON THE GROUNDS) ON SATURDAY, MARCH 5, 2011.

The above ruling was issued after it was discovered that Mr. Perez's horse was never on the grounds. The trainer never informed the Racing Office or the official veterinarian that the horse was sick.

(3) A CHANGE

After the third race Steward Randy Winick felt ill. Safety Steward Jim Dreyer filled in for the remainder of the evening.

Nine races were completed without a further reportable incident.
