Report of the Board of Stewards for the week of July 17, 2012 through July 22, 2012.

TUESDAY

07/17/2012

(1) DUTY STEWARD

Albert Christiansen will be present for morning duties and shall compose the week's minutes.

(2) CAL-BRED REPORT

Two races were offered CAL-BRED in the condition book, neither of which filled. The second race for maidens, fillies two years old, going 300 yards, was called off with three entries. Sub race #3 for three year olds, claiming price \$5,000, going 330 yards, had no entries.

(3) THE DRAW

Nine races were drawn for Friday's program. Three Thoroughbred and six Quarter Horse races make up the card.

WEDNESDAY

07/18/2012

(1) SCRATCHES

One equipment change completed scratch time at 9:00 a.m.

(2) CAL-BRED REPORT

Two races were offered CAL-BRED, neither of which filled. The fourth for maidens, two years old, going 300 yards, had three entries. Sub race #1 for two year olds, claiming price \$6,250, going 300 yards, failed to attract an entry.

(3) THE DRAW

Nine races were drawn for Sunday's program. One Thoroughbred and eight Quarter Horse races complete the card.

(2) MORENO RULINGRULING #105

JOCKEY CESAR T. MORENO IS FINED ONE HUNDRED DOLLARS (\$100.00)* FOR FAILURE TO FULFILL HIS RIDING ENGAGEMENT AT LOS ALAMITOS RACE COURSE ON SUNDAY, JULY 15, 2012. A VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1872 (FAILURE TO FULFILL JOCKEY AGREEMENT).

This ruling was issued after jockey Moreno missed his mount on Sunday. Traffic was blamed but not accepted as an excuse.

(3) RULINGS #106 & 107RULING #106

EXERCISE RIDER CAYETANO GUERRERO HAVING FAILED TO APPEAR BEFORE THE BOARD OF STEWARDS AT LOS ALAMITOS RACE COURSE ON JULY 13, 2012, TO ANSWER A COMPLAINT REGARDING CASE #12LA0138, ALLEGING VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1489 (H) (GROUNDS FOR DENIAL OR REFUSAL OF LICENSE) AND #1902 (CONDUCT DETRIMENTAL TO HORSE RACING) IS HEREBY SUSPENDED PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1547 (FAILURE TO APPEAR).

DURING THE TERM OF THIS SUSPENSION ALL LICENSES AND LICENSE PRIVILEGES OF CAYETANO GUERRERO ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE) SUBJECT IS DENIED ACCESS TO ALL PREMISES WITHIN THIS JURISDICTION.

RULING #107

GROOM NESTOR G. GARRIDO, HAVING FAILED TO APPEAR BEFORE THE BOARD OF STEWARDS AT LOS ALAMITOS RACE COURSE ON JULY 14, 2012, TO ANSWER A COMPLAINT REGARDING CASE #12LA0143, IS HEREBY SUSPENDED PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1547 (FAILURE TO APPEAR).

DURING THE TERM OF SUSPENSION ALL LICENSES AND LICENSE PRIVILEGES OF NESTOR G. GARRIDO ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE) SUBJECT IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

Both these rulings were issued when these two ex-employees of trainer Jose Flores failed to appear for their hearings. The alleged violations were for methamphetamine positive tests.

(4) NAVARRO RULINGRULING #100

JOCKEY DIONICIO NAVARRO WHO RODE "TIO CHAYO" IN THE FOURTH RACE AT LOS ALAMITOS RACE COURSE ON SUNDAY, JULY 15, 2012, IS SUSPENDED THREE (3) RACING DAYS (JULY 27TH, 28TH AND 29TH, 2012) FOR FAILURE TO MAKE THE PROPER EFFORT TO MAINTAIN A STRAIGHT COURSE, CAUSING INTERFERENCE,

RESULTING IN THE DISQUALIFICATIONS OF HIS MOUNT FROM FIFTH TO EIGHTH POSITION. A VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1699 (RIDING RULES - CARELESS RIDING).

THE TERM OF THIS SUSPENSION SHALL NOT PROHIBIT PARTICIPATION IN DESIGNATED RACES IN CALIFORNIA.

This ruling was agreed upon after reviewing replays with jockey Navarro. The rider was cited for too much whip and little effort to maintain a straight course.

(5) JOCKEY REVIEWS DISQUALIFICATION

Jockey Alex Bautista reviewed last Sunday's fourth race disqualification of his mount with the Stewards. The rider was not held responsible as the horse suddenly ducked in.

(6) GOOD EVENING

Nine races were completed without a reportable incident.

RULING #109

GROOM ENRIQUE F. MOROYOQUI, HAVING FAILED TO APPEAR BEFORE THE BOARD OF STEWARDS AT LOS ALAMITOS RACE COURSE ON JULY 20, 2012, TO ANSWER A COMPLAINT REGARDING CASE #12LA0146, IS HEREBY SUSPENDED PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1547 (FAILURE TO APPEAR).

DURING THE TERM OF SUSPENSION ALL LICENSES AND LICENSE PRIVILEGES OF ENRIQUE F. MOROYOQUI ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE) SUBJECT IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

RULING #110

EXERCISE RIDER JUAN C. PASION, HAVING FAILED TO APPEAR BEFORE THE BOARD OF STEWARDS AT LOS ALAMITOS RACE COURSE ON JULY 20, 2012, TO ANSWER A COMPLAINT REGARDING CASE #12LA0151, IS HEREBY SUSPENDED PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1547 (FAILURE TO APPEAR).

DURING THE TERM OF SUSPENSION ALL LICENSES AND LICENSE PRIVILEGES OF JUAN C. PASION ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE) SUBJECT IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

These rulings were issued after two more of trainer Jose Flores' grooms failed to appear to

address their complaints. Six of Flores' grooms failed to appear and two were suspended for thirty days. All six were excluded from Los Alamitos by management.

(2) THIRD RACE – INQUIRY - DISQUALIFICATION

After the finish of the third race (Quarter Horse – 300 yards) the Stewards posted the Inquiry sign to review an incident about thirty yards from the wire. Involved were the second place finisher #4 "Fire Boom" (jockey Oscar Peinado) and the third place horse #5 "All Jock" (jockey Eulices Gomez). After talking with the riders involved and reviewing the replays, the Stewards unanimously agreed to disqualify #4 from second and place him third, behind #5, for interference nearing the finish. Replays show #4 lugging out into the path of #5, costing the latter a better placing.

(1) ARRIAGA RULING

RULING #111

JOCKEY GREGORIO ARRIAGA IS FINED THREE HUNDRED DOLLARS (\$300.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1688 (B-2) (USE OF WHIPS - WHIPPING IN POST PARADE) ON SATURDAY, JULY 21, 2012.

This ruling was issued after the rider admitted whipping his mount in the post parade of last night's fourth race.

(2) NICASIO RULING

RULING #112

JOCKEY EDUARDO NICASIO IS FINED ONE HUNDRED DOLLARS (\$100.00)* FOR FAILURE TO REPORT TO THE JOCKEY'S ROOM AT THE DESIGNATED TIME. A VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1680 (JOCKEYS AND DRIVERS TO REPORT).

This ruling was agreed upon when Mr. Nicasio failed to arrive at the Jockey's Room at the required time.

(3) JOCKEY REVIEWS DISQUALIFICATION

Jockey Oscar Peinado appeared, with his interpreter jockey Ramon Sanchez, to review last night's disqualification of his mount. Mr. Peinado appeared to be doing all in his power to maintain a straight course.

(4) FIRST RACE – INQUIRY - DISQUALIFICATION

After the finish of the first race (Quarter Horse – 300 yards) the Stewards posted the Inquiry

sign to review the start. Involved were the winner #1 "Ill Be A Dasher" (jockey Antonio Alberto) and the last place horse #2 "Presidio" (jockey Joel Cruz). After talking with the riders involved and reviewing the replays, the Stewards unanimously agreed to disqualify #1 from first and place him last for interference at the start. Replays show #1 veer out at the break and eliminate the three horses outside of him.
