(2) PULIDO RULINGRULING #149

TRAINER ARNOLDO PULIDO IS FINED TWO HUNDRED DOLLARS (\$200.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1629 (PENALTY FOR LATE DECLARATION - DID NOT RECEIVE LASIX) ON SEPTEMBER 23, 2012.

The foregoing ruling was issued after Mr. Pulido was given a telephonic hearing regarding his failure to have his horse treated with lasix in a timely manner resulting in a declaration. His excuse was that his groom failed to be there when the veterinarian arrived to treat the horse.

(3) THIRD RACE – LATE DECLARATION - REFUND

A refund was ordered in the third race when State Veterinarian Dr. Beck reported that #5 "Jona's Prospector" (Tr. S. Martinez) was unsound in the Receiving Barn. Declared by the Stewards. Refund: \$1,019.00.

(2) SECOND RACE – INQUIRY - DISQUALIFICATION

The Stewards immediately posted the Inquiry sign following the running of the second race (Quarter Horse – 300 yards) to review an incident at the start involving #4 "Iwannatacaboutme" (1st – jockey R. Sanchez), #3 "About To Fire" (5th – jockey C. Mendez) and #2 "Alpha Male" (6th – jockey O. Peinado).

After speaking with the riders involved and reviewing the tape replays, the Stewards unanimously agreed to disqualify #4 from first to last (6th) position. Replays show #4 ducking in bumping and impeding #3 and #2, costing the latter two an opportunity of better placement.

(2) SANCHEZ RULINGRULING #150

JOCKEY RAMON SANCHEZ WHO RODE "IWANNATACABOUTME" IN THE SECOND RACE AT LOS ALAMITOS RACE COURSE ON SATURDAY, SEPTEMBER 29, 2012, IS SUSPENDED THREE (3) RACING DAYS (OCTOBER 7TH, 12TH AND 13TH, 2012) FOR FAILURE TO MAKE THE PROPER EFFORT TO MAINTAIN A STRAIGHT COURSE, CAUSING INTERFERENCE, RESULTING IN THE DISQUALIFICATIONS OF HIS MOUNT FROM FIRST TO SIXTH POSITION. A VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1699 (RIDING RULES - CARELESS RIDING).

THE TERM OF THIS SUSPENSION SHALL NOT PROHIBIT PARTICIPATION IN DESIGNATED RACES IN CALIFORNIA.

The preceding ruling was issued after jockey Sanchez appeared to review the second race from last night's disqualification. Ramon failed to convince the Stewards that he made an adequate effort. Hence the above ruling.

This evening's racing program was conducted without noteworthy incident.
