(2) ALBERTO RULINGRULING #189

PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE # 1766 (DESIGNATED RACES), JOCKEY ANTONIO ALBERTO, HAVING PARTICIPATED IN MORE THAN ONE DESIGNATED RACE IN CALIFORNIA ON SUNDAY, NOVEMBER 25, 2012, SHALL SERVE AN ADDITIONAL SUSPENSION DAY – FRIDAY, DECEMBER 7, 2012, IN ORDER TO SATISFY THE TERMS OF L.A.Q.H. RULING # 185, DATED NOVEMBER 17, 2012.

The foregoing ruling was issued after Mr. Alberto participated in more than one trial race while under suspension.

(3) RODRIGUEZ RULINGRULING #190

OWNER JOSE ACEVES RODRIGUEZ, HAVING FAILED TO APPEAR BEFORE THE BOARD OF STEWARDS AT LOS ALAMITOS RACE COURSE ON NOVEMBER 17, 2012, TO ANSWER A COMPLAINT REGARDING CASE #12LA0256, ALLEGING VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1876 (A) (FINANCIAL RESPONSIBILITY) IS HEREBY SUSPENDED PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1547 (FAILURE TO APPEAR).

DURING THE TERM OF SUSPENSION ALL LICENSES AND LICENSE PRIVILEGES OF JOSE ACEVES RODRIGUEZ ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE) SUBJECT IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

The above ruling was issued when the owner failed to appear to address a financial complaint to Equine Sports Medicine in the amount of \$1,693.66.

(4) FIRST RACE - BREAKDOWN

During the running of the first race #4 "Delilah Jones," while racing in the clear, went wrong and unseated her rider near the 3/16 pole. Jockey was uninjured; unfortunately, #4 "Delilah Jones" was humanely destroyed.

Jockey Osvaldo Macias was removed from his mounts this evening after having tested positive for marijuana. Hearing will be scheduled to address this and additional infractions.

(3) SECOND RACE – INQUIRY – ACCIDENT – NO CHANGE

Following the running of the second race the Stewards immediately posted the Inquiry sign to review an incident near the 1/8 pole. Tapes reflect #5 "Rock N Roll Booty" (Tr. D. Frey – jockey O. Peinado) while racing in the clear broke down and fell, unseating the jockey. As no other horses were involved, the race was declared official. Peinado was transported to Los Alamitos General Hospital for observation. Unfortunately, #5 was euthanized.

(4) SIXTH RACE – LATE DECLARATION - REFUND

A refund was ordered in the sixth race when #6 "Study Hall Pierce" (jockey F. C. Rubio – Tr. C. Joiner) broke through the starting gate doors and ran off. Declared by the Stewards. No injury to rider or horse. Refund: \$17,189.00.
