RULING #1

GROOM FERNANDO R. COUTINO IS SUSPENDED THIRTY DAYS (30) FROM DECEMBER 30, 2012 THROUGH JANUARY 28, 2013, FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULES #1874 (DISORDERLY CONDUCT - UNDER THE INFLUENCE OF ALCOHOL AND FIGHTING) AND #1930 (OBEDIENCE TO SECURITY OFFICERS AND PUBLIC SAFETY OFFICERS- ATTEMPTING TO FIGHT WITH SECURITY AND POLICE) ON DECEMBER 25, 2012 AT 4:00 A.M.

The foregoing ruling was issued after hearing testimony from Mr. Coutino and Security. After threatening Security, Cypress police were summoned. Upon arrival, he attempted to pick a fight with the officers, prompting them to arrest him.

(3) NAVARRO REMOVED FROM MOUNTS

Acting upon information received from Los Alamitos investigators, jockey Dionicio Navarro was removed from his mounts this evening and will remain so until an investigation is completed.

RULING #2

OWNER ARMANDO LEON, HAVING FAILED TO APPEAR BEFORE THE BOARD OF STEWARDS AT LOS ALAMITOS RACE COURSE ON DECEMBER 28, 2012, TO ANSWER A COMPLAINT REGARDING CASE #12LA0296, ALLEGING VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1876 (A) (FINANCIAL RESPONSIBILITY) IS HEREBY SUSPENDED PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1547 (FAILURE TO APPEAR).

DURING THE TERM OF SUSPENSION ALL LICENSES AND LICENSE PRIVILEGES OF ARMANDO LEON ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE) SUBJECT IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

The above ruling was issued after owner Leon failed to appear to address charges of alleged violation of California Horse Racing Board Rule #1876.

(2) FILMS

Jockeys Cesar De Alba and Salvador Ibarra reviewed last evening's sixth race with the Stewards. De Alba's mount broke out as Ibarra's mount ducked in, making it rather tight on the equine between them. Fortunately, the troubled horse was off rather slowly and the outcome was not affected. Both riders admitted they were slow in reacting and in the future would make a more timely attempt to correct their mount's wayward course.

(3) COLD EVENING

The slightly off racetrack was inconsequential during a nearly flawless evening.

RULING #3

EXERCISE RIDER JARIO CARRILLO, HAVING APPEARED, TESTING NEGATIVE AND HAVING SIGNED A TEST AGREEMENT WITH THE CALIFORNIA HORSE RACING BOARD, IS RESTORED TO GOOD STANDING.

RULING #9 ISSUED AT LOS ALAMITOS RACE COURSE ON JANUARY 11, 2011, IS SET ASIDE.

After appearing before the Board of Stewards and having tested negative for any drugs, the above ruling was issued.

(2) FILM REVIEW

After reviewing the break of the first race with the Stewards, jockey Eulices Gomez admitted his horse broke out but felt that his effort to correct his horse was adequate. The Stewards agreed his attempt was admirable but felt he could have reacted a bit quicker. We felt no action was warranted.

(3) FIRST RACE – INQUIRY - DISQUALIFICATION

Following the first race the Inquiry was posted to examine the break. #7 "Dollar Or More" (5th – J. Cruz) broke in sharply, knocking #6 "Toby Fires" (7th – C. Mendez) into #5 "Warm Devotion" (6th – E. Gomez), eliminating any opportunity they may have had. After questioning the riders involved and reviewing the start, the Stewards in a unanimous decision disqualified "Dollar Or More."
