(2) HARVEY RULING

RULING #5

TRAINER CURTIS HARVEY JR. IS FINED TWO HUNDRED DOLLARS (\$200.00)\* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1629 (PENALTY FOR LATE DECLARATION - DID NOT RECEIVE LASIX) ON JANUARY 6, 2013.

The foregoing ruling was issued after Mr. Harvey's entry was declared because it did not receive lasix. The trainer stated the horse shipped in from Hollywood Park and allegedly his veterinarian could not find where the horse was located.

(3) LOPEZ RULING

RULING #6

IN THE MATTER OF: YESENIA LOPEZ

HAVING NOW SATISFIED THE OUTSTANDING FINANCIAL OBLIGATION TO EQUINE SPORTS MEDICINE, THE LICENSE PRIVILEGES OF OWNER YESENIA LOPEZ ARE RESTORED AND LOS ALAMITOS RACE COURSE RULING # 60, DATED APRIL 21, 2012, SUSPENDING YESENIA LOPEZ FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1547 (FAILURE TO APPEAR), IS HEREBY SET ASIDE AND YESENIA LOPEZ IS RESTORED TO GOOD STANDING.

The above ruling was issued after Equine Sports Medicine reported Ms. Lopez has fulfilled her financial agreement in full.

(4) MORALES RULING

RULING #7

GROOM EVERADO MORALES IS FINED TWENTY FIVE DOLLARS (\$25.00)\* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1530 (CASE NOT COVERED BY RULES AND REGULATIONS - SELLING FOOD AND DRINKS IN BARN AREA).

The preceding ruling was issued after subject was afforded a hearing. Subject was cited by Security for selling food and beverages on the backside.

(5) SECOND RACE – INQUIRY – NO CHANGE

The Inquiry sign was immediately posted by the Stewards following the second race to review an observed incident at the start involving #6 "Miss Moonlight Magic" (Tr. J. Moreno – jockey C. Mendez). Films reflect #6, while racing in a flipping halter, momentarily held the starting gate doors closed simultaneously to the start. Pursuant to California Horse Racing Board Rule #1696 (The Start), the horse was declared a starter.

(6) SIXTH RACE – INQUIRY – NO CHANGE

Following the running of the sixth race the Stewards posted the Inquiry sign to evaluate an incident at the start, which involved #4 "Realist" (jockey E. Nicasio – Tr. F. Vallejo). After talking with Starter John Baker and reviewing the tape replays, the Stewards opted to make the race official. Tapes reflect #4 rears up simultaneously to the start and unseats her rider. No injury to rider or horse.

(2) IBARRA RULINGRULING #8

JOCKEY SALVADOR IBARRA WHO RODE "TELLIN LIES" IN THE NINTH RACE AT LOS ALAMITOS RACE COURSE ON FRIDAY, JANUARY 11, 2013, IS SUSPENDED THREE (3) RACING DAYS (JANUARY 19TH, 20TH AND 25TH, 2013) FOR FAILURE TO MAKE THE PROPER EFFORT TO MAINTAIN A STRAIGHT COURSE, CAUSING INTERFERENCE, A VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1699 (RIDING RULES – CARELESS RIDING).

THE TERM OF THIS SUSPENSION SHALL NOT PROHIBIT PARTICIPATION IN DESIGNATED RACES IN CALIFORNIA.

The foregoing ruling was issued after jockey Ibarra appeared to review the ninth race from last night. Salvador failed to convince the Stewards that he made an adequate effort in controlling his mount. Hence the above ruling.

(3) SECOND RACE – LATE DECLARATION - REFUND

A refund was ordered in the second race when #4 "Carters Secret Doll" (Tr. S. Perez) became fractious in the starting gate and injured herself. Declared by the Stewards on recommendation of Track Veterinarian Dr. Tom Hackathorn. Refund: \$717.00.
