(2) GARCIA RULINGRULING #51

JOCKEY EDDIE GARCIA IS FINED TWO HUNDRED DOLLARS (\$200.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1930 (OBEDIENCE TO SECURITY OFFICERS AND PUBLIC SAFETY OFFICERS – DISRESPECT TO SECURITY AND OUTFRIDER) ON MARCH 1, 2013.

Jockey Eddie Garcia appeared before the Stewards as requested in regards to his disrespectful attitude towards the morning outrider. It was established Mr. Garcia used abusive language towards the outrider. Hence the above ruling.

(3) FIRST RACE – INQUIRY - DISQUALIFICATION

The Stewards immediately posted the Inquiry sign following the running of the first race (Thoroughbred – 4½ furlongs) to review an incident near the 1/8 pole which involved #4 “Rachels Belle”(2nd – jockey D. Torres) and #6 “Kalookan Desert”(4th – jockey L. Medina).

After speaking with the riders involved and reviewing the tape replays, the Stewards unanimously agreed to disqualify #4 from second to fourth position. Replays show #4 drifts in, bumping #6 off stride and costing him an opportunity of better placement.

JOCKEY CRUZ MENDEZ IS FINED THREE HUNDRED DOLLARS (\$300.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1688 (B-2) (USE OF WHIPS - WHIPPING IN POST PARADE) ON FRIDAY, MARCH 15, 2013.

The foregoing ruling was issued after jockey Mendez appeared before the Stewards accompanied by his agent Frank Quesada to address a whipping violation in last night's eighth race.

(3) SEVENTH RACE – LATE DECLARATION - REFUND

A refund was ordered in the seventh race when #1 “Surfers Dream” (Tr. A. Aquino – jockey

C. Mendez) became fractious in the starting gate and injured herself. Declared on recommendation of Track Veterinarian Dr. T. Hackathorn. Refund: \$25,751.00.

RULING #53

JOCKEY VICTOR CARRERO IS FINED ONE HUNDRED DOLLARS (\$100.00)* FOR FAILURE TO FULFILL HIS RIDING ENGAGEMENT AT LOS ALAMITOS RACE COURSE ON SATURDAY, MARCH 16, 2013. A VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1872 (FAILURE TO FULFILL JOCKEY AGREEMENT).

The above ruling was issued after Mr. Carrero failed to fulfill his riding engagement on Saturday, March 16, 2013 in the first race.

(2) FIFTH RACE – LATE DECLARATION - REFUND

A refund was ordered in the fifth race when #2 "Miss Dallas First" (Tr. R. Dominguez – jockey E. Gomez) was declared by the Stewards. Rider refused to ride mount. Refund: \$6,569.00.

(3) SIXTH RACE – EIGHT MINUTE DELAY

There was an eight minute delay prior to the running of the sixth race due to a tractor breakdown.
