03/19/2013

(1) DUTY STEWARD

The second race in the book for Friday, maidens two years old, was used open (2 CAL-BREDS). Sub #1 in the book, three and up for a \$5,000 claim, was used open with six horses (4 CAL-BREDS).

After consuming a good part of the day, Director of Racing Ron Church finally molded eight races, five Thoroughbred and three Quarter Horse events.

RULING #56

JOCKEY LEONARDO GONZALEZ IS FINED ONE HUNDRED DOLLARS (\$100.00)\* FOR FAILURE TO FULFILL HIS RIDING ENGAGEMENT AT LOS ALAMITOS RACE COURSE ON SATURDAY, MARCH 23, 2013. A VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1872 (FAILURE TO FULFILL JOCKEY AGREEMENT).

Jockey Leonardo Gonzalez, who failed to fulfill his riding engagement in last evening's fourth race, was represented by jockey Gregorio Arriaga at his informal hearing. Gregorio explained that Gonzalez had ridden in Arizona and Leonardo's flight arrived too late for him to fulfill his engagement here. The excuse was unacceptable, resulting in the foregoing ruling.
