**TUESDAY**

04/09/2013

(1) DUTY STEWARD

(2) BARWICK RULING

IN THE MATTER OF: RULING #66  
DENNIS BARWICK

HAVING NOW SATISFIED THE OUTSTANDING FINANCIAL OBLIGATION TO EQUINE SPORTS MEDICINE, THE LICENSE PRIVILEGES OF OWNER DENNIS BARWICK ARE RESTORED AND LOS ALAMITOS RACE COURSE RULING # 233, DATED NOVEMBER 6, 2011, SUSPENDING DENNIS BARWICK FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE # 1547 (FAILURE TO APPEAR), IS HEREBY SET ASIDE.

Having been notified that owner Dennis Barwick has satisfied his debt to Equine Sports Medicine, the above ruling was issued.

(3) CASE #13LA0078

Following an informal hearing and in accordance with California Horse Racing Board Rule #1844 (c)(1), a warning was issued.

(4) JIMENEZ RULING

RULING #67  
JOCKEY ALEX JIMENEZ WHO RODE "MEMBER OF THE TRIBE" IN THE SEVENTH RACE AT LOS ALAMITOS RACE COURSE ON SUNDAY, APRIL 7, 2013, IS SUSPENDED THREE (3) RACING DAYS (APRIL 19TH, 20TH, AND 21ST, 2013) FOR CAUSING INTERFERENCE RESULTING IN THE DISQUALIFICATION OF HIS MOUNT FROM FIRST TO FIFTH POSITION. A VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1699 (RIDING RULES – CARELESS RIDING).

After reviewing the seventh race Sunday with jockey Alex Jimenez, during which his mount was disqualified, the Stewards could see no effort on his part to avoid the perilous situation he created.

Friday was the first evening of the year for two year olds at Los Alamitos, and everything went extremely well.

(1) SECOND RACE DELAY

A ten minute delay occurred after the horses reached the starting gate when a pony horse collapsed behind the gate and expired. Dr. Hackathorn speculated the horse hemorrhaged and bled to death.

(2) SIXTH RACE DELAY

Prior to the sixth race the mutuel manager informed us that the Sacramento hub had frozen up, shutting down the entire state's ability to accept wagers. No one could offer any information as to what the problem was. After a one hour delay, the system was finally restored and the remainder of the program was completed. Tote was instructed that a detailed explanation of the circumstances surrounding the situation was to be made available to us. Included with this week's minutes please find a preliminary explanation of the status of the investigation.
