TUESDAY

07/16/2013

(1) DUTY STEWARD

(2) CAL-BRED REPORT

(1) TREECE RULINGRULING #108

TRAINER CHARLES TREECE IS FINED TWO HUNDRED DOLLARS (\$200.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1895 (TRAINER'S DUTY TO INSURE LICENSED PARTICIPATION – OWNER UNLICENSED).

The foregoing ruling was issued after Mr. Treece appeared before the Stewards concerning his failure to have his owner properly licensed.

(2) FIRST RACE – ACCIDENT – RIDER INJURED

When the horses were coming out of the Paddock onto the track for the first race, #2 "Taylor's Journey" (jockey A. Jimenez – Tr. V. Aguayo) unseated his rider. Jockey Jimenez was complaining about back discomfort and was replaced by jockey Ruben Lozano.

(3) SECOND RACE – JOCKEY OBJECTION – NO CHANGE

Following the running of the second race, jockey Genaro Tapia who rode #4 "No Photo Finish," who finished fifth, lodged a claim of foul against #5 "JDF Choice" for alleged interference shortly after the start. After a review of the film and the jockeys involved, it was a unanimous decision to let the original order of finish stand due to the fact the films did not verify the claim of foul.

(2) PEINADO RULINGRULING #109

JOCKEY OSCAR M. PEINADO WHO RODE "CHICKS ON WINGS" IN THE SEVENTH RACE AT LOS ALAMITOS RACE COURSE ON FRIDAY, JULY 19, 2013, IS SUSPENDED THREE (3) RACING DAYS (JULY 27TH, 28TH, AND AUGUST 2ND, 2013) FOR CAUSING INTERFERENCE. A VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1699 (RIDING RULES – CARELESS RIDING).

THE TERM OF THIS SUSPENSION SHALL NOT PROHIBIT PARTICIPATION IN DESIGNATED RACES IN CALIFORNIA.

The above ruling was issued after reviewing Friday night's seventh race with jockey Peinado. The films revealed nothing that could have been construed as an effort on his part.

(3) FILM REVIEW

Jockey Ramon Guce was in to review Friday night's third race. His mount shifted out slightly while racing down the backstretch, placing horses to his outside in tight quarters. The Stewards were of the opinion his reaction time was a bit slow. He was cautioned we expect a better effort.

(4) RUSSELL RULING

RULING #110

JOCKEY CHRIS RUSSELL IS FINED ONE HUNDRED DOLLARS (\$100.00)* FOR FAILURE TO FULFILL HIS RIDING ENGAGEMENT AT LOS ALAMITOS RACE COURSE ON FRIDAY, JULY 19, 2013. A VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1872 (FAILURE TO FULFILL JOCKEY AGREEMENT).

The foregoing ruling was issued for Mr. Russell failing to fulfill his riding engagement on Friday, July 19, 2013.
