Jockey Gerardo Pimient Gavica reviewed last evening's seventh race with the Stewards. His mount broke in at the start, inconveniencing the horse inside of him. The Stewards felt he was rather tardy reacting, and the films make it difficult to dispute that opinion.

(2) GONZALEZ RULINGRULING #10

JOCKEY LEONARDO GONZALEZ IS FINED ONE HUNDRED DOLLARS (\$100.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1680 (JOCKEYS AND DRIVERS TO REPORT – LATE TO JOCKEYS ROOM).

The foregoing ruling was issued after Jockey Leonardo Gonzalez asked for and was granted permission to come in late and then proceeded to barely get to the Jockey's Room in time to ride.

(3) IT'S DR. FITZGERALD AGAIN

For one more evening, Dr. Becky Fitzgerald will be the track veterinarian.

(4) FOURTH RACE – INQUIRY - DISQUALIFICATION

Following the fourth race, the Stewards posted the Inquiry to review the start. #4 "Our Secret Queen" (4th – E. Gomez) broke in, pushing #3 "El Ray Buccaneer" (5th – E. Garcia) into #2 "Z Best Contender" (6th – R. Valenzuela), who in turn was shoved into the flanks of #1 "Stel Heights" (1st – C. De Alba). Both horses were eliminated from any chance at a decent placing. After speaking with the involved riders and examining the films, the vote was unanimous to disqualify "Our Secret Queen."
