RULING #62

TRAINER GUILLERMO MORALES WHO STARTED THE HORSE "TR SPECIALTY" IN THE SECOND RACE ON DECEMBER 1, 2013 AT LOS ALAMITOS RACE COURSE IS FINED FIVE THOUSAND DOLLARS (\$5,000.00)* AND SUSPENDED SIXTY (60) DAYS (APRIL 7, 2014 THROUGH JUNE 5, 2014) PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1887 (TRAINER TO INSURE CONDITION OF HORSE) AND RULE #1859.5 (DISQUALIFICATION UPON POSITIVE TEST) FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULES #1843 (A,B&D) (MEDICATION, DRUGS AND OTHER SUBSTANCES) (CETIRIZINE – CLASS IV AND HYDROXYZINE – CLASS III) AND #1902 (CONDUCT DETRIMENTAL TO HORSE RACING).

DURING THE TERM OF SUSPENSION ALL LICENSES AND LICENSE PRIVILEGES OF GUILLERMO MORALES ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE) GUILLERMO MORALES IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

The foregoing ruling was issued after receiving confirmation from the California Horse Racing Board that the proposed decision concerning Trainer Guillermo Morales had been approved.

(3) AZCARATE RULING

RULING #63

TRAINER DANIEL AZCHARATE IS FINED ONE HUNDRED DOLLARS (\$100.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1874 (DISORDERLY CONDUCT – ABUSIVE AND DISRESPECTFUL BEHAVIOR TOWARDS CALIFORNIA HORSE RACING BOARD VETERINARIAN AND TRACK VETERINARIAN).

The above ruling was issued after Trainer Azcarate was very disrespectful to State Veterinarian Dr. Beck and Track Veterinarian Dr. Fitzgerald following the declaration of his horse from the seventh race Saturday evening.

(4) MONROY RULING

RULING #64

GROOM LEON M. MONROY IS FINED ONE HUNDRED DOLLARS (\$100.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1874 (DISORDERLY CONDUCT – UNDER THE INFLUENCE OF ALCOHOL).

The above ruling was issued after Mr. Monroy admitted to being intoxicated in the barn area.

(5) FILMS

Jockey Alex Bautista reviewed last Saturday's second race with the Stewards this afternoon. His mount broke in at the start, and we felt he could have reacted quicker than what he did. In lieu of days, a warning was issued for the incident.
