Before watching replays, Jockey Boulanger explained that he felt #5 "Sergeant Peto" had come down on his mount, #3 "Lightning McQue," causing him to take up slightly into the turn. However, after reviewing films with the Stewards, Jockey Boulanger admitted he had more room than he thought. Jockey Boulanger was cautioned to go ahead and claim foul when necessary but to make sure there was substance to that claim.

RULING #154

JOCKEY RODOLFO ARVIZU IS FINED ONE HUNDRED DOLLARS (\$100.00)\* FOR FAILURE TO FULFILL HIS RIDING ENGAGEMENT AT LOS ALAMITOS RACE COURSE ON SUNDAY, AUGUST 10, 2014. A VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1872 (FAILURE TO FULFILL JOCKEY AGREEMENT).

The above ruling was issued after Jockey Rodolfo Arvizu appeared before the Stewards to explain his failure to ride his mount in the second race on Sunday, August 10, 2014. Jockey Arvizu offered the explanation that he had transportation problems.

(1) FIRST RACE – STEWARDS INQUIRY - ACCIDENT

Immediately following the running of the first race, the Stewards posted the Inquiry sign to review two mishaps. First, #3 "There Goes Kevin" went wrong at the ½ mile pole and was pulled up by Jockey Gary Boag, who dismounted and waited for help to arrive. "There Goes Kevin" was transported by Equine Ambulance back to Trainer Jerry Wallace's barn and euthanized.

The second mishap involved #4 "Kevinator," who broke down, unseating Jockey Vinnie Bednar, who was thrown to the track surface. Jockey Bednar was immediately attended to by E.M.T.'s and was able to return to the Jockey's Quarters on his own accord. "Kevinator" was euthanized on site.
