(2) MENDEZ RULING

RULING #168

JOCKEY SANTIAGO MENDEZ WHO RODE "SCUBA DOO" IN THE FOURTH RACE AT LOS ALAMITOS RACE COURSE ON SUNDAY, SEPTEMBER 7, 2014, IS SUSPENDED THREE (3) RACING DAYS (SEPTEMBER 20TH, 21ST, AND 26TH, 2014) FOR FAILURE TO MAKE THE PROPER EFFORT TO MAINTAIN A STRAIGHT COURSE, CAUSING INTERFERENCE RESULTING IN THE DISQUALIFICATION OF HIS MOUNT FROM FOURTH TO SEVENTH. A VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1699 (RIDING RULES – CARELESS RIDING).

THE TERM OF THIS SUSPENSION SHALL NOT PROHIBIT PARTICIPATION IN DESIGNATED RACES IN CALIFORNIA.

The foregoing ruling was issued after Jockey Mendez appeared to review the fourth race on Sunday in which his mount was disqualified. Santiago failed to convince the Stewards that he made an adequate effort in controlling his mount at the start.

(3) FIRST RACE – CLAIM OKAY

The first race claim of "Divine Josephine" was allowed after State Veterinarian Dr. Gary Beck reported the filly was unsound, because the claim card was marked "yes." Therefore, the claim was valid.

(4) ALL CLEAR

This evening's racing program was conducted without noteworthy incident.

(2) THIRD RACE – ACCIDENT - DISQUALIFICATION

Following the running of the third race, the Stewards posted the Inquiry sign to review an incident shortly after the start, which involved #3 "Captain On Takeoff" (Jockey R. Sanchez – dead heat – 3rd), #2 "Bigtime Bonnies" (fell), and #1 "Bouncer" (Jockey A. Luna – dead heat – 3rd). After speaking with the riders involved and reviewing the tape replays, the Stewards unanimously agreed to disqualify #3 from a dead heat for third to being unplaced. Replays reflect #3 drifts in soon after the start, causing #2 to clip heels and lose his rider. Jockey Aceves was transported to Los Alamitos General Hospital for observation. The horse was okay.
