**FRIDAY**

10/24/2014

**(1) DUTY STEWARD**

Entries this week will be under the supervision of James Dreyer, who will also be responsible for the minutes.

**(2) CAL-BRED REPORT**

The second race in the book, maiden two year olds, was called off with one (0 CAL-BREDS). Sub #2 in the book for Friday, two year olds for an \$8,000 claim, was off with one (1 CAL-BRED).

**(3) STAKE POSTPONED**

For reasons that will be discussed at a later date, the Town Policy Stakes has been temporarily postponed.

**(4) THE DRAW**

Nine races will be offered Friday evening consisting of three Thoroughbred and six Quarter Horse races.

Dr. Allred dropped by this morning to inform me that Veterinarian Troy Ford, who practices in the Fresno area, had been approached by an unnamed individual who attempted to get Dr. Ford to give him a prescription for Clenbuterol for one of Juan Aleman's horses and to predate it by several months. Dr. Ford advised Dr. Allred he would be willing to testify if necessary.

The Stewards were notified this afternoon that Dr. Becky Fitzgerald was in the hospital giving birth and Dr. Ashley Troncatty will be substituting.

(3) FILMS

Jockey Eddie Aceves was in to review Friday's fourth race. His mount drifted in at the start, and although he did straighten him, we felt he could have reacted a little quicker. He agreed and assured us that in the future he would do a better job.

(4) THIRD RACE – CLAIM VOIDED

The third race claim of "Rachels Belle" by Trainer Justin Clark was voided after she was placed on the Vet's List as unsound by Dr. Beck. The mare was returned to Trainer Jose Moreno.

(5) RACE DELAY

There was a thirty-three minute delay after one of the two horses that broke through the gate prior to the start of the seventh race jumped the inside rail and ended up in the lake. Enough praise cannot be bestowed on Outrider Eric Newdick after he jumped into the water and singlehandedly placed girths around the gelding so he could be lifted out of the lake. Also instrumental in the rescue were the gate and maintenance crews. It appears that "Walk The Dog" is going to be just fine.
