HAVING NOW COMPLIED WITH LOS ALAMITOS RACE COURSE RULING #148, DATED AUGUST 1, 2014, THE LICENSE PRIVILEGES OF OWNER LUIS M. RAMIREZ ARE RESTORED AND LOS ALAMITOS RACE COURSE RULING #202, DATED NOVEMBER 21, 2014, SUSPENDING MR. RAMIREZ, IS HEREBY SET ASIDE.

The above ruling was issued after notification that Mr. Ramirez had satisfied his debt to Los Alamitos Race Course in full.

RULING #50

IN THE MATTER OF: JOSE CORONADO

HAVING NOW SATISFIED THE OUTSTANDING FINANCIAL OBLIGATION TO EQUINE SPORTS MEDICINE, THE LICENSE PRIVILEGES OF OWNER JOSE CORONADO ARE RESTORED AND LOS ALAMITOS RACE COURSE RULING #66, DATED APRIL 5, 2014, SUSPENDING MR. CORONADO FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1876 (FINANCIAL RESPONSIBILITY) IS HEREBY SET ASIDE AND JOSE CORONADO IS RESTORED TO GOOD STANDING.

RULING #51

IN THE MATTER OF: AURELIANO PORTILLO

HAVING NOW SATISFIED THE OUTSTANDING FINANCIAL OBLIGATION TO EQUINE SPORTS MEDICINE, THE LICENSE PRIVILEGES OF OWNER AURELIANO PORTILLO ARE RESTORED AND LOS ALAMITOS RACE COURSE RULING #67, DATED APRIL 5, 2014, SUSPENDING MR. PORTILLO FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1876 (FINANCIAL RESPONSIBILITY) IS HEREBY SET ASIDE AND AURELIANO PORTILLO IS RESTORED TO GOOD STANDING.

The foregoing two rulings were issued when the Stewards were informed by Sports Equine Medicine that both subjects' debt to them had been satisfied.

RULING #52

OWNER JENS LARSEN, HAVING FAILED TO ABIDE BY A FINANCIAL AGREEMENT WITH EQUINE SPORTS MEDICINE IS SUSPENDED FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1876 (A) (FINANCIAL RESPONSIBILITY)

DURING THE TERM OF SUSPENSION ALL LICENSES AND LICENSE PRIVILEGES OF JENS LARSEN ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE) SUBJECT IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

RULING #53

OWNER RAUL ROMERO, HAVING FAILED TO ABIDE BY A FINANCIAL AGREEMENT WITH EQUINE SPORTS MEDICINE IS SUSPENDED FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1876 (A) (FINANCIAL RESPONSIBILITY)

DURING THE TERM OF SUSPENSION ALL LICENSES AND LICENSE PRIVILEGES OF RAUL ROMERO ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE)

SUBJECT IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

The above two rulings were issued after both subjects failed to abide their agreement with Sports Equine Medicine.

(2) FIRST RACE – JOCKEY OBJECTION – NO CHANGE

Following the running of the first race, Jockey Gary Boag, who rode #5 "Pride Of Wilshire" (3rd), lodged an Objection against #6 "Tribal Flash" (1st – Jockey C. Charlton) for alleged interference at the start. After a review of the film and talking to the jockeys involved, it was a unanimous decision to let the original order of finish stand due to the fact the films did not verify the claim of foul.

(3) THIRD RACE – LATE DECLARATION - REFUND

A refund was ordered in the third race as #5 "Perfect Genius" (Tr. E. January) was off in front during the warm-up and was declared on recommendation of Track Veterinarian Dr. Fitzgerald. Refund: \$8,830.00.

(4) FOURTH RACE – JOCKEY OBJECTION – NO CHANGE

After the running of the fourth race (Thoroughbred & Quarter Horse – 870 yards), the Stewards posted the Objection sign at the request of Jockey Cheryl Charlton (5th - #3 – "Versye") against #6 "Southern Sunrise" (1st – Jockey G. Boag) for alleged interference near the ¼ pole. After speaking with the riders involved and reviewing film replays, which were inconclusive, the Stewards declared no change in the order of finish.
