DURING THE TERM OF SUSPENSION ALL LICENSES AND LICENSE PRIVILEGES OF JOSE R. OLIVAS ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE) SUBJECT IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

The above ruling was issued after Owner Jose Olivas failed to appear to address a financial complaint by Equine Sports Medicine in the amount of \$520.25.

SANCHEZ, HAVING FAILED TO APPEAR BEFORE THE BOARD OF STEWARDS AT LOS ALAMITOS RACE COURSE ON OCTOBER 9, 2015, TO ANSWER A COMPLAINT REGARDING CASE #15LA0227, ALLEGING VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1876 (A) (FINANCIAL RESPONSIBILITY) IS HEREBY SUSPENDED PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1547 (FAILURE TO APPEAR).

DURING THE TERM OF SUSPENSION ALL LICENSES AND LICENSE PRIVILEGES OF JUAN L. SANCHEZ ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE) SUBJECT IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

This ruling was issued after Owner Juan Sanchez failed to appear to address a financial complaint by Equine Sports Medicine in the amount of \$891.50.

DURING THE TERM OF SUSPENSION ALL LICENSES AND LICENSE PRIVILEGES OF KENNETH A. CLERISSE ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE) SUBJECT IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

The above ruling was issued after Exercise Rider Kenneth Clerisse failed to appear to address charges of alleged violation of Rule #1489 (h) (Grounds for Denial or Refusal of License) as noted in Case #15LA0210.

(4) SILVA RULING

RULING #163

EXERCISE RIDER CIRILO L. SILVA, HAVING FAILED TO APPEAR BEFORE THE BOARD OF STEWARDS AT LOS ALAMITOS RACE COURSE ON OCTOBER 10, 2015, TO ANSWER A COMPLAINT REGARDING CASE #15LA0211, ALLEGING VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE 1489 (H) (GROUNDS FOR DENIAL OR REFUSAL OF LICENSE) IS HEREBY SUSPENDED PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1547 (FAILURE TO APPEAR).

DURING THE TERM OF SUSPENSION ALL LICENSES AND LICENSE PRIVILEGES OF CIRILO L. SILVA ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE) SUBJECT IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

The above ruling was issued after Exercise Rider Cirilo Silva failed to appear to address charges of alleged violation of Rule #1489 (h) (Grounds for Denial or Refusal of License) as noted in Case #15LA0211.

(5) FIFTH RACE – CLAIM VOIDED

The fifth race \$2,500 claim of #4 "Rainsford" by Trainer Elmer January was voided post-race after the three year old gelding was placed on the Vet's List as unsound by Dr. Beck. "Rainsford" was returned to Trainer Sergio Fiscal's barn.

(6) NINTH RACE – MINOR INCIDENT

Except for a minor incident in the ninth race where one of the favorites broke through the gates necessitating a scratch, it was another good night of racing.

(2) MARQUEZ FILM REVIEW

Jockey Carlos Marquez appeared before the Stewards to review his ride in the seventh race on Friday, October 9, 2015 where his mount, #3 "RV Stoliback," broke in and bothered #2 "Preener." Film review evidenced the incident happening right out of the gate and that "Preener" was a contributing factor in having broke slow. Jockey Marquez was given a pass on the incident.

(3) MENDEZ FILM REVIEW & RULING

RULING #164

JOCKEY SANTIAGO MENDEZ IS FINED TWO HUNDRED DOLLARS (\$200.00)\* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1688(b)(6) (USE OF RIDING CROP – MORE THAN THREE TIMES IN SUCCESSION WITHOUT GIVING THE HORSE A CHANCE TO RESPOND - FIRST OFFENSE), DURING THE SIXTH RACE AT LOS ALAMITOS RACE COURSE ON OCTOBER 10, 2015.

The foregoing ruling was issued after Jockey Santiago Mendez and the Stewards reviewed the film replays of the sixth race on October 10, 2015. Jockey Mendez acknowledged his violation but stated his error was not in multiple strikes but rather in not allowing his mount the time to respond.

(4) LOZANO FILM REVIEW & RULING

RULING #165

JOCKEY RUBEN LOZANO IS FINED TWO HUNDRED DOLLARS (\$200.00)\* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1688(b)(6) (USE OF RIDING CROP – MORE THAN THREE TIMES IN SUCCESSION WITHOUT GIVING THE HORSE A CHANCE TO RESPOND - FIRST OFFENSE), DURING THE SIXTH RACE AT LOS ALAMITOS RACE COURSE ON OCTOBER 10, 2015.

The foregoing ruling was issued after Jockey Ruben Lozano reviewed the sixth race on October 10, 2015 with the Stewards. Jockey Lozano acknowledged that he erred in striking his mount more than the allowed three times in succession, stating that he was trying to comply with the rule but had miscounted.

(5) ANOTHER GOOD NIGHT OF RACING

Another good night of racing with three Los Alamitos Super Derby Trials was run with an

impressive field of three year olds competing.
