Report of the Board of Stewards for the week of December 8, 2015 through December 13, 2015.

TUESDAY

12/08/2015

(1) DUTY STEWARD

Ruben Moreno will be on duty this week attending to morning office matters and recording the minutes during this reporting period.

(2) ENTRIES AND DRAW

Eight races were drawn for Friday night's card consisting of two Thoroughbred and six Quarter Horse events. The draw was completed at 1:45.

(3) CAL-BRED REPORT

Sub Race No.5 in the book for Friday, California-Bred three year olds and upward, claiming price \$10,000 going 330 yards, failed to fill with three entries (3 CAL-BREDS).

WEDNESDAY

12/09/2015

(1) SCRATCHES

Friday scratches were taken at 9:00 a.m. resulting in one scratch, no rider changes and one equipment change for Friday evening's program.

(2) ENTRIES AND DRAW

Preliminary draws were taken for Saturday's Champion of Champions and Sunday's Los Alamitos Two Million Futurity at 10:00 a.m. in the Racing Office and at 1:45 p.m. the final draw for the two big races was televised by TVG. The final draw for Saturday night's other eight race was completed at 3:00 p.m. In total Saturday night's program will have three Thoroughbred and six Quarter Horse events with the highlight being the Champion of Champions.

(3) CAL -BRED REPORT

The seventh race in the book for Saturday, California-Bred three year olds and upward, claiming price \$8,000 going 330 yards was off with one entry (1 CAL-BRED).

THURSDAY

12/10/2015

(1) SCRATCHES

Scratch time for Saturday night's program was conducted promptly at 9:00 a.m. resulting in one weight correction, no scratches, no rider changes, and no equipment changes for Saturday evening's program.

(2) ENTRIES AND DRAW

Sunday night's card will consist of nine races with four Thoroughbred and five Quarter Horse events. The draw for the Los Alamitos Two Million Futurity was completed in TVG's televised broadcast on Wednesday. The draw for Sunday's remaining eight races was completed at 1:00.

(3) CAL-BRED REPORT

Sub race No. 1 in the book for Sunday, California Bred two year olds, claiming price \$8,000, going 300 yards failed to fill with no entries (0 CAL-BRED).

FRIDAY

12/11/2015

(1) SCRATCHES

Sunday scratches were taken at 9:00 a.m. resulting in one scratch, three also-eligible scratches, one rider change and no equipment changes for Sunday evening's program.

(2) STEWARDS CONTINUED DISCUSSION ON MORROW'S COMPLAINT-CASE #SA0232

After consulting California Horse Racing Board legal counsel, this Board of Stewards will stay the current proceedings against Trainer Shaun Morrow pending acquisition of additional information regarding Mr. Morrow's bankruptcy petition, or the conclusion of his petition in federal court.

(3) DE LA TORRE FILM REVIEW

Jockey Julio De La Torre was in to review his ride in the second race on Sunday, December 6, 2015 aboard #7 "Yn Jamaikino" where he struck his horse numerous times in violation of the new crop rule. When questioned Jockey De La Torre stated he had just started riding again in California and was unaware of California Horse Racing Board Rule 1688 (Use of Riding Crop). Jockey De La Torre was issued a warning.

(4) SHIDAKER FINANCIAL HEARING

Case No. 15LA0272, a financial complaint lodged by Veterinarian Nicola Hardgrove against Owner/Trainer Duff Shidaker alleging a past due balance of \$1,414.50 was successfully mediated with both parties agreeing to a \$1,000.00 settlement.

(5) L'HEURUEX FINANCIAL HEARING

Pony rider Danielle L'Heurux appeared before the Stewards to address Case No. 15LA0275, a financial complaint filed by Chett Marketing Inc. alleging Ms. L'Heurux owed \$73.34. Ms. L'Heurux agreed to pay \$50.00 within a week and a final payment of \$23.34 by January 15, 2016. Chett Marketing Inc. representative Cheri Willett agreed to the terms.

(6) MARQUEZ RULING

RULING #207

PONY RIDER RODOLFO MARQUEZ, HAVING FAILED TO APPEAR BEFORE THE BOARD OF STEWARDS AT LOS ALAMITOS RACE COURSE ON DECEMBER 11, 2015, TO ANSWER A COMPLAINT REGARDING CASE #15LA0273, ALLEGING VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1876 (A) (FINANCIAL RESPONSIBILITY) IS HEREBY SUSPENDED PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1547 (FAILURE TO APPEAR).

DURING THE TERM OF SUSPENSION ALL LICENSES AND LICENSE PRIVILEGES OF RODOLFO MARQUEZ ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE) SUBJECT IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

The above ruling was issued after Pony Rider Rodolfo Marquez failed to contact or appear before the Stewards concerning Case No. 15LA0273, a financial obligation to Chett Marketing Inc. in the amount of \$342.40.

(7) EIGHTH RACE – ACCIDENT

Shortly after the running of the eighth race #3 "Blabber" fell to the track surface, unseating Jockey Carlos Huerta. Jockey Huerta was immediately attended to by the EMT's and transported to the hospital for further medical care. "Blabber" was able to rise and walked away from the incident

with no injuries.

OWNER STEVE MINGIONE, HAVING FAILED TO APPEAR BEFORE THE BOARD OF STEWARDS AT LOS ALAMITOS RACE COURSE ON DECEMBER 12, 2015, TO ANSWER A COMPLAINT REGARDING CASE #15LA0274, ALLEGING VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1876 (A) (FINANCIAL RESPONSIBILITY) IS HEREBY SUSPENDED PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1547 (FAILURE TO APPEAR).

DURING THE TERM OF SUSPENSION ALL LICENSES AND LICENSE PRIVILEGES OF STEVE MINGIONE ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE) SUBJECT IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

The above ruling was issued after Owner Steve Mingione failed to contact or appear to address a financial complaint alleging money owed to Chett Marketing Inc. in the amount of \$294.46.
