RULING # 16

OWNER HERIBERTO RAMOS PABON IS FINED FIFTY DOLLARS (\$50.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1874 (DISORDERLY CONDUCT-FAILED TO FOLLOW INSTRUCTIONS OF IDENTIFIER ERIC NAJDUCH) AND #1530 (CASES NOT COVERED BY RULES AND REGULATIONS – USING CELL PHONE IN RECEIVING BARN).

The foregoing ruling was issued after owner Pabon appeared to address Citation #8315. Mr. Pabon admitted to kneeling beside the horse's stall he was tending to while using his cellphone. If the horse had become fractious this could have created a very dangerous situation. He also became very rude and argumentative.

Jockey Jairo Rangel was in to review Sunday's fourth race today. After a closer look at the race the Stewards felt that Rangel was not in violation of Rule #1688 (b)(6) as first thought.

The Stewards posted the inquiry following the ninth race to review an incident shortly after the break. #1 Chicks Fayvorite (3rd – J. Ayala) stumbled at the start then drifted out causing #2 Miss Loujean (4th – V. Bednar) to check. The margin between the two horses at the wire was a half length. The Stewards felt that the incident cost Miss Loujean that much ground and voted unanimously to place Chicks Fayvorite behind Miss Loujean.
