JOCKEY JOSE NICASIO IS FINED ONE HUNDRED AND FIFTY DOLLARS (\$150.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1688(b)(6) (USE OF RIDING CROP-MORE THAN THREE TIMES IN SUCCESSION, WITHOUT GIVING THE HORSE A CHANCE TO RESPOND-THIRD OFFENSE WITHIN THE PREVIOUS 60 DAY PERIOD), DURING THE SIXTH RACE AT LOS ALAMITOS RACE COURSE ON JANUARY 6, 2019.

After Jockey Jose Nicasio clearly violated Rule #1688 (b)(6), the foregoing ruling was issued.

RULING # 15

GROOM CESAR HURTADO, HAVING FAILED TO RESPOND TO A COMPLAINT ALLEGING VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1890 (POSSESSION OF CONTRABAND – DRUG PARAPHERNALIA) AND REFUSAL TO TEST, IS SUSPENDED FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1547 (FAILURE TO APPEAR).

DURING THE TERM OF SUSPENSION, ALL LICENSES AND LICENSE PRIVILEGES OF CESAR HURTADO ARE SUSPENDED AND PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1528 (JURISDICTION OF STEWARDS TO SUSPEND OR FINE), CESAR HURTADO IS DENIED ACCESS TO ALL PREMISES IN THIS JURISDICTION.

The foregoing ruling was issued after groom Cesar Hurtado failed to appear to answer complaint #18LA0302.

(2) INQUIRY-NO CHANGE

The Stewards posted the inquiry following the fourth race to review an incident midway through the race. The horses involved were #4 "Paddys Princess (3rd J. Rangel) and #5 "One Way Woman" (4th J. Nicasio). After speaking to the riders involved and reviewing the films, the Stewards felt that both horses contributed to what amounted to minimal contact on approximately three occasions and that no change was warranted. The decision was unanimous.

JOCKEY ERICK GARCIA IS FINED FIFTY DOLLARS (\$50.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1688(b)(6) (USE OF RIDING CROP-MORE THAN THREE TIMES IN SUCCESSION, WITHOUT GIVING THE HORSE A CHANCE TO RESPOND-FIRST OFFENSE WITHIN THE PREVIOUS 60 DAY PERIOD), DURING THE FIRST RACE AT LOS ALAMITOS RACE COURSE ON JANUARY 12, 2019.

The foregoing ruling was issued after Jockey Erick Garcia violated Rule #1688 (b)(6) during the running of last evening's first race.

(2) FILMS

Jockey Ruben Lozano was in to review last evening's sixth race. His mount broke out and we felt he could have reacted a bit quicker than he did. The only saving factor is the fact that the horse next to him was off a bit slowly, so we felt a warning would suffice in this situation.

(3) OBJECTION-NO CHANGE

Following the first race, Jockey Johnny Andre Allen on #5 "Louder California" (4th) claimed an objection on #1 "Callie Mesa" (3rd -E. Payeras) going into the far turn. After speaking with the riders involved and examining the films, the Stewards could find nothing to support his claim and voted unanimously to let the original order stand.
