PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1766 (DESIGNATED RACES), JOCKEY JAIRO RANGEL, HAVING PARTICIPATED IN MORE THAN ONE DESIGNATED RACE WHILE UNDER SUSPENSION, SHALL SERVE ONE ADDITIONAL SUSPENSION DAY (AUGUST 16, 2020) IN ORDER TO SATISFY THE TERMS OF L.A.Q.H. RULING #175, DATED JULY 26, 2020.

The above ruling was issued after Jockey Rangel rode both of the Golden State Derby Trials.

(3) RULINGS #183

Ruling #183

EXERCISE RIDER JAVIER MORENO PENA IS FINED ONE HUNDRED DOLLARS (\$100*) AND PLACED ON PROBATION FOR AS LONG AS HE HOLDS A CALIFORNIA HORSE RACING BOARD LICENSE FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1874 (DISORDERLY CONDUCT). ADDITIONALLY, JAVIER MORENO PENA IS REQUIRED TO SIGN A TESTING AGREEMENT WITH THE CALIFORNIA HORSE RACING BOARD AND RE-ENTER THE WINNERS FOUNDATION.

Following an informal hearing the above ruling was issued. Mr. Pena brought a horse to the paddock last Sunday and was so intoxicated he had to be relieved of his responsibilities. He explained he had completed his classes with the Winners Foundation and had been doing well until this incident which was brought on by some personal problems. He was told this will be his final opportunity.

The second race claim of Two Fifty Coup by Sal Naranjo was voided after the gelding was placed on the Vet's list as unsound by Dr. Beck. He was returned to trainer Jerry Wallace II.
