Ruling #200

JOCKEY CHRISTIAN ARAGON IS FINED ONE HUNDRED DOLLARS (\$100.00)* FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1688 (B)(2) (USE OF RIDING CROP- STRUCK HORSE DURING POST PARADE – 2ND RACE) AT LOS ALAMITOS RACE COURSE ON SEPTEMBER 4, 2020.

Ruling #201

GROOM RAYMUNDO LARIOS, HAVING APPEARED AS ORDERED, IS RESTORED TO GOOD STANDING. RULING #164, ISSUED AT LOS ALAMITOS RACE COURSE ON JULY 18, 2020, IS SET ASIDE. PURSUANT TO CALIFORNIA HORSE RACING BOARD RULE #1900 (GROUNDS FOR SUSPENSION OR REVOCATION) RAYMUNDO LARIOS IS SUSPENDED FOR FIFTEEN (15) DAYS FOR VIOLATION OF CALIFORNIA HORSE RACING BOARD RULE #1489 (H) (ENGAGED IN THE USE OF DRUGS - METHAMPHETAMINE). HOWEVER, WITH CREDIT FOR TIME SERVED, RAYMUNDO LARIOS IS ELIGIBLE TO BE RE-LICENSED WITH THE PROVISION THAT HE SIGNS A TESTING AGREEMENT WITH THE CALIFORNIA HORSE RACING BOARD AND REMAINS ON PROBATION FOR AS LONG AS HE HOLDS A LICENSE ISSUED BY THE CALIFORNIA HORSE RACING BOARD.

(2) JOCKEY REPLACED

6th Race #1 jockey Jairo Rangel reported an illness in his family and was relieved of his duties.

(3) FILMS

Jockey Christian Aragon was present to address his violation of the riding crop rule during the post parade. In view of the fact that the horse "Maz Kanata" had thrown him twice an appropriate penalty was issued.

Jockey Irving Lara was present to review the actions that caused the disqualification of his mount "Outta Dodge" (6th race #5 9/4/2020) and upon review it was the Stewards opinion that Irving Lara

could not have prevented his horse from interfering with other horses after the break therefore no penalty was issued.
