Stewards Kim Sawyer and Albert Christiansen will be present for entries and declarations for the three days prior to opening day Friday, September 5, 2008.

09/02/08² **THE DRAW**
Thirteen races were drawn for opening day. One Quarter Horse and twelve Thoroughbred races made up the card.

WEDNESDAY

09/03/08¹ **THE DRAW**
Thirteen races once again were drawn for the Saturday program. All races were for Thoroughbreds.

THURSDAY

09/04/08¹ **SCRATCHES**
Five scratches and three rider changes were completed by the 10:00 a.m. scratch time.

09/04/08² **THE DRAW**
Eleven Thoroughbred races were drawn for Sunday's program.

09/04/08³ **CAL-BRED REPORT**
Two Cal-Bred races were on the opening day program. The ninth race on the card for maiden three year olds and upward, claiming price \$32,000, at six and one half furlongs attracted seventeen entries. The tenth race for maiden two year olds, going six and one half furlongs, had nine participants.

Trainer JERRY WALLACE is fined THREE HUNDRED DOLLARS (\$300.00)* pursuant to California Horse Racing Board rule #1629 (Penalty for Late Declaration), for violation of California Horse Racing Board rule #1843.5 (Horse Improperly Medicated), necessitating the late declaration of BRADS STORM TIME from the ninth race on Friday, September 5, 2008.

09/05/08⁴ **STEWARDS' INQUIRY – ACCIDENT – NO CHANGE**
After the finish of the fourth race (Seven furlongs), the Stewards posted the inquiry sign to review an incident shortly after the start. Involved were #1 Yoursmynanours (MEX) (Jockey Tyler Baze) and #4 Just Miss (Apprentice jockey Michael Martinez). Shortly after the start, almost simultaneously, #1 and

#4 ducked in, unseating both riders. No other horses were affected. Accident report attached.

09/06/08³**CAL-BRED REPORT**

The sixth race on today's card for Cal-Bred maidens, two years old, at 6 ½ furlongs, was contested with six horses.

09/06/08⁴**MEETING WITH JOCKEYS**

Before the first race, the Stewards ventured to the jockey's room. Ten to twelve riders were present along with Jockey's Guild Regional Manager Darrell Haire. The basic riding rules, emphasizing the five-eighths track differences, the usual rules regarding the track policies, and quick official procedures were covered. The riders were afforded comments; complaints were noted and responded to.

09/06/08⁵**STEWARDS' INQUIRY / ACCIDENT – NO CHANGE**

After the finish of the fourth race (Six furlongs) the Stewards posted the inquiry sign to review a spill approaching the eighth pole. Involved were #1 Russian

Liquor (jockey Martin Garcia), and #5 Cotati (jockey Matt Garcia). Tape replays show #1, racing on the lead, crosses his front legs and falls. #4 Dawn's Day (jockey Martin Pedroza), jumped the prone #1; however, #5, traveling behind #4, unsuccessfully attempted to jump #1 and tripped, unseating jockey Matt Garcia.

Jockey Martin Garcia was okay and rode the remainder of his mounts. Jockey Matt Garcia appeared dazed, and was transported to the hospital. Accident reports attached.

09/06/08⁶**STEWARDS' INQUIRY - DISQUALIFICATION**

After the finish of the eighth race (Six and one half furlongs) the Stewards posted the inquiry sign to review an incident nearing the wire. Involved were the second place finisher #1 Caribbean Boy (jockey Joy Scott) and the third place finisher #4 City Lights (jockey Luis Contreras). After receiving the three patrol judges' reports, talking with the riders involved and reviewing the replays, the Stewards unanimously agreed to disqualify #1 from second position and place him third behind #4, for interference about twenty yards from the finish. Replays show #1 drift in and bump #4 off stride, costing the latter the opportunity at second place.

09/07/08⁴**RULING #2**

Jockey Joy Scott appeared before the Stewards to address the disqualification of her mount in Saturday's eighth race. Jockey Scott contended she made the proper effort to straighten her mount. The Stewards, however, were of the opinion that she reacted too late and could have avoided the interference.

LAFP #02

Jockey JOY SCOTT, who rode CARIBBEAN BOY in the eighth race at Fairplex Park on September 6, 2008, is suspended for THREE (3) racing days (September 14, 15, and 17, 2008) for failure to make a proper effort to maintain a straight course in the stretch, causing interference which resulted in the disqualification of her mount from second to third position. California Horse Racing Board rule #1699 (Riding Rules – Careless riding). Term of suspension shall not prohibit participation in designated races in California.

09/07/08⁵**INFORMAL HEARING**

Trainer Peter Miller and Racing Veterinarian Dr. Jill Bailey, D.V.M. appeared at the Stewards' Office to address a complaint concerning an incident at Del Mar. In performing her duties as Racing Veterinarian, Dr. Bailey had recommended the scratch of an entry of Mr. Millers'. After the race the trainer confronted Dr. Bailey in a boisterous manner. At the hearing both parties were afforded the opportunity to explain their sides of the incident. Trainer Miller admitted he had lost his composure as he was upset at the scratch of his horse. Decision to be reached by tomorrow.

The tenth race on the card for Cal-Bred maidens, three years old and upward, claiming price \$25,000 at six furlongs, was contested with a full field.

09/08/08⁴**RULING #3 (ref 09/07/08⁵)****LAFP #03**

Trainer PETER MILLER is fined the sum of THREE HUNDRED DOLLARS (\$300.00)* for violation of California Horse Racing Board rule #1874 (Disorderly Conduct – disrespect to a Racing Official) on Friday, August 22, 2008.

This ruling was agreed upon after a days' deliberation. The facts of the case clearly indicate Mr. Miller was out of line. That Mr. Miller confronted Dr. Bailey in a public place, the saddling paddock, was given consideration in arriving at a penalty.

09/08/08⁵**RULING #4****LAFP #04**

Owner ROBERT HENIE (dba Palm West Stable), having failed to abide by the terms of a signed financial agreement with trainer Monty Meier, is suspended for violation of California Horse Racing Board rule #1876 (Financial Responsibility).

This ruling was issued after subject failed to pay his first installment of \$2,500.00 on this agreed debt.

09/08/08⁶**JOCKEY OBJECTION – NO CHANGE**

After the finish of the first race (About 4 furlongs) the Stewards posted the jockey objection at the request of rider Agapito Delgadillo, aboard the second place finisher #1 Stormin Hal. Delgadillo alleged interference nearing the finish by the winner #9 Catalina Fog (jockey Alonso Quinonez). After talking with the riders involved, receiving the Patrol Judge's reports and reviewing the replays, the Stewards unanimously agreed that no change in the order of finish was warranted. Replays show #9 lug in nearing the wire, making light contact with #1; however, the incident did not cost #1 a better placing.

09/08/08⁷**STEWARDS' INQUIRY / ACCIDENT – NO CHANGE**

The Stewards posted the inquiry sign after the finish of the third race to review an accident which took place shortly after the start. Involved was #4 Perfect Runner, who unseated jockey Joy Scott. Replays show #4 veer in and bump with #3 Convercent (jockey Luis Contreras), causing jockey Scott to lose her balance and fall off. Since most of the blame for the incident was on #4, no change in the order of finish was made.

The eighth race on the program for Cal-Bred maidens, two years old; claiming price \$32,000 had nine entries contesting six furlongs.

09/10/08⁴**RULING #5****LAFP #05**

Trainer SANFORD SHULMAN, who worked the horse "Ammarie" at Del Mar Race Course on August 18, 2008, to be removed from Vet's list, is fined FIVE HUNDRED DOLLARS (\$500.00)* pursuant to California Horse Racing Board rule #1866 (Veterinarian's List) for violation of California Horse Racing Board rule #1844 (c) & (1) (Medication, Drugs, and Other Substances – Phenylbutazone in excess of permitted level).

This ruling was agreed upon after conferring with trainer Shulman telephonically. Mr. Shulman stated his groom accidentally fed the horse two bute pills the night before the work. The scenario is believable but does not relieve the trainer of the responsibility.

09/10/08⁵**JOCKEY OBJECTION – NO CHANGE**

After the finish of the ninth race (Six furlongs) the Stewards posted the jockey objection at the request of jockey Joy Scott, aboard the second place finisher #7 Speaking. The rider alleged interference by the winner #2 Jaguk and apprentice jockey Pedro Arambula nearing the finish. After speaking with the riders involved, receiving the Patrol Judges reports and reviewing the replays, the Stewards unanimously agreed to dismiss the claim of foul. Replays show #2 drift out up the stretch, but well clear of the field at the time.

09/10/08⁶**STEWARDS' INQUIRY - NO CHANGE**

Following the finish of the tenth race (6 ½ furlongs) the Stewards posted the inquiry sign to review an accident at the start. Replays verify #5 Rare Krista stumbled leaving the gate unseating jockey Agapito Delgadillo. No other horses were involved and the rider appeared okay.

Two scratches and two rider changes for Friday's program were completed at 10:00 a.m.

09/11/08²**THE DRAW**

Thirteen races were drawn for the Sunday program. One Quarter Horse dash accompanies twelve thoroughbred races for the full card.

09/11/08³**CAL-BRED REPORT**

The eighth race on the card, for Cal-Bred maidens, fillies two years old, claiming price \$32,000 going six furlongs, had a full field.

09/11/08⁴**RULING #6****LAFP #06**

Trainer GARY SHERLOCK is fined THREE HUNDRED DOLLARS (\$300.00)* pursuant to California Horse Racing Board rule #1629 (Penalty for Late Declaration), for violation of California Horse Racing Board rule #1845(Authorized Bleeder Medication), necessitating the late declaration of WARREN'S ADVENTURE from the fifth race on September 10, 2008.

This ruling was issued because the van picking up the trainer's horse yesterday originally failed to do so. When the error was discovered by the van driver, he returned and retrieved the horse, but ultimately arrived at Fairplex Park too late for lasix. Trainer Sherlock was contacted at Keeneland and accepted responsibility for the unfortunate incident.

09/11/08⁵**CASE DISMISSED**

Jockey Brice Blanc appeared to address an alleged whip violation. A horse that he had ridden was claimed, and the next day the new trainer observed several marks on her belly which seemingly were made by a whip. Jockey Blanc testified that he uses the new whip with a cushioned popper. The Stewards reviewed replays of the race in which Blanc whips the filly four times left handed. Nothing abusive or unusual was noted. In view of the fact of the time delay and the inconclusiveness of the situation, the Stewards opted to dismiss the case in the interest of fairness.

09/11/08⁶**FITNESS FOR LICENSE – RULING #7****LAFP #07**

Exercise rider ERIK ALAN KRUG, having participated in a fitness for license hearing as required by Hollywood Park Racing Association Ruling #4 issued on November 10, 2007, is hereby reinstated. Conditions of reinstatement are that Mr. Krug is required to abide by the terms of a drug testing agreement with the California Horse Racing Board and must comply with the guidelines of the contract set forth by the Winner's Foundation. Furthermore, Mr. Krug's license will be considered probationary for its term.

Exercise rider Erik Krug appeared for an informal fitness for license hearing. Respondent was accompanied by Winner's Foundation Representative Bob Fletcher. Mr. Krug presented documentation as required by Hollywood Park's ruling which was acceptable to the Stewards. Mr. Fletcher testified that Mr. Krug was a model participant in the Winner's Foundation program. Subject testified that his drug and disorderly problems were behind him.

09/11/08⁷**STEWARDS' INQUIRY -DISQUALIFICATION**

After the finish of the fourth race (Six furlongs) the Stewards posted the inquiry sign to review an incident in the middle of the backstretch. Involved were the third place finisher #1 Love Happens (jockey Clinton Potts) and the fifth(last) place horse #2 Song of Illinois (jockey Martin Garcia). The Stewards unanimously agreed to disqualify #1 from third position and place her last for interference approaching the five-sixteenths pole, after discussion with the two riders, review of the Patrol Judges reports and replaying the race tapes. The replays show #1 shift out from the rail, and cross in front of #2, causing the latter to clip heels, stumble and lose all chance at a better placing. Jockey Martin Garcia stated he was pitched forward so hard when he clipped heels that the wind was knocked out of him and he was unable to ride his horse.

09/11/08⁸**TRAINER OBJECTION – NO CHANGE**

At the request of trainer Jerry Wallace, the Stewards posted the objection sign after the finish of the tenth race. Trainer Wallace alleged interference by the winner #5 Gotham Glory (jockey Luis Contreras) against his entrant #3 Blackestofbeauties (jockey Agapito Delgadillo) in the stretch. After receiving the Patrol Judges' reports, talking with the riders involved and reviewing the replays, the Stewards unanimously agreed to dismiss the claim of foul.
