FILM REVIEW

Jockey JORGE CARRENO came to the office this morning to review his ride in the eighth race on Sunday. He was due yesterday but claimed he didn't know he was on the board. Films revealed that Mr. CARRENO angled his mount in without sufficient clearance down the backstretch and, in fact, caused a rival to clip heels. After some discussion, Mr. CARRENO accepted responsibility and the following was issued:

LAFP #004

Jockey JORGE CARRENO, who rode PEARL DADDY in the eighth race at Fairplex Park Race Track on Sunday, September 16, 2012, is suspended THREE (3) racing days (September 30, October 4 and 5, 2012) for altering course without sufficient clearance down the backstretch and causing interference; a violation of California Horse Racing Board rule #1699 (Riding Rules – careless riding).

The term of this suspension shall not prohibit participation in designated races in California.

9/20/12²**STUTE AND OVIEDO WARNINGS**

Trainers GARY STUTE (case number 12PM005) and PHIL OVIEDO (case number 12PM004) were both warned for being late to the receiving barn with their respective runners. This was each of their first offenses within the last year.

FRIDAY9/21/12¹**FILM REVIEW**

Jockey JORGE CARRENO came to the office to review his ride in the third race yesterday. It was our feeling that Mr. CARRENO eased his horse before the wire and may have cost him third position (for which he was beaten a nose). Mr. CARRENO initially said that he didn't think his mount was going to finish anywhere and therefore stopped riding, but the story then changed to the excuse that the horse didn't feel very sound. While the horse did appear to change leads a little roughly, Mr. CARRENO hit the horse with his whip three more times before standing up, which negated his argument that the horse didn't feel sound. Appearing frustrated that we were not buying his argument, he simply asked what the fine would be. Mr. CARRENO was told the amount; he was surprised and given the following ruling:

LAFP #005

Jockey JORGE CARRENO is fined THREE HUNDRED DOLLARS (\$300.00) for violation of California Horse Racing Board rule #1692 (Requirements for Horse, Trainer and Jockey – failure to ride his mount out until the finish line is passed) while aboard ELIZABETH A in the third race at Fairplex Park on September 20, 2012.

Jockey KEVIN KRIGGER came to the office to review his ride in the seventh race on Wednesday in which he bumped a rival as the field straightened out for its run down the backstretch. He was candid and said that the move was an error but that his horse was a little erratic. He received a warning.

9/21/12²**BAZE HEARING**

We held an informal hearing this morning into a complaint (case number 12PM001) filed by owner EUGENE ADAMS against blacksmith KYLE BAZE. The original dispute (about ten years ago) stemmed from an unpaid shoeing bill. After a couple of civil suits, two payments and the involvement of the Stewards and an unscrupulous collection agency, Mr. ADAMS obtained a judgment against Mr. BAZE and filed the instant complaint. Unfortunately, Mr. ADAMS was not willing to accept an amount close to the full amount or a payment plan for the full payment. The case was therefore dismissed.

9/21/12³**AGUIRRE HEARING**

We held an informal hearing into a complaint (case number 12DM048) filed by ownKAREN MICKETT against trainer PAUL AGUIRRE alleging that Mr. AGUIRRE was training a horse of which they owned 30% but could never procure a bill of sale. It turns out that bloodstock agent DANNY ALAMEDA (currently suspended) sold them 30% of a horse but has never

produced a bill of sale and the horse hasn't really done much since. Mr. AGUIRRE is the trainer. Clearly there are issues about which we are not aware, but will make a decision shortly.

9/21/12⁴**LATE SCRATCH**

As the field entered the track for the eleventh race, #2 DEMOCRACY unseated his rider, JORGE CARRENO, who was unable to ride. The horse was scratched when there was no one to replace CARRENO. See attached accident report.

SATURDAY9/22/12¹**FILM REVIEW**

Jockey AGAPITO DELGADILLO came to the office as directed to review his ride in the fourth race yesterday. As the field entered the turn of the four furlong race, Mr. DELGADILLO drove up on the inside of a rival and then his horse starting getting out. He then made pretty hard contact with that rival who was also drifting in. He received a warning.

Jockey RICARDO JAIME came to the office as well to discuss the incident described above. Although films indicated that he was somewhat less culpable, he was cautioned to stay on his path, especially on these shorter races when the field is entering the turn.

9/22/12²**INQUIRY/DISQUALIFICATION**

Following the running of the fourth race, we posted the Inquiry sign to examine an incident in which the eventual winner #5 SMOKIN MOTION, ridden by JOEL CRUZ, drifts in causing three horses to steady including eventual second place finisher #4 BEV'S EX (jockey RAMON GUCE) who steadied sharply, and then recovered to be beaten a half of a length. After speaking with the patrol judges and riders involved, it was our unanimous decision to disqualify the winner and place him second.

Jockey MATT GARCIA came to the office to review his ride in the twelfth race yesterday in which he was involved in two incidents that we thought were worthy of review. In the first, going into the turn, he angled his mount in causing a rival to steady and in the second, he allowed his mount to drift in and caused a rival to steady. The majority believed that a warning was in order while Steward SAWYER voted for three suspension days.

Jockey JOEL CRUZ did not come to the office this morning as directed. His mount was disqualified in yesterday's fourth race. Films revealed that his mount drifted inward during the run down the backstretch and interfered with three horses. Mr. CRUZ also allowed a slight drift in the stretch. He was therefore issued the following ruling:

LAFP #006

Jockey JOEL CRUZ is suspended THREE (3) RACING DAYS (September 29, 30, and October 4, 2012) for crossing over without sufficient clearance

Mr. Carreno wasn't able to ride his mount and the horse had to be scratched. The rider was examined by the track physician and released to ride the next day.
