**FERNANDEZ RULING**

We issued the following ruling when Valet PABLO FERNANDEZ failed to appear for his hearing yesterday regarding case number 18DM0033:

LAFL #009

Pursuant to California Horse Racing Board #1900(Grounds for Suspension or Revocation) Valet Pablo Fernandez, having failed to appear to respond to charges alleging violation of California Horse Racing Board rule #1489(8) (Engaged in the use of Drugs – marijuana), is suspended for violation of California Horse Racing Board rule #1547 (Failure to Appear).

During the term of suspension, all licenses and license privileges of Pablo Fernandez are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards to Suspend or Fine), Mr. Fernandez is denied access to all premises in this jurisdiction.

**STEWARDS' REVIEW**

Ceballos) of #2 RUNNINGWSCISSORS to ride the race with his feet out of the stirrup irons. Film revealed that shortly after the start, the right stirrup either broke or unbuckled, leading to the situation. No inquiry was necessary.
