Wednesday

06-24-09¹ **SAD NEWS** (Refer 06-21-09⁴)

Assistant Starter **DAVID FOWLER-WRIGHT** passed away from injuries suffered in an accident following Sunday's seventh race start. The 47 year old had been working as an assistant starter/rakeman for at least four years according to starter Robert Mooneyhan. The entire matter is being investigated by OSHA, CFSA and CHRB investigators. All horsemen are deeply saddened by David's loss.

06-24-09² **SAFETY MEETING**

A safety meeting was conducted today for all racing department heads. Fair Manager Debbie Cook, CARF's Larry Swartzlander and CFSA (California Fair Services Authority) representatives Tom Allen, Thomas Amberson and Omar DeGuzman all spoke at the meeting. Although the meeting was obviously a reactionary move, the areas discussed should be helpful in prevention of future accidents.

06-24-09³ **NO SHOW WAGERING – Fourth Race**

#5 OLYMPIC FORCE flipped in the post parade injuring its hip. #4 was scratched which reduced the field to four betting interests. Show wagering was cancelled in accordance with CHRB rule 1954 (Pari-mutuel Pools).

06-24-09⁴ **INQUIRY / NO CHANGE – Seventh Race**

9 to 5 favorite, #9 KENYA SKYE, stumbled at the start unseating jockey David Lopez. After review it was determined the gate opened properly and no change was warranted. #9 was reported to have a broken left hind leg.

#6 MADRIGALS MAGIC bolted shortly after the start of this five furlong Arabian race unseating jockey Jorge Herrera. No other horses were involved. Jockey Herrera was transported to St. Joseph's with what appeared to be minor injuries. No change.

06-25-09² **INQUIRY – Seventh Race – DISQUALIFICATION**

The stewards posted the inquiry sign to review an incident near the ¼ pole. #2 SWEET SWEET TAYLOR (Jorge Ayarza) (4th) stumbled in the path of seventh place finisher, #3 OLD FLING (Juan Ochoa) causing jockey Ochoa to check sharply. In the unanimous opinion of the stewards, #3 was cost any chance at a better placing. #2 was disqualified from fourth and placed seventh for the interference.

 The stewards met with outrider **Mike Waite** and license technician **Daniel Smith** in an attempt to clarify the new guidelines concerning provisional exercise rider licenses. As with any new implementation certain logistical and clerical issues arise and, hopefully, we solved a few issues. In and aside, Investigator Charles Smith arrived from Sacramento with the bright yellow provisional exercise rider vests which will help outriders identify the rookies.

06-26-09² **LATE DECLARATION – Fifth Race**
 State Veterinarian Don Dooley called to report that #2 DOLCETTA acted up while blood was being drawn for pre-race TCO₂ testing and the needle broke off in the horse. Trainer Donna Elordi was contacted and the horse was scratched on Dooley's recommendation. X-rays and surgery to remove the needle are on the horizon. More to come.

06-27-09¹ **MEMORIAL (Refer: 6-24-09¹)**
 A memorial service was held last evening for **David Fowler-Wright** following the races. The event was attended by co-workers, officials and management. Close friends noted in their eulogies what a nice hardworking person David was and how greatly he will be missed.

06-27-09² **ARAC 'REP' MEETING**
 Representatives of the **Arabian Racing Association of California** (ARAC) met with the stewards and racing secretary **Tom Doutrich** to discuss possibly moving a filly and mare stake from July 18 to July 5th. The race has been published in Pleasanton's

condition book to be run July 18 with nominations closing July 11th. The request to move is based on generating more handle on the 4th of July weekend. A disclaimer on the back of the nomination blank allows the association to move or cancel the race without liability. However, it is the opinion of the stewards that this disclaimer is used for the protection of the association and traditionally utilized for bad weather or lack of nominations. Moving a race to a later date has been done many times in the past but this is the first request to move a race forward to our knowledge. If the request was granted the race would actually be run before the original nomination closing date of July 11th. The potential for litigation and confusion seems ripe under these circumstances and the stewards recommended no change. Racing Secretary Tom Doutrich agreed after consultation to try and compromise and accommodate ARAC by putting an extra race on for the fillies and mares on the 4th of July weekend, allowing the possibility of racing back on the 18th in the stake. Problem resolved?

- 06-27-09³ **ACCIDENT (Mules) – Second Race**
 Following the running of this 350 yard mule race, #4 BAR JF WINNING TICKET propped while pulling up unseating jockey **Javier Gomez**. Gomez was transported to San Joaquin General with unknown injuries. An accident report will be generated by this office and attached to the minutes.
- 06-27-09⁴ **INQUIRY (Quarter Horse) – NO CHANGE – Third Race**
 The stewards posted the inquiry to review the start of this maiden race. #'s 2, 3, 4 and 5, broke in a tangle. After review it was determined #4 CORONA FLY (**Sergio Ruiz**) was the main culprit and finished behind the other rivals. No Change. Jockey Ruiz was ordered to see the stewards.
- 06-27-09⁵ **INQUIRY/OBJECTION – NO CHANGE – Seventh Race**
 The stewards posted the inquiry to review an incident near the 3/8 mile pole possibly involving #10 GIOVANNI (NZ) (1st, Michael Martinez), #8 APOLLO COMMANDER (9th, Pablo Flores) and #3 SILK CREEK (7th, Barrington Harvey). After review it was a unanimous decision to make no change. #8, who finished ninth, was deemed the culprit for coming down under right handed whipping, bumping #3 and forcing him over the heels of #2 SOLID SENSATION. Jockey **Pablo Flores** was ordered to the stewards.

06-28-09¹ **RULING NO. 5 – GODINEZ**

Trainer **JESSE RAY GODINEZ**, who was scheduled to start #8 JUST FAX BOB and #9 BOY SECRETS in the third race at the San Joaquin County Fair (Stockton) on Saturday, June 27, 2009, is fined the sum of two hundred dollars (\$200.00) for violations of California Horse Racing Board rule 1588(j) (Horse Ineligible to Start) for failure to have both horses on the grounds twenty-four (24) hours prior to race time.

The foregoing ruling was issued after Godinez appeared and accepted the penalty. Godinez is stabled at Los Alamitos and had to ship to Stockton. According to Godinez, he stopped at his home in Madera to rest and ship in to Stockton in the morning.

06-28-09² **RULING NO. 6 – TOROK**

Trainer **SANDY TOROK**, who was scheduled to start the horse BALLS TO THE WALL in the first race at the San Joaquin County Fair (Stockton) on June 27, 2009, is fined the sum of two hundred dollars (\$200.00) for violation of California Horse Racing Board rule #1629 (Penalty for Late Declaration – brought wrong horse to Receiving Barn).

The above ruling was issued after Torok appeared and admitted to mixing up two of her horses.

06-28-09³ **RULING NO. 7 – FLORES**

Apprentice Jockey **PABLO FLORES**, who rode **APOLLO COMMANDER** in the seventh race at San Joaquin County Fair on Saturday, June 27, 2009, is suspended five (5) racing days (July 5, 8, 9, 10 and 11, 2009) for bumping and impeding another horse on the backstretch; a violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules – careless riding).

The term of this suspension shall not prohibit participation in designated races in California.

The above ruling was issued after jockey representative Chris Russell appeared on Flores' behalf. Flores was given five days instead of the minimum three days for causing another rival to clip heels and almost fall.

06-28-09⁴ **INQUIRY – DISQUALIFICATION – Second Race**

The stewards posted the inquiry sign to review an incident in the stretch involving first and second place finishers, #8 **LA JEST A FLASH** (Juan Avila) and #7 OTIS (Barrington Harvey). After talking to the riders and reviewing the tapes, #8 was disqualified and placed second. Tapes clearly show that jockey Harvey was forced to steady mid-stretch. Closer to the wire #8 comes out and bumps #7.
