09-20-13³ **INQUIRY – DISQUALIFICATION – 1st RACE**
 The stewards posted the Inquiry sign following the first race for a review of an incident near the start of this three hundred (300) yard Quarter Horse event.

After interviewing the riders involved and reviewing the video, the stewards decided unanimously to disqualify #4 WORSHIPFUL (Martin Arriaga) from fifth to sixth for interfering with #3 BEGGIN FOR FISH (Luis Godoy).

The video shows #4 WORSHIPFUL broke in at the start, bumped and impeded #3 BEGGIN FOR FISH, then crossed over in front of that rival, preventing him from a better placing.

09-20-13⁴ **OBJECTION – NO CHANGE – 5th RACE**
 The stewards posted the Objection sign following the fifth race at the request of Jockey Alejandro Gomez (#1 BLAZING REFLECTION) third, who claimed foul against first place finisher #2 ANELINA (Juan Hernandez).

After interviewing the riders involved and reviewing the video, the stewards decided unanimously to make no change in the original order of finish.

The video failed to substantiate the claim of foul.

09-20-13⁵ **INQUIRY – DISQUALIFICATION – 6th RACE**
 The stewards conducted an inquiry following the sixth race to review an incident approaching the 1/16 pole involving #4 COME ON DEPUTY (Marcia Stortz) second and #1 O WILD WEST WIND (Juan Hernandez) third.

After interviewing the riders involved and reviewing the video, the stewards decided unanimously to disqualify #4 COME ON DEPUTY from second to third for interference.

The video shows #4 COME ON DEPUTY drifts out under left handed whipping, bumps and impedes #1 O WILD WEST WIND, who was beaten a head for second place.

09-21-13³ **FINANCIAL COMPLAINT (13SW0063)**

The financial complaint filed against owners Joy and John Gish by trainer Ruby Thomas was resolved by signed agreement that calls for a payment of one thousand dollars (\$1,000) by Sept. 27, 2013 and fifteen hundred dollars (\$1,500) by Oct. 24, 2013. In addition the Gish's will provide twenty-five hundred dollars (\$2,500) worth of hay.

09-21-13⁴ **FINANCIAL COMPLAINT (13SW0064)**

The financial complaint filed against owners Joy and John Gish by trainer Ariel Gordon for an alleged debt for training services totaling \$17,505.21, was dismissed, as Ms. Gordon failed to prove her case at hearing. CSR Christine Niccoli recorded the proceedings.

09-21-13⁵ **RULING NO. 1 – MARCIA STORTZ (REF: 9-20-2013⁵)**

The foregoing ruling was issued after Ms. Stortz and the stewards reviewed the video of the sixth race from Sept. 20, 2013. Ms. Stortz was very candid in acknowledging she erred by allowing her mount to drift out in the stretch and cause interference.

Jockey **MARCIA STORTZ** who rode **COME ON DEPUTY** in the sixth race at the San Joaquin County Fair on September 20, 2013 is hereby suspended three days (September 28, 29 & October 3, 2013) for failure to maintain a straight course in the stretch causing interference resulting in disqualification of her mount from second to third position. A violation of California Horse Racing Board rule #1699 (D) and (F) (Riding Rules – Careless Riding).

The term of this suspension shall not prohibit participation in designated races in California.

09-21-13⁶ **RULING NO. 2 – FAUSTINO GARDUNO**

The below ruling was issued after Mr. Garduno met with the stewards regarding his actions in the Receiving Barn prior to the seventh race on Sept. 20, 2013.

Horse Identifier Gary Greiner reported that Mr. Garduno was extremely uncooperative when Mr. Greiner was attempting to identify #6 SOCIETY GEM (Trainer Debbie Winick).

Mr. Greiner wanted to check the lip tattoo and Mr. Garduno, who is the co-owner and groom of the three-year-old filly took exception, declaring the filly had been identified for previous races without being lipped. After relenting to Mr. Greiner's request, Mr. Garduno was still abusive toward Mr. Greiner.

Owner **FAUSTINO GARDUNO** is hereby fined one hundred dollars (\$100)* for causing a disturbance in the Receiving Barn prior to the 7th race on September 20, 2013 at the San Joaquin County Fair, a violation of CHRB Rule 1874 (Disorderly Conduct).

09-21-13⁷ **FILM REVIEW**

Jockeys Ricardo Gonzalez and Martin Arriaga met with the stewards for a review of their rides in the first and ninth on Sept. 20, 2013.

Both riders made satisfactory efforts in controlling their mounts and were advised to do as well or better in the future.

09-21-13⁸ **HEAVY RAIN CANCELS RACING**

A strong storm swept through the area and while attempts were made by the track crew to maintain a safe racing surface, following the fourth race the riders voiced concerns about the track.

The stewards met with the jockeys and while they were conducting a vote on whether to continue, the human ambulance became mired in the mud on the track and couldn't move. The ambulance company, American Medical Response, was contacted and advised to provide either a four-wheel drive ambulance or put chains on the one they were using. Their supervisor, Mike Robinson, advised they had no four wheel or chains available.

The riders voted not to continue and with ambulance issues the remainder of today's program was cancelled.

Trainer **BRUCE TOWELL** is hereby fined the sum of one hundred dollars (\$100)* for abusive behavior toward another person in the barn area at the San Joaquin County Fair on September 20, 2013; a violation of California Horse Racing Board rule #1874 (Disorderly Conduct).

09-22-13⁴ **INQUIRY – NO CHANGE – 9th RACE**

The stewards posted the inquiry sign following the ninth race for a review of the start. After a thorough review, the stewards made the original order of finish official.

The video shows a ragged start for this ten horse field, with a number of horses making contact. The stewards determined that no one incident called for a disqualification.

09-22-13⁵ **REBATE**

The horsemen who had horses prepared to start in the five races that were cancelled on Saturday, Sept. 21, 2013, due to the heavy downpour that rendered the track unsafe, were awarded three hundred dollars (\$300) each, for expenses incurred.

09-28-13⁴**RULING NO. 4 – PATRICIA M. CURTIN (13GG090)**

The following ruling was issued as Ms. Curtin failed to appear for a hearing to address the complaint filed against her for positive marijuana (urine and blood) samples. She submitted on August 7, 2013.

Exercise Rider **PATRICIA M. CURTIN** having failed to respond to written notice to appear before the Board of Stewards at the San Joaquin County Fair (Stockton) on or before September 27, 2013 is hereby suspended for violation of California Horse Racing Board rule #1547 (Failure To Appear) pending an appearance at a hearing before the Board of Stewards to answer charges alleging violation of California Horse Racing Board rule #1874 (Disorderly Conduct) on August 7, 2013.

During the term of suspension, all licenses and license privileges of Patricia M. Curtin are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards), subject is denied access to all premises in this jurisdiction.

09-28-13⁵**RULING NO. 5 – JORGE L. ARZATE (13GG117)**

The following ruling was issued after Exercise Rider Jorge Arzate met with the stewards and agreed to an informal hearing to address the complaint filed against him for possession and use of marijuana in his tack room at Golden Gate Fields on Sept. 7, 2013.

Mr. Arzate was very contrite and fully understands the consequences of any further substance abuse issues.

Exercise Rider **JORGE L. ARZATE** is hereby fined the sum three hundred dollars (\$300)* and placed on a testing agreement with the California Horse Racing Board for violation of California Horse Racing Board rules #1874 (Disorderly Conduct) and #1890 (Possession of Contraband – Marijuana) on September 13, 2013.

Steward Paul Nicolo filled in for Will Meyers who was absent for medical reasons and we all wish him a speedy recovery.

09-28-13⁷**OBJECTION – NO CHANGE – 1st RACE**

The stewards conducted an inquiry following the first race at the request of Jockey Luis Godoy, who finished second on #4 BAR JF HOT TICKET. Mr. Godoy lodged a claim of foul against #5 BAR JF RED TICKET, alleging interference at the start.

After interviewing the riders involved and reviewing the video, the stewards decided unanimously to disallow the claim of foul and make the original order of finish official.

The video shows contact between the two mules at the start, but the incident did not warrant a disqualification.

09-28-13⁸**INQUIRY – NO CHANGE – 9th RACE**

The stewards posted the inquiry sign following the ninth race for a review of an incident in the stretch involving #5 KATIE (Juan Hernandez) third and #8 GIANIS (Alejandro Gomez) fourth.

After interviewing the riders involved, the patrol judges and reviewing the video, the stewards decided unanimously to make the original order of finish official.

The video shows #5 KATIE drift out slightly near the 1/16 pole and a tiring #8 GIANIS steadies briefly. The incident did not affect the outcome.

The video shows #2 FIRST REGAL CHOICE initiates contact with #3 SPARKIN ONE at the start. The three Quarter Horses do brush after the initial bump, but the second incident had no bearing on the outcome.

The stewards posted the inquiry sign following the fourth race for a review of an accident at the start.

After a thorough review the stewards decided unanimously to make the original order of finish official.

The video shows #3 HERE BE DRAGONS (Barrington Harvey) broke in the air from the gate and lunged over #2 BEST BY FAR (Juan Hernandez) causing both riders to hit the dirt. Both horses were considered starters.

Jockey Hernandez was excused from his remaining mounts.
