**HOLLENDORFER HEARING CASE #11SA045**

Dan Ward, assistant trainer for Jerry Hollendorfer, met with the Stewards to discuss a complaint filed by Official Veterinarian Jill Bailey against Mr. Hollendorfer. The offense involved CHRB rules 1852 (Reporting to Receiving Barn) and 1894 (Duties of Trainer). The horse in question was late to the receiving barn for the second race on Thursday, February 10. This was Mr. Hollendorfer's first offense of this nature and the Stewards issued him a warning.

**FILM REVIEW (ref. 02/12/11<sup>5</sup>)**

Jockey Daniel Sandoval met with the Stewards to discuss the inquiry in the last race yesterday. Mr. Sandoval admitted he drifted in after the start but thought he was clear. After watching all angles of the race he could see that the horse to his inside was still on his heels. He stated he would be more aware in the future and the following ruling was issued:

**LATS #055**

Jockey **DANIEL SANDOVAL**, who rode "Stray Cat" in the tenth race at Santa Anita Park on February 12, 2011, is suspended for FIVE (5) RACING DAYS (February 19, 20, 21, 24, and 25, 2011) for crossing over without sufficient clearance and causing interference which resulted in the disqualification of his mount from second to unplaced. This constitutes a violation of California Horse Racing Board rule #1699 (Riding Rules-Careless Riding).

Term of suspension shall not prohibit participation in designated races pursuant to California Horse Racing Board rule #1766 (Designated Races).

This ruling was issued after J.J. Eaton Racing licensed ownership failed to satisfy their debt to Rafael Becerra. Mr. James Eaton had conversations periodically with the Stewards since November 10, 2010 stating he would remedy the debt, but upon failing to do so he was made aware of this ruling.

**INQUIRY (7 Furlongs-Dirt) NO CHANGE**

Following the running of the eighth race the inquiry sign was posted to review an incident near the finish line. Involved were #1 Mythical Power (R. Bajarano 3<sup>rd</sup>), #2 Ventana (M. Garcia 4<sup>th</sup>), and #4 Captain Cherokee (J. Talamo 2<sup>nd</sup>). Approaching the finish of the race #4 continually drifted out into the path of #2 who had to take up for several strides. The jockey of # 1 Rafael Bajarano stated he had to quit riding as his available space became less. The jockey of #2 Martin Garcia stated he took up early because his horse had a long stride. There was no jockey objection. After a review of all angles of the race, conversation with the Patrol Judges and all jockeys involved it was the Stewards' vote to let the original order of finish stand. In the Stewards' opinion this shuffling did not deprive those involved the opportunity of a better placing.
