We felt Mr. Quinonez could have waited one more stride before dropping down, alleviating some pressure. He agreed and promised that he would make a better effort in the future.

**JOCKEY OBJECTION-NINTH RACE-NO CHANGE**

Jockey Hector Berrios lodged a jockey's claim of foul following the ninth race where he rode the second place finisher, #9 Jack O Lyn. He claimed foul against the winner, #2 Got Even (Garrett Gomez). Mr. Berrios asked the Stewards to review an incident down the lane, where both horses came together in the final 1/8<sup>th</sup>. After reviewing the films talking to the patrol judges and both jockeys involved, we felt that both horses contributed to the incident and therefore no change was made to the original order of finish.

Apprentice jockey JESIERE MEDINA came to the office this morning to request an apprentice extension due to a medical excuse. She has already obtained an extension from the New York Board of Stewards where the injury had taken place, but there appeared to be a mathematical error in the extension. We therefore corrected the error and issued our own extension so that there is no confusion as to when her apprenticeship is to end:

Apprentice jockey **JESIÈRE MEDINA**, having provided evidence of an apprentice extension from New York granting her 407 days, is granted an extension in California until January 4, 2012, or until her 40<sup>th</sup> winner, whichever comes first.

**CALNAN COMPLAINT**

The complaint against owner **PETER CALNAN** (case number 11HP058) filed by Golden Eagle Farm was dismissed when the two parties reached and signed a financial agreement.

**THOMAS WARNING**

Trainer RAY THOMAS was given a warning pursuant to case number 11PM009 which was a complaint filed by the CHRB alleging that Mr. Thomas' employee had appeared in the receiving barn to run a horse without a license (which had expired).

**MITCHELL COMPLAINT DISMISSED**

The complaint against JAY and ESTER MITCHELL (case number 11DM009) filed by Loveacres Ranch alleging an unpaid farm bill was dismissed. The complaint was based on a court judgment against Jay Mitchell, but he is not licensed in California. However, given that his wife is licensed and they appear to owe the farm something, an agreement is being contemplated.

**INQUIRY/NO CHANGE**

Following the running of the eighth race, we posted the inquiry sign to examine an incident at the start in which jockey Rafael Bejarano, aboard #1 Summers At Delmar, was unseated shortly after the gates opened. Films revealed that the horse stumbled leaving the gate, Mr. Bejarano lost his balance and fell to the track, therefore no change was appropriate. Mr. Bejarano actually landed on his feet, was transported by ambulance and cleared to ride, while the horse was also uninjured. See attached accident report.

**OBJECTION/NO CHANGE**

Following the running of the ninth race (Oak Tree Derby), jockey Rafael Bejarano aboard fourth place finisher #13 Midnight Interlude, claimed foul against the second place finisher #3 Venomous (GB) for interference nearing the wire. Films revealed that #3 Venomous does come out and bump his rival, but that it occurred so close to the wire that #13 Midnight Interlude was not cost the opportunity at a better placing. Therefore, after speaking with the patrol judges and riders involved, we unanimously voted to make no change to the original order of finish.
