**FILM REVIEW**

While the films are not ultimately conclusive, we admonished him that, in our opinion, this constituted careless riding and had the film evidence been stronger, would result in days. He was issued a warning.

**FILM REVIEW**

Jockey JOE TALAMO came to the office to review his ride in the fourth race on Sunday in which he allowed his mount to drift in a bit during the stretch run. He was cautioned to keep a straighter course in the future.

Jockey KAYLA STRA came to the office to review her ride in the seventh race Sunday in which she dropped in a bit going into the first turn. Although she correctly pointed out that her rival was running up into a precarious position, we pointed out that she played a part in the traffic jam.

Apprentice jockey ESWAN FLORES came to the office to review his ride in the ninth race on Sunday, in which he shifted out abruptly at the quarter pole, making hard contact with a rival in the process. He recognized his mistake and accepted the following penalty:

**PRTS #035**

Apprentice jockey ESWAN FLORES is suspended for THREE (3) racing days (November 13, 17, and 18, 2011) for altering course without sufficient clearance near the quarter pole and causing interference aboard “Peppy Bolly” in the ninth race at Santa Anita Park on October 30, 2011. This constitutes a violation of California Horse Racing Board rule #1699 (Riding Rules – careless riding).

Term of the suspension shall not prohibit participation in designated races pursuant to California Horse Racing Board rule #1766 (Designated Races).

**O’NEILL HEARING**

Jockey CHRISTIAN SANTIAGO REYES came to the office this morning to review his ride in the fifth race yesterday in which he drops over toward the inner rail leaving the gate without sufficient clearance, causing a chain reaction involving five horses. He was issued a suspension in the following ruling:

**PRTS #039**

Jockey **CHRISTIAN SANTIAGO REYES**, is suspended for FIVE (5) RACING DAYS (November 11, 12, 13, 17, and 18, 2011) for altering course without sufficient clearance shortly after the start and causing interference aboard "Hy Point Player" in the fifth race at Santa Anita Park on November 4, 2011. This constitutes a violation of California Horse Racing Board rule #1699 (Riding Rules-Careless Riding). Term of suspension shall not prohibit participation in designated races pursuant to California Horse Racing Board rule #1766 (Designated Races).
