FILM REVIEW

ABEL LEZCANO came to the office to review two races from Sunday's card. In the first race, we felt that (and video confirmed) that he pushed his way out in order to create running room, allowing him to eventually win the race. Unfortunately, he forced two horses off of their paths. While he and his agent made some arguments and provided some explanation, ultimately they realized the error. In the sixth race, we wanted to warn Mr. Lezcano about his tendency to try to hold horses in during the backstretch run, in an effort to save ground. He explained that adjusting to California's less aggressive riding style (as compared to New York) has been challenging. After considering both races, we issued the following suspension based on his actions in the first race:

LATS #109

Jockey ABEL LEZCANO, who rode LADY CHAIRMAN in the first race at Santa Anita Race Track on April 3, 2016, is suspended for THREE (3) RACING DAYS (April 17, 21, and 22, 2016) for altering course without sufficient clearance and causing interference. This constitutes a violation of California Horse Racing Board rule #1699 (Riding Rules – careless riding). Pursuant to California Horse Racing Board rule #1766 (Designated Races), the term of suspension shall not prohibit participation in designated races.

Jockey FERNANDO PEREZ came to the office to be present when we spoke with Mr. Lezcano about the second incident. We found Mr. Perez blameless, but his presence promoted more honesty and openness in the discussion.

APPRENTICE APPLICANT

Apprentice Jockey ERICA MURRAY, who has about 24 wins in Louisiana, came to the office to introduce herself and request an apprentice license. We granted the license but requested a meeting before she is named to ride in a race. She is recovering from an injury and believed it would take about 30 days before being prepared to ride a race.

4/7/16³**BALTAS RULING**

We issued the following ruling when trainer RICHARD BALTAS found a better race in the newly published condition book:

LATS #108

Trainer RICHARD BALTAS is fined FOUR HUNDRED DOLLARS (\$400.00) pursuant to California Horse Racing Board rule #1629 (Penalty for Late Declaration – did not want to run on April 3, 2016).

4/7/16⁴**PURSE REDISTRIBUTION**

We held a formal hearing today (case number 16SA027) to consider the disqualification (and purse redistribution) of the horse RUN FOR RETTS who finished third in the eighth race at Los Alamitos on December 5, 2015. The horse tested positive for amphetamine and methamphetamine following the race. The disqualification was uncontested by the licensees involved, therefore we opened the record, entered the documents into evidence and closed the record. Ruling to follow.

4/7/16⁵**INQUIRY/NO CHANGE**

Following the running of the second race, we posted the Inquiry sign to examine an incident in the stretch in which second place finisher #4 I'M NO PATSY (C. Lindsay) drifted out in front of #5 MIDNIGHT LADY (J. Talamo) causing that horse to check briefly. After speaking with the patrol judges and jockeys involved, we unanimously voted to make no change to the original order of finish. While there was interference, we did not believe it cost the horse the opportunity at a better placing. In a separate incident apprentice jockey CHAD LINDSAY fell off his mount after the wire in what appeared to be a case of dizziness from dehydration. Accident report attached.

FILM REVIEW

Apprentice jockey CHAD LINDSAY came to the office to discuss the episode of dizziness yesterday. His doctors believed that he was simply dehydrated. He will have to be examined by the track physician before riding tomorrow.

Jockey MODESTO LINARES came to the office to review his ride in the sixth race yesterday during which we believe he violated the whip rule by striking his mount four times in succession without giving her a chance to respond. After seeing the video, Mr. Linares agreed and accepted the following ruling:

LATS #113

Jockey MODESTO LINARES is fined ONE HUNDRED DOLLARS (\$100.00) for violation of California Horse Racing Board rule #1688(b)(6) (Use of Riding Crop – than three times in succession without giving the horse a chance to respond – first offense in the last sixty days), during the sixth race at Santa Anita Race Track on April 7, 2016.

MEZA WITHDRAWAL

Veterinarian Dr. AMY SEIM withdrew her complaint (case number 16SA0071) against trainer FRANICS MEZA alleging unpaid veterinary services, when the debt was paid in full.

POLANCO HEARING

We held a formal hearing this morning into case number 16SA049 which was a complaint filed the CHRB against trainer MARCELO POLANCO alleging a phenylbutazone overage discovered in the post-race test sample of one of the runners in his care. Present at the hearing were the full Board of Stewards, Investigator JIM HAMILTON and Mr. Polanco, who represented himself. MICHELLE DERIEG recorded the hearing. While Mr. Polanco believed that this overage was happenstance, there was a bit more to this case. On the morning his horse ran, Official Veterinarian Dr. GRANDE contacted this Board and explained that he had a concern based on Mr. Polanco's veterinarians' confidential reports. That is, the two horses that Mr. Polanco had running that day may have been treated with phenylbutazone twice. We contacted Mr. Polanco and explained the situation, directed to him to do his own investigation and warned him that the horses would be drug tested if they ran. He was satisfied that the runners had been properly treated, they were tested and both came back with higher than average bute levels, and one of which was over the permitted level. Documents were entered into evidence, oral testimony heard and the matter was closed. Ruling to follow.

WALES RULING

After reviewing the 11th race from last Saturday (Arabian Stakes event), we contacted jockey TRAVIS WALES, who rode the winner about his whip use. He acknowledged that he was familiar with our whip rule and simply forgot, leading him to go far beyond the three strike limit. We considered this two offenses and issued the following ruling:

LATS #110

Jockey TRAVIS WALES is fined THREE HUNDRED DOLLARS (\$300.00) for two (2) violations of California Horse Racing Board rule #1688(b)(6) (Use of Riding Crop – more than three times in succession without giving the horse a chance to respond – first and second offenses in the last sixty days), during the eleventh race at Santa Anita Race Track on April 2, 2016.

4/8/16⁵**PURCELL RULING**

Our review of the Arabian race also led us to call second place finishing jockey KELSI PURCELL, to discuss her whip use. She acknowledged violating our whip rule and accepted the following ruling:

LATS #111

Jockey KELSI PURCELL is fined ONE HUNDRED DOLLARS (\$100.00) for violation of California Horse Racing Board rule #1688(b)(6) (Use of Riding Crop – more than three times in succession without giving the horse a chance to respond – first offense in the last sixty days), during the eleventh race at Santa Anita Race Track on April 2, 2016.

4/8/16⁶**MARCIAL RAMIREZ**

We issued the following ruling when jockey MARCIAL RAMIREZ failed to fulfill his riding assignment last Sunday. While we heard from the owner and trainer that his car may have broken down, we have yet to hear from Mr. Ramirez and therefore issued the following ruling:

LATS #112

Jockey MARCIAL RAMIREZ, who was scheduled to ride #6 BABY BOLLY in the second race on April 3, 2016 at Santa Anita Park is fined TWO HUNDRED DOLLARS (\$200.00) for violation of California Horse Racing Board rule #1872 (Failure to Fulfill Jockey Agreement).

4/8/16⁷**DISQUALIFICATION/PURSE REDISTRIBUTION**

Pursuant to the hearing referenced yesterday, we issued the following ruling:

LATS#114

Acting on a report from the University of California at Davis Maddy Laboratories, the official laboratory for the California Horse Racing Board, that the post-race urine sample #LA33553 taken from the horse RUN FOR RETTS, third place finisher in the eighth race at Los Alamitos Race Course on December 5, 2015, contained the prohibited substances Methamphetamine and Amphetamine (Class 1), it is hereby ordered that RUN FOR RETTS be disqualified from all purse monies earned and deemed unplaced in accordance with California Horse Racing Board rule #1859.5 (Disqualification Upon Positive Test Finding).

It is further ordered that all purse monies (\$12,000.00) earned or awarded to owner TOMMY TOWN THOROUGHBREDS (\$11,400.00) and jockey SANTIAGO GONZALEZ (\$530.00) be returned to the Paymaster of Purses on or before May 8, 2016 for redistribution pursuant to California Horse Racing Board rule #1760 (Purse Award or Prize to be Withheld).

The revised order of finish is as follows:

5th LUCKY TO WIN
6th ALL IN THE END.

All records are ordered changed to reflect this ruling. In accordance with California Horse Racing Board rule #1956 (Race Declared Official) neither pari-mutuel payoffs nor the distribution of any pari-mutuel pool shall be affected.

Trainer MARCELO POLANCO, who started the horse SMIL’N FROM ABOVE, fourth place finisher of the fourth race at Santa Anita Race Track on February 12, 2016, is fined TWO HUNDRED FIFTY DOLLARS (\$250.00) pursuant to California Horse Racing Board rule #1887 (Trainer to Insure Condition of Horse) for violation of California Horse Racing Board rule #1843(a) & (d) (Medication, Drugs and Other Substances – Phenylbutazone in excess of permitted level [2.85 ug/ml – Class 4]).

Apprentice jockey DAVID LOPEZ came to the office to review his ride in the second race yesterday during which he had a little trouble navigating the stretch run in the mud. He ran up on heels and overcorrected, interfering with a rival. Safety steward LUIS JAUREGUI gave him some tips on how to ride sloppy tracks.

Jockey ALONSO QUINONEZ came to the office to review his ride in the fifth race yesterday. We felt that he rode his horse into a space without sufficient room. He explained that he had room when he started into the space but that the hole closed as he got there. We agreed. Warning.

Jockey ABEL LEZCANO came to the office to review his ride in the second race yesterday. We felt that he was pushing his way out and floating a rival as the field was turning into the stretch. He agreed but claimed that his horse was getting out. We explained that this is fitting into a larger narrative of his aggressive riding style that does not meet our standard in California and will result in riding suspensions. Warning.

4/10/16²**CARDENAS RULINGS**

Jockey JESSE CARDENAS failed to appear for two days after being ordered to review video of the second race last Thursday. We therefore reviewed the video without him, and issued the following two rulings:

LATS #116

Jockey JESSE CARDENAS is fined FIFTY DOLLARS (\$50.00) for violation of California Horse Racing Board rule #1930 (Obedience to Security Officers and Public Safety Officers – failure to attend film review on April 8, 2016).

LATS #117

Jockey JESSE CARDENAS is fined ONE HUNDRED DOLLARS (\$100.00) for violation of California Horse Racing Board rule #1688(b)(6) (Use of Riding Crop – more than three times in succession without giving the horse a chance to respond – first offense in last 60 days), during the second race at Santa Anita Winter Meet on April 7, 2016.

4/10/16³**MALDONADO RULING**

We issued the following ruling after jockey EDWIN MALDONADO rode in two designated races in Kentucky yesterday while under suspension:

LATS #118

Jockey EDWIN MALDONADO is suspended for ONE (1) additional racing day (April 16, 2016) pursuant to California Horse Racing Board rule #1766(g)(h) (Designated Races – rode in designated races out-of-state while under suspension).

4/10/16⁴**BEJARANO RULING**

Jockey RAFAEL BEJARANO dropped his appeal of a riding suspension, we therefore issued the following ruling:

LATS #119

Jockey RAFAEL BEJARANO, having withdrawn his appeal of ruling LATS #047 issued at Santa Anita Winter Meet on February 11, 2016, is suspended for THREE (3) racing days (April 17, 21, and 22, 2016). All other terms of the original ruling shall remain in effect.

Pursuant to California Horse Racing Board rule #1766 (Designated Races) the term of suspension shall not prohibit participation in designated races.

4/10/16⁵**INQUIRY/DISQUALIFICATION**

Following the running of the third race, we posted the Inquiry sign to examine two incidents involving the third place finisher #5 TOO FAST TO PASS (A. Lezcano). The first occurred down the back stretch when Mr. LEZCANO angled his mount sharply to the inside rail causing fifth place finisher #3 STORY TO TELL (M. Pedroza) to steady and also making hard contact with #2 NO CONTINGENCY (S. Elliott), who finished last. We believed unanimously that neither horse was the cost the opportunity for a better placing. In the second incident, #5 TOO FAST TO PASS drifts inward in the home stretch causing fifth place finisher #3 STORY TO TELL to steady and in our unanimous opinion, lose the opportunity at a better placing. After speaking with the patrol judges and the riders involved, we disqualified #5 and placed him fifth.

Original order of finish: 7-1-(5)-4-3-6-2

Corrected order of finish: 7-1-4-3-(5)-6-2

4/10/16⁶**INQUIRY/OBJECTION/DISQUALIFICATION**

Following the running of the fifth race, we posted the Inquiry sign and there was a rider's claim of foul. The Objection lodged by the second place finisher #9 ANGELS JOURNEY, MARTIN PEDROZA, was quickly dismissed as we found no evidence of interference by the winner in the stretch run. However, our Inquiry also involved the winner and his actions on the backstretch. Video revealed that the winner #5 CANDY PROMISES shifted out from behind horses, crossed in front of #7 BLACK SONA to clip heels and unseat her rider, apprentice CHAD LINDSAY. After speaking with the patrol judges and riders involved, we voted unanimously to disqualify the winner and place him unplaced. The

horse was corralled and returned safely to his barn and Mr. Lindsay was examined by the track physician and cleared to ride. See attached accident report.

INQUIRY/DISQUALIFICATION

Following the running of the sixth race, we posted the Inquiry sign to examine an incident in the stretch involving the second and third place finishers. Video showed that the second place finisher #1 MR. OPPORTUNIST (J. Talamo) drifts out and makes contact with the third place finisher #3 HE'S A TIGER (A. Delgadillo). Given the close finish margin (less than a head), and after speaking with the patrol judges and riders involved, we voted unanimously to disqualify #1 and place him third.

POST-RACE ACCIDENT

Following the running of the eighth race, jockeys FERNANDO PEREZ and EDWIN MALDONADO were both unseated when their horses propped.
