**FILM REVIEW**

Jockeys MARTIN PEDROZA and RUBEN FUENTES were both in together to review Sunday's ninth race (turf) in which they both were involved in an inquiry. Mr. Pedroza's horse was lugging in when entering the stretch, making contact with Mr. Fuentes's horse who was lugging out late in the stretch. Both riders agreed they should have done better. We felt Mr. Pedroza made an effort to correct his horse, therefore, he wasn't penalized. Mr. Fuentes on a very close decision was issued a warning.

**FUENTES RULING**

Jockey RUBEN FUENTES was issued the following ruling after he accepted the penalty for violating the riding crop rule #1688. Mr. Fuentes violated the rule on Sunday, May 5, 2019, in the eighth race.

**LATS RULING #094**

Jockey RUBEN FUENTES, is fined ONE HUNDRED DOLLARS (\$100.00)\* for violation of California Horse Racing Board rule #1688(b)(6) (Use of Riding Crop – more than three times in succession without giving the horse a chance to respond – first offense in last 60 days), during the eighth race at Santa Anita Park on May 5, 2019.

**FRANCO RULING**

The following ruling was issued after Jockey GIOVANNI FRANCO accepted the penalty for violating the riding crop rule CHRB #1688 during Sunday’s eighth race on May 5, 2019.

**LATS RULING #095**

Jockey GEOVANNI FRANCO, is fined ONE HUNDRED DOLLARS (\$100.00)\* for violation of California Horse Racing Board rule #1688(b)(6) (Use of Riding Crop – more than three times in succession without giving the horse a chance to respond – first offense in last 60 days), during the eighth race at Santa Anita Park on May 5, 2019.

**CHEW RULING**

Trainer MATT CHEW was issued the following ruling when he elected not to run his horse “PIED N TRUE” in the today’s sixth race. Mr. Chew violated CHRB rule #1629 (Penalty for Late Declaration).

**LATS RULING #096**

Trainer MATTHEW CHEW, who was scheduled to start PIED N TRUE in the sixth race on May 10, 2019, at Santa Anita Park, is fined FOUR HUNDRED DOLLARS (\$400.00)\* for violation of California Horse Racing Board rule #1629 (Penalty for Late Declaration – trainer decision).

**ROSALES CASE (#19SA0089)**

Stable Foreman FLORIDALMA HERNADEZ ROSALES was suspended after failing to appear for a scheduled hearing filed by the CHRB for alleging rule violation of CHRB #1874 (Disorderly Conducted). The following ruling issued.

**LATS RULING # 097**

Stable Foreman FLORIDALMA HERNADEZ ROSALES, having failed to respond to charges alleging violations of California Horse Racing Board rule #1874 (Disorderly Conduct) on February 26, 2019, at San Luis Rey Downs is suspended for violation of California Horse Racing Board rule #1547 (Failure to Appear).

During the term of suspension, all licenses and license privileges of FLORIDALMA HERNADEZ ROSALES are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards to Suspend or Fine), FLORIDALMA HERNADEZ ROSALES is denied access to all premises in this jurisdiction.

**STEWARDS' INQUIRY/ DISQUALIFICATION (1<sup>ST</sup> RACE TURF)**

After the running of the first race we posted the inquiry sign to review an incident at the top of the stretch. The horses involved were the third place horse #1 "SPANISH CHANNEL" (J. C. Diaz Jr.) and the fifth place horse #3 "OUR ROMANCE" (D. Van Dyke). After speaking to the patrol judges and reviewing the video tape we unanimously voted to disqualify the third place horse #1, and place him behind the fifth place horse #3, for crossing over without sufficient clearance. We believed this cost the #3 an opportunity of a better placing.

**FILM REVIEW**

Apprentice Jockey J. C. DIAZ JR. and his Valet Ozzie Ayala were in the office to review yesterday's first race in which Mr. Diaz was disqualified from third to fifth place. Mr. Diaz crossed over into the path of another horse causing him steady, which cost him a better placing. The young rider stated that his horse switched leads, which caused him to angle in. We felt he could have made a better effort maintaining a straight course by grabbing the right rein; therefore, we issued the following ruling:

**LATS RULING #098**

Apprentice Jockey J.C. DIAZ, JR., who rode SPANISH CHANNEL in the first race at Santa Anita Park on May 11, 2019, is suspended for THREE (3) racing days (May 19, 24 and 25, 2019) for failure to maintain a straight course in the stretch and causing interference resulting in a disqualification from third to fifth position. This constitutes a violation of California Horse Racing Board rule #1699 (Riding Rule – careless riding). Pursuant to California Horse Racing Board rule #1766 (Designated Races), the term of suspension shall not prohibit participation in designated races.
