RULING #4 – ALEJANDRO GOMEZ

Ruling # 4

Jockey **Alejandro Gomez** who rode **Up Time** in the third race at Golden Gate Field on Friday, August 7, 2020 is suspended three (3) racing days August 15, 16 and 20, 2020 for failure to make a proper effort to maintain a straight course leaving the Starting Gate and causing interference resulting in the disqualification of his mount from sixth to eighth; a violation of California Horse Racing Board rule #1699 (c) & (e) (Riding Rules-Careless Riding).

The foregoing Ruling was issued after **Mr. Gomez** and the **Stewards** reviewed the video of the third race from Friday, August 7, 2020. **Mr. Gomez** acknowledged he was remiss in failing to control his mount leaving the Starting Gate.

RULING #5 – MARTIN ARRIAGA

Ruling # 5

Jockey **Martin Arriaga** is fined the sum of One Hundred dollars (\$100.00)*; for violation of California Horse Racing Board rule #1437 (Conditions of a Race Meeting) (Use of riding crop during morning training hours prohibited) at Golden Gate Fields on Saturday, August 8, 2020.

The above Ruling was issued after **Mr. Arriaga** met with the Stewards and admitted using his riding crop on his mount during a workout this morning. **Mr. Arriaga** had been warned previously by the morning **Outriders**.

CLAIM VOIDED – 3RD RACE

The Stewards voided the claim submitted by Trainer **Gary Greiner** for the mare **Crimson Cloud** (Tr. **Robert Hansen**) after the State Veterinarian **Forrest Franklin, DVM** reported she was lame in in the left foreleg. **Crimson Cloud** was returned to the barn of **Roger Hansen**.

INQUIRY – NO CHANGE – 4TH RACE

The Stewards posted the Inquiry Sign following the fourth race for a review of an incident in the first turn of the one-mile turf event. The video shows #1 **Diametric (David C. Lopez)** drift out slightly and appear to clip the heels of #2 **With Open Eyes (Kyle Frey)** bobble and dislodge Jockey **Lopez**. **Mr. Lopez** fortunately stayed on after coming out of both irons and was able to pull his mount up.

CLAIM VOIDED

The Stewards voided the claim submitted by Trainer **Guillermo Preciado** for the gelding **Elevate** (Tr. **Steve Sherman**) upon the recommendation of the State Veterinarian **Forrest Franklin, DVM**, who reported the five-year-old was lame in the left foreleg. **Elevate** was returned to the **Sherman** barn.

RULING #6 – William Delia

Ruling # 6

Trainer **William Delia** is fined the sum of One Hundred dollars (\$100.00)* for presenting the horse **Reign On (GB)** to the Receiving Barn for the seventh race on Saturday, August 8, 2020 improperly shod; a violation of California Horse Racing Board rule #1555 (Duties of Horseshoe Inspector).

The above Ruling was issued after **Mr. Delia** met with the Stewards and accepted responsibility for his gelding **Reign On (GB)** arriving at the receiving barn with no hind shoes. **Mr. Delia** explained he had instructed his shoer to remove the hind shoes on a number of horses in his barn, however **Reign On (GB)** was not intended to be one of them.

CLAIM VOIDED – 9TH RACE

The Stewards voided the claim submitted by Trainer **Isidro Tamayo** for **Full Of Pepper** (Tr. **Holly Evans**) after the Official Veterinarian, **Forrest Franklin, DVM** reported the four-year-old filly was lame in the left foreleg. **Full Of Pepper** was returned to **Ms. Evans** barn.
