## FOURTEENTH BIENNIAL REPORT

TO THE GOVERNOR AND THE LEGISLATURE  
OF THE STATE OF CALIFORNIA

(For the Period July 1, 1958 to June 30, 1960)

To EDMUND G. BROWN, *Governor,*  
and to the *Members of the Legislature:*

The California Horse Racing Board herewith presents its biennial report covering the period July 1, 1958, through June 30, 1960, pursuant to the provisions of Section 19432 of the Business and Professions Code of the State of California. This report will be the fourteenth biennial report which has been made by the Racing Board since horse racing has been legalized in California.

There has been a tremendous development and expansion of the horse racing sport in this State. This development has involved an increase in all phases of horse racing.

In order to bring into focus this tremendous development it is only necessary to state that there are 19 associations in the State conducting racing with pari mutuel wagering, and included among which are major racing associations, state, county, and district fairs, and organizations specializing in the harness and quarter horse fields, and that in no other state in the Union are the three types of racing conducted under the jurisdiction of the same board.

### HISTORY AND ACTIVITIES


The State of California legalized pari mutuel racing in 1933. Chapter 769, Statutes of 1933 created a three member board to prescribe rules and regulations for conducting horse racing and pari mutuel wagering in California. These rules and regulations are published by the Board, the latest revision being effective May 10, 1960.

Chapter 953, Statutes of 1955, added provisions relative to conducting charity days racing to the horse racing law. The Board requires licensees to submit annual reports of racing revenues and expenses showing breakdowns between track and charity. These reports are field audited by the Audits Division of the Department of Finance under contract with the Board.

Revenues from pari mutuel wagering are deposited in the Fair and Exposition Fund, the General Fund, and the Wildlife Restoration Fund, the latter fund receiving \$750,000 each year. Fees from occupational licenses granted under the horse racing law are deposited in the Fair and Exposition Fund.

After direct appropriations to the Horse Racing Board, the Department of Finance, the State Fair, Los Angeles County Fair, and certain agricultural associations, 45 percent of the balance of the Fair and Exposition Fund is allocated to the other district and county fairs. The remaining 55 percent of the balance is allocated as follows:

To the California State Polytechnic College.....	25 percent
To the University of California .....	33 percent
To a reserve for capital outlay for fair purposes.....	42 percent

Legislation enacted by the 1959 Legislature resulted in increased license fees and revision of the distribution. Limits were established on the total amount made available for the various fairs and for reserve purposes. The balance remaining in the fund at the end of each month, after providing for the various appropriations and allocations, is to be transferred to the General Fund.

## HORSE RACING REVENUES

The State's revenues from horseracing are derived from license fees based on a percentage of the pari mutuel pool wagers at each race track, breakage of winning ticket amounts to the nearest 10 cents of each dollar, and escheated unclaimed pari mutuel tickets. There is also a small amount of revenue from occupational licenses issued to owners, trainers, jockeys, and others.

During the period covered by this report, the proceeds from pari mutuel fees in excess of 4 percent of the "handle" for each racing meet, were deposited in the General Fund. The proceeds from "breakage" were deposited in the State College Fund until June 29, 1959, the effective date of legislation providing for their deposit in the General Fund. All other revenues were deposited in the Fair and Exposition Fund.

The California Horse Racing Board was responsible for collecting \$28,086,568 and \$36,117,012 in state revenues for the 1958-1959 and 1959-1960 fiscal years, respectively. This record revenue representing an increase of 28 percent over the 1958-59 fiscal year was achieved due to legislation enacted effective June 29, 1959. The net effect legislation was to increase the State's graduated percentage share of pari mutuel pools depending on the amount of gross handle and the State's share of breakage. Previously, the State did not share in breakage until a pool amounted to \$27,000,000. Now, the State shares equally in breakage until a pool reaches \$24,000,000; then all subsequent breakage is paid to the State.

## OPERATIONS

A staff of 16 permanent employees, headed by the board's chairman and two members appointed by the Governor for four-year terms, performs the functioning of this board in carrying out its mandate to regulate, license and supervise generally the conduct of racing in this State. The administrative staff consists of the secretary of the board and four employees, the investigation six, and the licensing five. Inter-mittent and seasonal help is employed in the administrative and licensing departments.

During the period covering this report, Arthur L. Martin of the Attorney General's office, rendered legal services to the board.

## LEGISLATION

### RECOMMENDATIONS

#### 1. State Stewards

In order for the Racing Board to keep abreast with the growth, development and advancement of racing, it is necessary that it be in a position to carry out all activities pertinent to its duty to see to it that all race meetings are conducted in a manner commensurate with the best interest of racing and in the public interest. In this connection, it is imperative that the Racing Board have sufficient funds with which to pay the necessary state stewards. Historically, the actual conduct of the races is under the supervision of the stewards. These men are trained and experienced in all phases relating to the running of races. It is incongruous and inconsistent that the racing laws of this State and the rules and regulations of the Racing Board should be enforced by stewards appointed by the Racing Board and paid by the racing associations running the meetings over which they preside.

In the Seventh Biennial Report, 1944-1946, the Racing Board requests funds with which to hire and pay the state stewards and in the Ninth Biennial Report, 1948-1950, and again in 1954-1956, the Racing Board renewed this request to hire and pay for the state stewards who represent the Racing Board and report to it. The Racing Board at this time renews its requests to the Legislature to provide it with the necessary funds so that it may hire and pay two stewards in order that these individuals will no longer be in the incongruous position of representing the Racing Board and at the same time receiving their paychecks from the racing associations against whom they must enforce the laws and rules of racing.

The racing laws of New York State provide for an assessment against the corporation conducting a race meeting, and this fund is used to pay for the state steward and other activities of the New York State Racing Commission.

The Washington State law also provides for an assessment against the racing associations for such purposes. The Washington Horse Racing Commission has always employed the state steward and paid him his salary, from the Washington Horse Racing Commission's operating fund. Racing associations in the State of Washington have never

hired or paid the state steward. The commission pays the salary and is not reimbursed by the racing associations.

Operating funds for salaries and expenses of the Washington commission come from a percentage of the pari mutuel receipts and other revenue collected for the State.

The steward representing the State of California is paid by the various racing associations, and it is recommended that the State of California levy an assessment against the racing associations (fairs excepted) for the necessary funds required for the State to pay for the employment of two state stewards.

The Racing Board, in making this request, believes that those appointed to represent the Racing Board and the State of California, should be paid by the State.

This request for two state stewards to be hired exclusively by the Racing Board is for supervision of the major racing associations only, and does not include a board-paid steward for the fairs. It would be a year-round job for each steward.

## CONCLUSION

We members of this Board, in rendering this report and making the recommendations herein contained, do so with a sincere desire and purpose of fully meeting its duty and obligation of furthering and preserving the sport and business of racing that it believes has been of great benefit to the people of the State of California.

The Board expresses appreciation for the cooperation and service rendered by the Governor, the State Attorney General, the State Legislature and other Public officials, as well as the various track operators, Law Enforcement Agencies, the Thoroughbred Racing Protective Bureau, the Press, Television, Radio, and the Board employees.

## CHARITY DAYS

In accordance with Section 19551 of the Horse Racing Law, as a condition of the issuance of the license, the Board requires that the licensee of such meeting shall conduct such charity days racing and shall furnish its plant, facilities and all personnel and property necessary for the conduct of racing on the Charity Days.

For the year ended 1959, the Board granted 34 Charity Days to the various Racing Associations and the sum in excess of \$1,000,000 was produced for charitable organizations in the State of California.

## BREEDERS AWARDS

The Horse Racing Law Chapter 4, Division 8, Business & Professions Code provides for California bred horses and races.

Section 19567 states as follows:

"Since the purpose of this Chapter is to encourage agriculture and the breeding of horses in this State, a sum equal to 10 percent of the first money of every purse won by a California bred horse at a horse race meeting shall be paid by the licensee conducting the meeting to the breeder of such animal."
