NINETEENTH BIENNIAL REPORT

TO THE GOVERNOR AND THE LEGISLATURE
OF THE STATE OF CALIFORNIA

(For the Period July 1, 1968 to June 30, 1970)

To RONALD REAGAN, *Governor*

and to the Members of the Legislature:

The California Horse Racing Board herewith presents its final biennial report covering the period July 1, 1968 through June 30, 1970. Pursuant to Section 19441 of the Business and Professions Code of the State of California, as amended, effective November 23, 1970 this report will henceforth be issued annually. (Statutes 1970, Chapters 1572, 1581, 1609, 1612)

COMPOSITION OF THE CALIFORNIA HORSE RACING BOARD

The California Horse Racing Board consists of three members, appointed by the Governor. Each member holds his office for a four-year term, no more than one seat falling vacant during a single year. The Board meets periodically with its meetings open to the public.

HISTORICAL AND LEGAL BACKGROUND OF HORSERACING IN CALIFORNIA

Shortly after 1900 a number of new racetracks were built in California and California became a center of breeding and racing activities. However, with increased activity and success abuses developed and because of abuses in California, and reports of corrupt practices throughout the nation, California followed the lead of New York and in 1909 declared horseracing with wagering on its results to be illegal.

The period between 1909 and 1933, when an initiative measure passed to relegalize such racing, there were three unsuccessful attempts to have the people vote to reestablish racing on a legal basis. The 1933 measure, in order to get the support of the people, wrote many safeguards into the law and gave complete jurisdiction and supervision over all racing activities to the State of California acting through the California Horse Racing Board, a three-member commission appointed by the Governor. Whereas previously racetracks had acted autonomously and the stewards had complete and final authority over all meetings, the California law transferred this authority to the centralized body, the commission. It gave the commission full and final authority over all aspects of all race meetings upon the result of which pari-mutuel wagering was conducted. The law also gave the board wide discretion in rulemaking powers, and pursuant to these powers, the board passed rules establishing the authority of the stewards but making the stewards strictly and completely responsible to the board for all their actions.

Authority

The California Horse Racing Board was established pursuant to Section 25a of Article IV of the State Constitution and operates under the provisions of Section 19400 through 19664 of the Business and Professions Code.

OBJECTIVES

The California Horse Racing Board supervises all race meetings in the state where parimutuel wagering is conducted. Principal activities of the board are concentrated in:

Licensing of racing associations.

Sanctioning of every person who participates in any phase of horse-racing.

Designating racing days and charity days.

Acting as a quasi-judicial body in matters pertaining to horseracing.

Collecting the state's lawful share of revenue derived from horse-racing meets.

Enforcing laws, rules and regulations pertaining to horseracing in California.

LICENSING

Licensing of personnel connected with horseracing is performed by a license clerk in the board's mobile office. Processing of applications includes checking of files, obtaining approvals by stewards, receipt of payments for license fees, and typing of licenses.

Since licensing is performed at the racetracks, information on applicants must be available in the mobile offices for on-the-spot decisions. Therefore, license, ruling and intelligence card files are maintained at mobile offices and/or headquarters. License application and penalty files are kept at headquarters only. Various means are used to distribute source or duplicate information to the different locations in an effort to keep files up to date.

ENFORCEMENT

The enforcement arm of the California Horse Racing Board is the Bureau of Investigation, under the supervision of a chief investigator, who is a peace officer. The Bureau of Investigation is staffed by race-track investigators on field assignments at each operating race meeting. Racetrack investigators compile and maintain intelligence information on racing participants and on those persons whose presence within a racing enclosure is considered inimical to the interests of the State of California. The Bureau of Investigation maintains liaison between the board and other local and state enforcement agencies to coordinate a policy of enforcement against violators of the gaming laws of the state. Investigators obtain necessary information for administrative cases coming before the board including investigations of racing offenses, improper conduct of racing participants, and documents required for hearing before the board. Investigators inspect racing operations for compliance with the rules and regulations of the board, cause the ejections of known undesirables from racing enclosures, and keep the board informed of all racing matters.

ADMINISTRATION

The board checks to determine compliance with the rules and regulations. Before each race horses are inspected, and after each race drug tests are made on horses under the supervision of a board-appointed veterinarian. The work of the board covers from the San Diego area to Ferndale. The headquarters office of the board is in Los Angeles. It also maintains two mobile offices in northern and southern California during conduct of race meetings. These mobile offices are staffed by the licensing and investigation personnel. Throughout a race meeting a certified public accountant, approved by the board, prepares an audited and certified statement covering the previous day's parimutuel sales, calculations and payouts. This statement, together with the association's check for the state's revenue, is presented to the license clerk in the mobile office. He deposits this check and all other fees in a special trust account the same day. Daily reports of deposits by the field offices are summarized. Funds are remitted weekly to the proper state funds based on a report issued by the board to the State Controller.

HORSERACING REVENUES

The State's revenue from horseracing is derived from licensee fees on a percentage of the parimutuel pool wagers at each racetrack, breakage of winning ticket amounts to the nearest 10 cents of each dollar, and escheated unclaimed parimutuel tickets. There is also a small amount of revenues from occupational licenses issued to owners, trainers, jockeys and others.

The proceeds from 4 percent of the parimutuel wagering and from occupational license fees are deposited in the Fair and Exposition Fund. Proceeds from parimutuel fees in excess of 4 percent, and all other revenues (i.e., breakage, unclaimed parimutuel tickets, fines and miscellaneous) are deposited in the General Fund.

In accordance with the provisions of the Horse Racing Law, the revenues deposited in the Fair and Exposition Fund are appropriated, first, for support of the Horse Racing Board and for costs incurred by the Department of Agriculture in supervising, and by the Department of Finance in auditing, all fairs. The Horse Racing Law also provides for annual appropriations totaling not to exceed \$8,015,000 for promotion and encouragement of agricultural fairs and citrus fruit fairs and expositions, to be expended in accordance with the specifications contained therein. The law further provides that revenues in excess of the amounts appropriated shall be transferred to the General Fund at the end of each calendar month.

The California Horse Racing Board was responsible for collecting \$59,839,346 and \$58,244,375 in State Revenue for the 1968-69 and 1969-70 fiscal years respectively. The chart below provides an accounting of the state's revenue with its resulting low cost of operations.
