**THURSDAY****06-23-16<sup>1</sup> DUTY STEWARD**

Ruben Moreno will be on duty this week attending to office matters and recording the minutes during this reporting period.

**06-23-16<sup>2</sup> CAL-BRED REPORT**

The fifth race in the book for Sunday, California state-bred maiden claiming for 2-year olds with a claiming price of \$32,000 going five and one half furlongs, failed to fill with four entries (two Cal-breds).

**06-23-16<sup>3</sup> ENTRIES & DRAW**

Entries for Sunday, June 26, 2016 were drawn at 11:30 a.m.

**06-23-16<sup>4</sup> RULING NO. 4 - FRANCISCO MALDONADO**

Jockey FRANCISCO MALDONADO who rode **SASSY JAZZY** in the second race on Sunday, June 19, 2016 at the Alameda County Fair (Pleasanton) is hereby fined one hundred dollars (\$100)\* for violation of California Horse Racing Board rule #1688 (Use of Riding Crop – used more than three times without giving the Mule a chance to respond).

The foregoing ruling was issued after Francisco Maldonado reviewed the second race on June 19, 2016 with the stewards. Jockey Maldonado acknowledged that he erred in striking his mount more than the allowed three times in secession, stating that he was not aware of the new rule as he did not ride last year.

06-23-16<sup>5</sup> **RULING NO. 5 - FRANCISCO MONROY**

Jockey **FRANCISCO MONROY** who rode **CALI MCGEE** in the second race on Sunday, June 19, 2016 at the Alameda County Fair (Pleasanton) is hereby fined one hundred dollars (\$100)\* for violation of California Horse Racing Board rule #1688 (Use of Riding Crop – used more than three times without giving the Mule a chance to respond).

The foregoing ruling was issued after jockey Francisco Monroy and the stewards reviewed the film replay of the second race on June 19, 2016. Jockey Monroy acknowledged his violation.

06-23-16<sup>6</sup> **RULING NO. 6 - JONATHAN WONG**

Trainer **JONATHAN WONG** is hereby fined one hundred dollars (\$100)\* for failure to have the horse **SOMETHING FOR LUCK** in the Receiving barn at the designated time for the sixth race on June 19, 2016. A violation of California Horse Racing Board rule #1894 (Duties of Trainer – timely attendance at the receiving barn).

The above ruling was issued after trainer Jonathan Wong stated his grooms were having a hard time catching his entrant SOMETHING FOR LUCK.

06-23-16<sup>7</sup> **RULING NO. 7, 8 & 9 - GONZALEZ, GALEOTE & RULING NO. 7**

Acting on an Order of Remand following the adoption of a proposed decision by the California Horse Racing Board, Trainer **MIGUEL GONZALEZ** who started the horse **SPARKIN ONE**, winner of the Third race at The San Joaquin County Fair (Stockton) on September 12, 2015 is suspended one year November 20, 2016 through November 19, 2017 and fined the sum of twenty thousand dollars (\$20,000.00)\* pursuant to California Horse Racing Board Racing rule #1887 (a) (Trainer to Insure Condition of Horse) for violation of California Horse Racing Board rules #1843 (a) (b) & (d) (Medication, Drugs and Other Substances: Prohibited Drug Substance-Clenbuterol [Class3]), (Third offense) #1843.1 (a) (Prohibited Medication), #1844 (a) & (e) (6) (Authorized Medication) and #1894 (Duties of Trainer).

During the term of suspension, all licenses and license privileges of **MIGUEL GONZALEZ** are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards to suspend or Fine) subject is denied access to all premises in this jurisdiction.

**RULING NO. 8**

Acting on an Order of Remand following the adoption of a proposed decision by the California Horse Racing Board, Owner **CANDIDO GALEOTE** who owned **SPARKIN ONE**, winner of the third race at The San Joaquin County Fair (Stockton) on September 12, 2015 is suspended sixty (60) days, June 25, 2016 through August 23, 2016 and fined the sum of five thousand dollars (\$5,000.00)\* pursuant to California Horse Racing Board Racing rule #1887 (a) (Trainer to Insure Condition of Horse) for violation of California Horse Racing Board rules #1843 (a) (b) & (d) (Medication, Drugs and Other Substances: Prohibited Drug Substance-Clenbuterol [Class3]) #1843.1 (a) (Prohibited Medication), #1844 (a) & (e) (6) (Authorized Medication) and #1902 (c) (Conduct Detrimental to Horse Racing).

During the term of suspension, all licenses and license privileges of **CANDIDO GALEOTE** are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards to suspend or Fine) subject is denied access to all premises in this jurisdiction.

**RULING NO. 9**

Acting on an Order of Remand following the adoption of a proposed decision by the California Horse Racing Board, Owner **SAMUEL G. GALEOTE** who had the care and attendance of the horse **SPARKIN ONE**, winner of the Third race at The San Joaquin County Fair (Stockton) on September 12, 2015 is suspended one hundred eighty (180) days, June 25, 2016 through December 21, 2016 and fined the sum of five thousand dollars (\$5,000.00)\* pursuant to California Horse Racing Board Racing rule #1887 (a) (Trainer to Insure Condition of Horse) for violation of California Horse Racing Board rules #1843 (a) (b) & (d) (Medication, Drugs and Other Substances: Prohibited Drug Substance-Clenbuterol [Class3]) (second offense), #1843.1 (a) (Prohibited Medication), #1844 (a) & (e) (6) (Authorized Medication) and #1902 (c) (Conduct Detrimental to Horse Racing).

During the term of suspension, all licenses and license privileges of **SAMUEL G. GALEOTE** are suspended and pursuant to California Horse Racing Board rule #1528 (Jurisdiction of Stewards to suspend or Fine) subject is denied access to all premises in this jurisdiction.

Acting on an Order of Remand from the California Horse Racing Board, the above rulings were issued.

06-24-16<sup>2</sup> **RULING NO. 10 - JACQUI NAVARRE**

Owner **JACQUI NAVARRE** is hereby fined the sum of one hundred dollars (\$100)\* for a prohibited cooking vessel (plastic oat bucket) left unattended. A violation of California Horse Racing Board rule #1530 (cases not covered).

The above ruling was issued after owner Jacqui Navarre had no excuse for her lapse of memory while cooking her oats.

06-24-16<sup>3</sup> **RULING NO. 11 - JUSTIN RIVERA**

Groom **JUSTIN LORENZO RIVERA** is hereby fined the sum of one hundred dollars (\$100)\* for exercising horses without procuring the appropriate license. A violation of California Horse Racing Board rule #1481 (a) – occupational licenses and fees.

The above ruling was issued after Justin Rivera waved a hearing and was oblivious that he needed an exercise rider's license.

06-24-16<sup>4</sup> **GUILD REPRESENTATIVE**

Jockeys Guild Regional Manager Darrell Haire visited the steward's stand and discussed racing around the United States with Idaho racing being the hot topic.

06-24-16<sup>5</sup> **RACE #1 - ACCIDENT - INQUIRY**

Shortly after the finish of the first race (Mule) 300 yards the #1 STEWBALL broke in sharply unseating his jockey Juan Arriaga who fell to the track surface. Jockey Arriaga was immediately attended to by track EMT's and transported back to the jockey's room uninjured. Accident report to follow.
