Friday08/01/08 (1) **Hearing for Etienne Desomer – Case #08SW-0080**

The Etienne Desomer hearing was scheduled for 3:00 p.m., but Mr. Desomer thought it was at 4:30 p.m. Mr. Desomer was involved in an altercation on July 17th, 2008 at Cal-Expo.

The stewards settled on a Two Hundred (\$200) Dollar fine for the altercation and a One Hundred (\$100) Dollar fine for being late for the hearing.

08/01/08 (2) **Driver Review**

Driver David Siegel came to the steward's office to view Race #4 on Saturday, July 26, 2008. After discussing the race, Mr. Siegel understood what the stewards were talking about.

There was no penalty involved.

08/01/08 (3) **Incentive Program Announced**

The new fall incentive program was agreed to by horsemen and management. The package will help all horsemen after the break, plus should bring new horses to race at Cal-Expo.

08/01/08 (4) **Claims**

Race #6 - #5 "Titan Seelster" was claimed by Bob Johnson from Tim Clevenger.

08/01/08 (5) **First Race – Trainer Late to Paddock**

Trainer Hans Rynningen was late to the paddock with "Princess Markoni" for the first race tonight.

There was a Fifty (\$50) Dollar fine from the stewards.

08/01/08 (6) **Third Race – Inquiry**

The stewards put up the inquiry sign for possible interference between #5 "Cam's Gidget", driven by Robley Johnson and #4 "Adora", driven by David Siegel, at the top of the stretch.

After reviewing the tapes, the stewards placed #5 "Cam's Gidget" from sixth (6th) for interference to #4 in the stretch.

08/01/08 (7) **Fourth Race – Inquiry**

The stewards put up the inquiry sign for a possible violation of the pylon rule by #4 “Rod’s Famous Ribs”, driven by Lou Pena.

After review of the tapes, the horse, who finished second (2nd) was placed sixth (6th) for leaving the course before the 3/4 pole.

The second placing was between #2 “Never Nasty”, driven by Etienne Desomer, and #1 “Jazzimoto”, driven by James Kennedy, after the 1/4 pole.

In the 2nd qualifying race at Cal-Expo the #4 horse "Hi Ho Offto Bettigo", driven by Steve Wiseman made a break after the start. The #2 horse, "The Ridge", driven by Tim Maier, was not able to clear the breaking horse and the sulky of the #2 horse went over him, falling to the track and throwing Mr. Maier to the ground. Mr. Maier was the only casualty in the incident.
