Ninety eight (98) horses are entered in Thursday's twelve (12) race card.

Numerous driver changes were recorded for Thursday's program. No scratches were submitted. Friday's fifteen (15) race program drew one hundred seventeen (117) entries.

A number of driver changes were taken for Friday. No scratches were submitted. Saturday's fifteen (15) race card drew one hundred eleven (111) horses. No Cal-Bred races were used.

03/11/09 (2) **Ruiz Hearings – Disqualifications – Cases SW-0001; SW-0004; SW-0005**

A hearing was conducted concerning three positive test findings on horses trained by Matias Ruiz. The horses were “Avid Sportsman”, “Sandra Hotspur” and “Bob Lee”. Mr. Ruiz is at least part owner in all three horses and was present at today’s hearing to represent all interests. All other owners were properly notified and opted not to show at the hearing. All horses tested positive for the Class III drug “Heptaminol”. “Avid Sportsman” raced in the 14th Race on December 19, 2008, finishing first (1st). “Sandra Hotspur” raced in the 10th Race on December 27, 2008, finishing sixth (6th). “Bob Lee” finished fourth (4th) in the 9th Race on December 27, 2008.

Senior Special Investigator Martin Snezek presented all relevant evidence, which was accepted into the record without objection. Mr. Ruiz was given the opportunity to review the evidence and give testimony. Mr. Ruiz accepted the laboratory findings and understood rulings would be issued disqualifying the horses. Mr. Ruiz indicated that the purse account with the paymaster had sufficient funds to cover the rulings. Rulings to follow.

Ruling #29

Acting upon a report from University of California, Davis, an official laboratory for the California Horse Racing Board, that the post race sample #CE-10531, taken from the horse "Avid Sportsman", the first place finisher in the Fourteenth Race on December 19, 2008, at Cal-Expo, tested positive for the prohibited drug "Heptaminol" (Class III), it is ordered that "Avid Sportsman" be disqualified from all purse monies earned in said race, in accordance with California Horse Racing Board Rule #1859.5 (Disqualification Upon Positive Test Finding).

03/13/09 (2) **Robley Johnson Hearing – Case # 09SW-0022**

A hearing was conducted today concerning a high Phenylbutazone reading level of 6.36 ug/ml on the horse "Red Star Engineer", who raced in the first race on February 13, 2009.

Robley Johnson was the trainer of record and testified on his own behalf.

Mr. Johnson stated that he had given "Bute" paste two (2) days out and that his veterinarian gave the horse Bute paste 26 to 28 hours out.

This is Johnson's second Class VI violation inside the 365 day parameter. Disposition to follow.

03/13/09 (3) **Second Race – Inquiry/Disqualification**

#5 "Girlie Tough", driven by Luke Plano, went off stride in the stretch and finish. Driver Plano was unable to take up and lose ground to the field. #5 was disqualified and placed fifth (5th) for the violation.

03/13/09 (4) **Seventh Race – Recall**

As the horses were turning to the gate for the 7th Race, #4 "Steady As A Rock" (Jason Ricco), made a break in the path of #5 "Quick On My Feet" (Chris Hernandez) and the two hooked wheels, unseating both drivers. #4 was scratched by the stewards for erratic behavior, and #5 went on to run second (2nd) in the race.

03/13/09 (5) **Thirteenth Race – Inquiry/No Change**

#2 "Speedy Feldy" (James Kennedy) went off stride at the wire, finishing third (3rd). After reviewing the tapes and the photo finish, it was determined the breaking rule was complied with and no horses were 'lapped on' at the finish. No change.

**Matias Ruiz Settlement and Disposition - Cases 09SW-0001;
09SW-0004; 09SW-0005****Ruling # 32**

Trainer Matias Ruiz, who started “Avid Sportsman”, “Bob Lee” and “Sandra Hotspur” at Cal Expo Harness Association, Cal Expo and having entered into a signed stipulated agreement with the California Horse Racing Board is fined Seven Thousand Five Hundred (\$7,500) Dollars, which payment shall be stayed pending completion of probation. Further, commencing April 01, 2009, respondent’s trainer’s license shall be suspended for a period of Ninety (90) Days through and including June 29, 2009, with respondent placed on probation for a One Year Period beginning June 30, 2009, and ending June 29, 2010, subject to the following terms and conditions:

- (A) *During the period of probation, Matias Ruiz must not be in violation of CHRB rules and regulations, sections 1843, 1843.6 and 1887 regarding Class 1, Class 2, or Class 3 substances.*
- (B) *If the respondent violates a condition of his probation, the above-referenced stay of the fined Seven Thousand Five Hundred (\$7,500) Dollar fine shall be lifted, and the fine shall be imposed after notice and hearing.*

“Avid Sportsman”, “Bob Lee” and “Sandra Hotspur” tested positive for the Class III drug Heptaminol.

The above ruling was issued in accordance with the provisions of a stipulated agreement entered into between the CHRB and Trainer Matias Ruiz.

Driver Claude Ladouceur, who drove “Dirty Dog” in the Third Race on Saturday, March 07, 2009, is hereby Suspended Three (3) Racing Days commencing on Thursday, March 19, 2009, through Saturday, March 21, 2009 for violation of California Horse Racing Board Rule #1721 (B) (Driving Rules – Jostle, Strike or Interfere with Another Horse).

Ruling # 34

Driver Claude Ladouceur, who drove “Dirty Dog” in the Third Race on Saturday, March 7, 2009, is hereby fined the sum of One Hundred Dollars (\$100) for violation Of California Horse Racing Board Rule # 1721 (F) (Driving Rules – Take Up Abruptly in Front of Horses Past the Quarter, So as to Cause Confusion and Interference Among Trailing Horses).

The above rulings were issued after Mr. Ladouceur met with the stewards to review his drive aboard “Dirty Dog” in last Saturday’s 3rd Race. Ladouceur was candid in stating he was embarrassed that he drove so poorly. He accepted both penalties without hesitation and promised to do a better job in the future. Ladouceur made the lead in the first turn and then slowed his

horse, causing confusion to trailing horses. Then in the stretch, he changed course causing a rival to alter course to avoid an accident. "Dirty Dog" faded to last in the stretch, so no disqualifications were necessary.

Ruling # 35

Driver Steve Wiseman, who drove #1 "Flirtiscape" in the Fourth Race on Friday, March 13, 2009, is hereby fined the sum of One Hundred Dollars (\$100) for violation of California Horse Racing Board Rule # 1721 (L) (Driving Rules – Drive or Cause to be Driven any Unreasonably Slow Quarters or Fractions).

The above ruling was issued after Wiseman was contacted by the stewards and accepted the penalty. Wiseman slowed his mount in the second quarter of this open filly and mare division to 30 3/5, which is very slow for the category.

03/14/09 (4) **Svensden Ruling**

Ruling # 36

Driver Lemoyne Svensden, who drove "Gimme Hope" in the Seventh Race on Friday, March 13, 2009, is hereby fined the sum of One Hundred (\$100) Dollars for violation of California Horse Racing Board Rule #1721(E) (Driving Rules – Crowded a Horse – Forced a Hole – Approaching the 1/4 Pole).

The above ruling was issued after Svensden was contacted by the stewards and accepted responsibility. Svensden tried to back his horse into a tight spot causing Driver Rocky Stidham to steady his horse #2 "Pedal Pad" near the first quarter.

03/14/09 (5) **Tenth Race – Inquiry/Disqualification**

The stewards posted the inquiry sign to review possible interference in the final turn. The review involved first (1st) place finisher #1 "Leadmeastray" with Driver Steve Wiseman and third (3rd) place finisher #2 "Jessalil Peace" with Luke Plano driving.

After talking with the drivers and a thorough review of all angles, it was determined that interference did occur. As the horses are in mid-turn, Plano pulls #2 to the outside with a clear path to the lead. As #2 attempts to pass #1, Wiseman pulls #1 into #2's path, causing #2 to move three wide and forcing Plano to check his mount and costing him forward progress. #2 finishes third (3rd), beaten less than 1/2 length for second. In an unanimous vote, the stewards felt #2 was cost a chance at a better placing. #1 was disqualified from first (1st) to third (3rd) for the interference.
