Bertrand felt Marchand’s interference in an entry dispute in June cost him a race and a chance to pay the balance. Decision to come.

Bertrand Ruling**Ruling # 80**

The Cal-Expo Board of Stewards, having heard arguments in Case #10SW-0084, find Owner Richard Bertrand to be indebted to Owner Lisa Kadle in the amount of Three Hundred Forty Five Dollars and Fifty Five Cents (\$345.55). The above ruling was issued after deliberation over yesterday’s hearing. Bertrand had been paying on the horse and has a \$345.55 balance left.

Gullian Hearing Ruling – Case #10SW-0109

A hearing was conducted for Trainer David Gullian, who trained “Our Gabby’s Girl”, 2nd place finisher on May 6, 2010. U.C. Davis Lab reported Methocarbamol in the post race test sample. Gullian testified by phone from Minnesota and could not explain the test results. He stated that he had Robaxin in the barn, but did not use it for the horse in question. Gullian accepted the following ruling:

Maier who suffers from diabetes. A backup ambulance was summoned to transport Maier. Maier's horse, #2 "Missniobekniobe", was scratched by the stewards. A total delay of twenty four (24) minutes was caused by the incident.

#5 "Power Of Key Largo" (Luke Plano) went off stride before the 3/4 pole and ended up third (3rd). After review it was determined that #5 complied with the breaking rule and no interference occurred. No change.
