Proceedings of the Board of Stewards for the period of Monday, December 27, 2010 through Sunday, January 02, 2011. Steward Michael W. "Wayne" Oke was the Reporting and Duty Steward for the enclosed period.

12/27/10 (1) **Entries and Draw**

The race office was open this morning accepting entries for Thursday's, Friday's and Saturday's cards.

12/27/10 (2) **Draw For Thursday**

At the 1:30 p.m. draw, eighty four (84) head were drawn to compete in eleven (11) races. Scratch time is 9:00 a.m. Tuesday.

Qualifying entries were taken this morning for qualifying races to be held today commencing at 4:30 p.m. There will be seventeen (17) horses competing in three (3) qualifying events.

12/31/10 (1) **Fifth Race – Inquiry/Disqualification**

The inquiry sign was lit to allow the stewards to review the finish of the race.

After reviewing film the stewards unanimously concluded that fourth (4th) place finisher #2 "Heavy Pockets" (Paul Welence) broke stride approaching the finish, and while 'off-stride', interfered with #1

“Exquisite Gem” (Lemoyne Svendsen), the eventual seventh (7th) place finisher. Consequently, the stewards disqualified #2 and place her seventh (7th) for ‘interference while off-stride’. Driver Welence was held blameless in the incident.

12/31/10 (2) **Fifth and Eleventh Race Sanctions**

Trainer Tim Maier, who had “Little Rooster”, programmed to start in Race #5, was fined the sum of Fifty (\$50) Dollars after paddock officials informed the stewards that the horse was late arriving in the paddock. Similarly, Trainer Rick Cisco, who had “Rare Wine” programmed to start in Race #11, received the same penalty under the same circumstances.
