Robley Johnson Hearings – Cases 10SW-0146 and 10SW-0151

Two cases for high Flunixin readings on the horse "Red Star Ruffles", trained by Robley Johnson, were heard today. The first was on October 8, 2010 where the horse finished first (1st) in the second race. The Flunixin was measured at 64 ng/ml. The second was on October 16, 2010 where the horse finished first (1st) in the third race. The Flunixin was measured at 58 ng/ml.

Present at the hearing were the Board of Stewards, Investigator Carol Nolan, Dr. Robert Goodbary, and Trainer Robley Johnson. The proceedings were recorded by Yvonne Fenner, Certified Shorthand Reporter.

Testimony was presented that Mr. Johnson was not notified of the first high test before the second test was taken. These two tests are his first violations in a 365 day period.

Testimony was taken from Dr. Goodbary and Robley Johnson. All documents were accepted on the record and the matter deemed submitted.

First Race – Inquiry/No Change

#2 "Goli Tie" (Sue Boyce) went offstride before the start and finished third (3rd). After review it was determined that Driver Boyce complied with the breaking rule. No change.

Seventh Race – Tote Problems Again

The tote board was frozen for the 7th Race. All TV and simulcast monitors relayed tote information without a problem. This has been an ongoing problem and Michelle Arndt of Sport Tech relayed that high level

technicians are coming from Maryland headquarters on February 20th to address the problems. More to follow.

- 02/05/11 (1) **Maier Hearing Postponed – Case #10SW-0157**
 Trainer Tim Maier requested that his attorney, Don Calabria, be contacted by phone for today’s hearing on a Ketoprofen overage on November 18th. The horse “Sweet Treats” raced in the 2nd Race, finishing first (1st).

Investigator Carol Nolan had not heard from Maier that he was using an attorney and requested a postponement.

Nolan and Calabria conversed telephonically and Saturday, February 26 was agreed upon as the new date.

- 02/05/11 (2) **Robley Johnson Ruling (Ref: 02/04/11¹)**

Ruling # 10

Trainer Robley Johnson is hereby fined Seven Hundred Fifty (\$750) Dollars for two violations of California Horse Racing Board Rule #1843(A) (Medications, Drugs and Other Substances) pursuant to California Horse Racing Board Rule #1887(A) (Trainer to Insure Condition of Horse).*

The first violation is for the horse “Red Star Ruffles” (Flunixin 64 ng/ml – Case No: 10SW0146), who finished First in the Second Race at Cal Expo, California on October 8, 2010.

The second violation is also for the horse “Red Star Ruffles” (Flunixin 58 ng/ml – Case No: 10SW0151), who finished First in the Third Race at Cal Expo, California on October 16, 2010.

**Mitigating circumstances considered.*

The above ruling was issued after deliberation over yesterday's hearing. The leniency of the ruling was due to mitigating circumstances being considered:

- 1) Not notified of first test before second test was taken (no way to change procedure)
- 2) Low purses at Cal-Expo
- 3) No violations in past year

Mr. Johnson was informed that while we took into consideration the above, that any further violation in the next year will be considered his third violation.
