The racing office was open today with the purpose of filling race cards for February 18 and 19.

Thirteen (13) races were filled for February 18. One hundred three (103) horses are scheduled to start. Thirteen (13) races also filled for February 19. 02/17/11 (1) **Kendra McAllister Ruling [Ref: 02/11/11 (1)]**

Ruling # 14

Pony Rider Kendra R. McAllister is hereby fined a combined total of Two Hundred (\$200) Dollars for violation of California Horse Racing Board Rule #1930 (Obedience to Security Officers and Public Safety Officers) on August 21, 2010 at The Humboldt County Fair, Ferndale and for violation of California Horse Racing Board Rule #1922 (Identification Required) on January 21, 2011 at Golden Gate Fields.

The ruling above was issued after the stewards held a formal hearing on February 11, 2011. Pony Rider Kendra McAllister was found to have violated California Horse Racing Board Rule #1930 (Obedience to Security Officers and Public Safety Officers) by using profanity in front of California Horse Racing Board investigators who were present in the paddock area at the Humboldt County Fair (Ferndale) on August 21, 2011. Ms McAllister was additionally found guilty of violation of California Horse Racing Board Rule #1922 (Identification Required) by initially not having her California Horse Racing Board license in her possession and subsequently, providing an expired license to a California Horse Racing Board investigator at Golden Gate Fields on January 21, 2011.

02/17/11 (2) **Off Track**

Considerable rain this afternoon led to a 'sloppy' track condition for the duration of tonight's eleven (11) race card

02/17/11 (3) **Fourth Race - Inquiry**

The steward's posted the inquiry sign after viewing third place finisher #10 "Cherry Tree Rojo" (Tim Maier) make two breaks in this race. "Cherry Tree Rojo" made a break before the start and after the 1/2 mile pole in this race. Driver Maier complied with California Horse Racing Board Rule #1722 (Breaking) by losing ground in both occurrences. No change was made in the order of finish.

02/17/11 (4) **Fifth Race - Inquiries**

The stewards posted the inquiry sign after viewing two (2) incidents. In the first incident, the stewards viewed sixth place finisher #6 "Incredible Gambler" (Luke Plano) go on a 'break' at the 3/4 pole. This caused

interference to seventh (last) place finisher #1 “Spanish Rosey” (Rocky Stidham). For this reason, #6 “Incredible Gambler” was disqualified and placed seventh (last) place.

In the second incident, the stewards observed fourth place finisher #5 “Beach Beach Beach” (Lemoyne Svendsen) make a ‘break’ at the ‘top of the stretch’ (after 3/4 pole). The stewards ruled that he ‘complied’ with this break. No change was made for this occurrence.

The stewards also ruled out the possibility of any horse/driver interference in this second incident.

02/18/11 (2) **Thirteenth Race – Inquiry/Disqualification**

The stewards posted the inquiry sign after viewing third place finisher #4 “Top Flite Justice” (Richard Schneider) drift out in the final seventy (70) or eighty (80) yards of this race. This incident caused a fast closing #2

“Heartland Express” (Rick Plano) to alter course and lose ground in this races later stages.

After film review, the stewards unanimously voted to disqualify #4 “Top Flite Justice” and place him fourth. Driver Richard Schneider was ordered to film review.

Driver Richard Schneider appeared in the steward's office to review his drive behind #4 "Top Flite Justice" who originally finished third (3rd) in the thirteenth race last night (February 18). The stewards had disqualified "Top Flite Justice" and placed him fourth behind #2 "Heartland Express" for interference seventy (70) or eighty (80) yards before the finish.

During film review, Driver Schneider accepted responsibility for letting his 'charge' drift out and significantly impede his fast closing rival in deep stretch. More to follow.
