06/06/11 (1) **Entries for Thursday**

Eight (8) races were drawn for Thursday. A Total of fifty seven (57) horses are scheduled to start. No Cal-Bred races were used.

A few driver changes were taken for Thursday.

06/09/11 (2) **Girard Ruling****Ruling # 60**

Driver Pierre Girard, who drove "Lodi Nickolus" in the Sixth Race on Saturday, June 4, 2011, is hereby fined the sum of Two Hundred (\$200) Dollars for violation of California Horse Racing Board Rule #1721 (F) (Driving Rules – Carry a Horse Out – Resulting in a Disqualification). Incident occurred near the 3/4 mile marker.

The above ruling was issued after Girard reviewed the films with the stewards and pled his case. Girard finally accepted the fact that he had placed a wheel under a rival, causing that rival to break stride.

06/09/11 (3) **Tote System Still Malfunctioning**

The tote console in the steward's stand continues to go in and out of service, causing the wagering to be closed via telephone with Sportech Tote Person Michelle Arndt. The numbers had to be placed in the system in the same manner. The 1st and 2nd Races had problems, and the console was not operational at all for the final two races. Rumor has it that Sportech is bringing in a new system for the State Fair. In the meantime, harness has five days of racing left, and Michelle will do her best to keep the system operational.

06/09/11 (4) **Eighth Race – Inquiry/Disqualification**

#2 "Pussy Cat" (Scott Cisco) went offstride at the top of the stretch and through the wire, finishing fourth (4th). #2 failed to lose ground due to traffic problems. #2 was disqualified and placed last for the violation of the breaking rule.

Driver David McKellar, who drove "Intrepid Kate" in the First Race on June 9, 2011, is hereby fined the sum of Fifty (\$50) Dollars for violation of California Horse Racing Board Rule #1530 (Cases Not Covered – Violation of 'Cal-Expo House Whipping Rule' – (2) Driver Must Keep One Line in Each Hand at All Times During the Race Except When the Horse and Driver Reach the 7/8 Mile Marker During the Race.

The above ruling was issued after McKellar accepted the penalty without argument. He stated he forgot the rule in the heat of battle.

06/10/11 (2) **Tenth Race – Inquiry/No Change**

#3 "Fork In The Road" (James Kennedy) went off stride briefly in the stretch, recovered and finished fourth (4th). After review it was determined that no interference occurred and the breaking rule was complied with, so no change was warranted.
