11/28/11 (1) **Entries for Thursday**

Nine (9) races were drawn for Thursday's card. Sixty six (66) horses are scheduled to compete. No Cal-Bred races were used.

11/29/11 (1) **Changes for Thursday/Entries for Friday and Saturday**

A few driver changes were made by the 9:00 a.m. scratch time for Thursday. Friday's thirteen (13) race card drew ninety eight (98) entries. Saturday's thirteen (13) race card consisted of ninety six (96) horses entering. No Cal-Bred races were used.

Scratch time was delayed until 10:00 a.m. to accommodate numerous driver changes for the Friday and Saturday races.

Thursday

12/01/11 (1) **Veterinarian Visits [Ref: 11/26/11 (2)]**

Practicing Veterinarian Audrey Clifton was in to explain here part in a double Lasix given to "Ally Chandon" on November 25, 2011.

Dr. Clifton took her orders from the owner's representative (mother) and failed to confirm with the trainer. Harness racing is fairly unique in that owners are more hands on with the animals and tend to take charge, overlooking the fact their trainers are held responsible for the barn. Dr.

Clifton assured us that no matter who pays the bills, the trainer will be consulted before any medications are used.

 #3 “Aston Boko” (Richard Wojcio) went offstride before the stat and finished fourth (4th). After review, it was determined #3 complied with the breaking rule. No change.

- 12/02/11 (1) **Meeting**
 The stewards met with Executive Kirk Breed to bring him up to speed on standardbred happenings and discuss matters of mutual concern.
- 12/02/11 (2) **Wiseman Ruling**
- Ruling # 38**
- Driver Steve Wiseman, who drove “Sterling Chris” in the Sixth Race on December 01, 2011, is hereby fined the sum of Fifty (\$50) Dollars for violation of California Horse Racing Board Rule #1530 (Cases Not Covered – Violation of ‘Cal-Expo House Whipping Rule’ – (4)(A) Any Blatant or Exaggerated Movements of the Whipping Arm Which Will Result From Raising the Elbow Above the Driver’s Shoulder Height and/or Allowing the Hand Holding the Whip to Reach Behind the Driver During the Use of the Whip).*
- The above ruling was issued after Wiseman was contacted and admitted to being overzealous while vying for 1st place.
- 12/02/11 (3) **First Race – Inquiry/No Change**
 The inquiry sign was posted to review possible interference by second (2nd) place finisher #5 “Poor House” (James Kennedy) pulling late into the path of fifth (5th) place finisher #4 “Dine N Wine” (Gene Vallandingham). After review it was determined that #4’s chances were not compromised. No change.
- 12/02/11 (4) **Third Race – Inquiry/Disqualification**
 #2 “Only in Lodi” (Pierre Girard) went inside two (2) pylons and finished fourth (4th). #2 was ‘lapped on’ at the finish with fifth (5th) place finisher #6 “Mr Me” (Susan Boyce). #2 was disqualified and placed fifth (5th) for the violation.

12/02/11 (5) **Sixth Race – Inquiry/Disqualification**

#2 “Dancinwiththedevel” (Lemoyne Svendsen) went off stride in deep stretch and through the wire, finishing third (3rd). #7 “Lodi Nickolus” (Pierre Girard) finished fourth (4th) and was lapped on #2 at the finish. #2 was disqualified and placed fourth (4th) for a ‘lapped on’ break at the finish.

Saturday12/03/11 (1) **Girard Ruling [Ref: 12/02/11 (4)]****Ruling #39**

Driver Pierre Girard, who drove “Only In Lodi” in the Third Race on Friday, December 2, 2011, is hereby fined the sum of One Hundred Dollars (\$100) for violation of California Horse Racing Board Rule #1721 (O) (Driving Rules – Drive In Such a Manner as to Obtain for Himself an Unfair Advantage – Inside Multiple Pylons, Resulting in a Disqualification).

The above ruling was issued after Girard contacted the stewards and pled guilty to losing his compass and going inside pylons.

12/03/11 (2) **Herrera Ruling****Ruling # 40**

Driver Harold Herrera, who drove #5 “Youremyaddiction” in the Eleventh Race on December 02, 2011, is hereby fined the sum of Fifty (\$50) Dollars for violation of California Horse Racing Board Rule #1530 (Cases Not Covered – Violation of ‘Cal-Expo House Whipping Rule’ – (4)(A) Any Blatant or Exaggerated Movements of the Whipping Arm Which Will Result From Raising the Elbow Above the Driver’s Shoulder Height and/or Allowing the Hand Holding the Whip to Reach Behind the Driver During the Use of the Whip).

The above ruling was issued after Mr. Herrera appeared and admitted to whipping in violation of the rules.

- 12/03/11 (3) **Qualifiers**
Tonight's two (2) qualifiers had eight (8) participants, of which seven (7) made the grade.
- 12/03/11 (4) **Eleventh Race – Recall**
The recall lights were flashed by Starter Bill Vallandingham as the horses approached the start. #2 "Bullet Tooth Tony" had broken equipment (overcheck). #2 was checked up and the race restarted with about a four (4) minute delay.
- 12/03/11 (5) **Thirteenth Race – Inquiry/No Change**
The inquiry sign was posted to review the circumstances surrounding numerous horses going offstride after the start. After review, it was determined #2 "Power Of Elizabeth" (Scott Cisco) went offstride after the start on its own, while in the clear. #3 "Check Raisin" (James Kennedy) went off-stride before the 1/4, causing #5 "Alexander Penn" (Gene Vallandingham) to go off-stride and also causing #7 "Awesome Deal" (James Lackey) and #8 "Enemy Lines" (Luke Plano) to race wide to avoid a collision. #3 was at fault for all interference incurred, and since #3 finished last, no change was necessary.
